A BILL ENTITLED

1 AN ACT concerning

2 **Environment – On-Site Sewage Disposal Systems – Nonprofit Campgrounds**

3 FOR the purpose of requiring the Department of the Environment to authorize a certain
4 nonprofit campground to use certain on-site sewage disposal systems under certain
5 circumstances; prohibiting the Department from applying certain criteria to a
6 nonprofit campground; providing that certain requirements for using the best
7 available technology for nitrogen removal do not apply to a nonprofit campground;
8 defining certain terms; and generally relating to the use of on-site sewage disposal
9 systems at nonprofit campgrounds.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Environment**

18 **9–1112.**

19 **(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS**
20 **INDICATED.**

21 **(2) “CAMPSITE” MEANS A PORTION OF A NONPROFIT CAMPGROUND**
22 **WITH CONNECTIONS TO WATER SUPPLY, ELECTRICAL SERVICE, AND ON-SITE**
23 **SEWAGE DISPOSAL SYSTEMS.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(3) “NONPROFIT CAMPGROUND” MEANS ONE PARCEL OR TRACT OF**
2 **LAND INCLUDING BUILDINGS OR OTHER STRUCTURES THAT:**

3 **(I) CONTAINS UP TO THREE SEPARATE CAMPSITES;**

4 **(II) IS USED FOR TEMPORARY OR SEASONAL OVERNIGHT**
5 **OCCUPANCY; AND**

6 **(III) IS OWNED AND OPERATED BY AN ORGANIZATION THAT IS**
7 **EXEMPT FROM TAXATION UNDER § 501(C)(3) OF THE INTERNAL REVENUE CODE.**

8 **(B) THE DEPARTMENT SHALL AUTHORIZE A NONPROFIT CAMPGROUND**
9 **WITH AN ACCUMULATIVE MAXIMUM DAILY FLOW OF 5,000 GALLONS PER DAY OR**
10 **GREATER TO USE SEPARATE CONVENTIONAL ON-SITE SEWAGE DISPOSAL SYSTEMS**
11 **TO SERVICE SEPARATE CAMPSITES.**

12 **(C) THE DEPARTMENT MAY NOT APPLY THE CRITERIA FOR LARGE ON-SITE**
13 **SEWAGE DISPOSAL SYSTEMS UNDER COMAR 26.04.02.05 TO A NONPROFIT**
14 **CAMPGROUND.**

15 **(D) SECTION 9-1108 OF THIS SUBTITLE AND COMAR 26.04.02.07 DO NOT**
16 **APPLY TO A NONPROFIT CAMPGROUND.**

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
18 October 1, 2017.
