1 AN ACT concerning

2 **Commissioner of Financial Regulation – Consolidation of Nondepository**
3 **Special Funds**

4 FOR the purpose of consolidating the Mortgage Lender–Originator Fund, the Money
5 Transmission Fund, and the Debt Management Services Fund into one fund;
6 renaming the Mortgage Lender–Originator Fund to be the Nondepository Special
7 Fund; establishing the purpose of the Nondepository Special Fund; requiring certain
8 revenues, fees, and examination assessments to be credited to the Nondepository
9 Special Fund to be used for a certain purpose; requiring that certain money be
10 transferred to a certain fund as of a certain date; repealing certain definitions;
11 altering a certain definition; making conforming and stylistic changes; and generally
12 relating to financial regulation.

12 Debt Management Services Fund shall be transferred into the Nondepository Special Fund,
13 as enacted by Section 1 of this Act, as of July 1, 2016, and the transferring of funds shall
14 be ~~terminated~~ completed as of the end of July 1, 2016.

15 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
16 1, 2016.
