 28 employee who sustains an injury in the line of duty that:
- 29 (i) Precludes the individual from continuing to serve or be employed  
 30 as a State or local public safety employee; and

1                   (ii) In the case of a volunteer member of a fire department or  
2 ambulance or rescue company or squad, precludes the member from continuing to be  
3 employed in the nonpublic safety occupation in which the member is engaged at the time  
4 of the injury.

5                   (3) “Fund” means the Edward T. Conroy and Jean B. Cryor Scholarship  
6 Fund.

7                   (4) “School employee” includes an employee of a public or nonpublic school  
8 in the State.

9                   (5) “State or local public safety employee” means a person who is employed  
10 in the State as:

11                   (i) A career or volunteer member of a:

12                           1. Fire department;

13                           2. Ambulance company or squad; or

14                           3. Rescue company or squad;

15                   (ii) A law enforcement officer;

16                   (iii) A correctional officer; or

18 of this State at the time of death.

19                   (6) “Surviving spouse” means a person who has not remarried.

22 City, the attack on the Pentagon in Virginia, or the crash of United Airlines Flight 93 in  
23 Pennsylvania.

24                   (b) There is a program of scholarships that are awarded by eligible postsecondary  
25 institutions under this section.

26                   (c) (1) The program for military and public safety personnel and their eligible  
27 dependents is the Edward T. and Mary A. Conroy Memorial Scholarship Program.

28                           (2) The program for eligible dependents of public and nonpublic school  
29 employees is the Jean B. Cryor Memorial Scholarship Program.

30                   (d) (1) A person may apply to an eligible postsecondary institution for a  
31 scholarship under this section if the person:

1                   (i) 1. Is accepted for admission or enrolled in the regular  
2 undergraduate, graduate or professional program at an eligible institution IN THE STATE  
3 OR OUTSIDE THE STATE; or

4                   2. Is enrolled in a 2-year terminal certificate program in  
5 which the course work is acceptable for transfer credit for an accredited baccalaureate  
6 program in an eligible institution IN THE STATE OR OUTSIDE THE STATE;

8                   (iii) Meets the other eligibility criteria specified in this section.

10 required to be a resident of Maryland at the time of application or at the time of the

12                   (i) A son, daughter, stepson, or stepdaughter of a member of the  
13 armed forces who:

14                   1. Died as a result of military service after December 7, 1941;

15                   2. Suffered a service connected 100% permanent disability  
16 after December 7, 1941; or

17                   3. Was declared to be a prisoner of war or missing in action,  
18 if that occurred on or after January 1, 1960, as a result of the Vietnam conflict, and if the  
19 child was born prior to or while the parent was a prisoner of war or missing in action;

20                   (ii) A prisoner of war or missing in action, if that occurred on or after  
21 January 1, 1960, as a result of the Vietnam conflict and was a resident of this State at the  
22 time the person was declared to be a prisoner of war or missing in action;

23                   (iii) A veteran, as defined under § 9-901 of the State Government  
24 Article, who:

25                   1. Suffers a service connected disability of 25% or greater;  
26 and

27                   2. Has exhausted or is no longer eligible for federal veterans'  
28 educational benefits;

29                   (iv) The surviving spouse of a member of the armed forces who  
30 suffered a service connected 100% permanent disability;

31                   (v) A son, daughter, stepson, or stepdaughter of or the surviving  
32 spouse of a victim of the September 11, 2001, terrorist attacks;

1                   (vi) A son, daughter, stepson, or stepdaughter of a school employee  
2 who, as a result of an act of violence:

3                   1. Died in the line of duty; or

4                   2. Sustained an injury in the line of duty that rendered the  
5 school employee 100% disabled; or

6                   (vii) The surviving spouse of a school employee who, as a result of an  
7 act of violence:

8                   1. Died in the line of duty; or

9                   2. Sustained an injury in the line of duty that rendered the  
10 school employee 100% disabled.

11                   (3) To apply for a scholarship under this section, the following persons are  
12 not required to be a resident of Maryland at the time of application or at the time of the  
13 disabling or fatal event:

14                   (i) 1. A son, daughter, stepson, or stepdaughter of any State or  
15 local public safety employee killed in the line of duty; or

16                   2. The surviving spouse of any State or local public safety  
17 employee killed in the line of duty; or

18                   (ii) 1. A disabled public safety employee;

19                   2. A son, daughter, stepson, or stepdaughter of a disabled  
20 public safety employee who sustains an injury in the line of duty that renders the public  
21 safety employee 100% disabled; or

25                   (e) A scholarship awarded under this section:

26                   (1) May be used for the tuition and mandatory fees at any eligible  
27 institution; and

28                   (2) May not:

29                   (i) Exceed the equivalent annual tuition and mandatory fees of a  
30 resident undergraduate student at the 4-year public institution of higher education within  
31 the University System of Maryland, other than the University of Maryland Global Campus

1 and University of Maryland, Baltimore Campus, with the highest annual expenses for a  
2 full-time resident undergraduate; and

3 (ii) Be less than the lesser of:

4 1. \$3,000; or

5 2. The equivalent annual tuition and mandatory fees of a  
6 resident of the institution attended by the recipient of the scholarship.

7 (f) (1) Each postsecondary institution shall determine the eligibility of  
8 persons who apply to the institution for the Edward T. Conroy Memorial Scholarship  
9 Program and the Jean B. Cryor Memorial Scholarship Program.

10 (2) Funds for the Edward T. Conroy Memorial Scholarship Program and  
11 the Jean B. Cryor Memorial Scholarship Program shall be allocated by the Commission to  
12 each postsecondary institution based on the number of eligible recipients attending each  
13 institution.

14 (3) In October and February of each year, each postsecondary institution  
15 shall report to the Commission the number of eligible recipients attending the institution.

16 (4) The Commission shall allocate funds for awards to postsecondary  
17 institutions upon verification of eligible recipients attending the institutions.

18 (5) If funds cannot be allocated in the fiscal year in which awards are made,  
19 priority shall be given to allocating funds for those awards in the following fiscal year.

20 (g) (1) Each recipient of a scholarship under this section may hold the award  
21 for 5 years of full-time study or 8 years of part-time study.

22 (2) The number of eligible recipients under subsection (d)(2)(iii) of this  
23 section shall be limited to 15 each year.

24 (3) An award provided under subsection (d)(2)(v) of this section may not  
25 exceed the amount specified in subsection (e)(2) of this section when combined with any  
26 other scholarship received by a student based on the student's status as a child or spouse  
27 of a victim of the September 11, 2001, terrorist attacks.

28 (h) (1) There is an Edward T. Conroy and Jean B. Cryor Scholarship Fund.

29 (2) The Commission shall administer the Fund.

30 (3) The Fund is a special, nonlapsing fund that is not subject to § 7-302 of  
31 the State Finance and Procurement Article.



1           (4) The State Treasurer shall hold the Fund and the Comptroller shall  
2 account for the Fund.

3           (5) The Commission:

4           (i) May accept any gift or grant from any person for the Fund;

5           (ii) Shall use any gift or grant that it receives for a scholarship from  
6 the programs; and

7           (iii) Shall deposit any gift or grant that it receives for the programs  
8 with the State Treasurer.
