## Education - Residential Boarding Programs for At-Risk Youth - Expansion

3 FOR the purpose of authorizing the State Department of Education to contract with an operator to provide at-risk youth in the State with the opportunity to participate in 4 5 a certain program that is intended to provide a student with the opportunity to 6 attend a multiweek accelerated learning residential boarding education program; 7 specifying that a certain program is not required to provide college admissions 8 counseling; requiring a county board of education, for each day a student attends a 9 certain program, to pay the Department a certain percentage of the basic daily cost for certain eligible children; requiring the Governor to include in the annual budget 10 11 bill an amount sufficient to cover the transportation, boarding, and administrative 12 costs of a certain program; requiring the Governor, beginning in a certain fiscal year, 13 to include in the annual budget bill a certain amount to serve up to a certain number 14 of students subject to a certain limitation, a certain additional amount for a certain 15 number of additional students, and an additional amount based on a certain 16 calculation; prohibiting certain provisions of this Act from being construed to 17 prohibit a certain program from receiving funds from private, federal, or other 18 sources; providing for the application of certain provisions of law; defining a certain 19 term; and generally relating to expanding residential boarding education programs 20 for at-risk youth in the State.

- 2 (3) WAS INCLUDED IN THE FULL-TIME EQUIVALENT ENROLLMENT OF 3 THE COUNTY AS CALCULATED UNDER § 5–201 OF THIS ARTICLE.
- 4 (F) (1) IN ADDITION TO THE FUNDS DISBURSED IN ACCORDANCE WITH SUBSECTION (E) OF THIS SECTION, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION TO THE DEPARTMENT IN AN AMOUNT SUFFICIENT TO COVER THE TRANSPORTATION, BOARDING, AND ADMINISTRATIVE COSTS OF A PROGRAM ESTABLISHED UNDER THIS SECTION.
- 9 (2) (I) SUBJECT TO SUBPARAGRAPH (IV) OF THIS PARAGRAPH,
  10 FOR FISCAL YEAR 2023 AND EACH FISCAL YEAR THEREAFTER, THE GOVERNOR
  11 SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF AT LEAST
  12 \$4,300,000 TO THE DEPARTMENT FOR A PROGRAM TO SERVE UP TO 100 STUDENTS.
- 13 (II) FOR EACH ADDITIONAL 10 STUDENTS ENROLLED IN A
  14 PROGRAM, AS REPORTED BY THE DEPARTMENT, THE GOVERNOR SHALL INCLUDE
  15 IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF AN ADDITIONAL \$430,000.
- (III) FOR FISCAL YEAR 2023 AND EACH FISCAL YEAR
  THEREAFTER, FOR EACH STUDENT ENROLLED IN A PROGRAM, AS REPORTED BY THE
  DEPARTMENT, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN
  APPROPRIATION IN AN AMOUNT THAT IS AT LEAST EQUAL TO THE PRIOR YEAR PER
  PUPIL AMOUNT MULTIPLIED BY THE CHANGE IN THE PER PUPIL AMOUNT PLUS ONE.
- 21 (IV) THE TOTAL AMOUNT OF FUNDS APPROPRIATED UNDER 22 THIS PARAGRAPH MAY NOT EXCEED AN AMOUNT ADEQUATE TO FUND THE PER 23 PUPIL ALLOCATION FOR 400 STUDENTS FOR ANY FISCAL YEAR.
- 24 (G) THIS SECTION MAY NOT BE CONSTRUED TO PROHIBIT A PROGRAM FROM 25 RECEIVING FUNDS FROM PRIVATE, FEDERAL, OR OTHER SOURCES.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2021.
