3 **Clinical Professional Art Therapists**

4 FOR the purpose of altering the membership of the State Board of Professional
5 Counselors and Therapists ~~to include two members who are licensed as clinical~~
6 ~~professional art therapists~~; requiring certain individuals to be licensed by the
7 Board as clinical professional art therapists before performing certain work in
8 the State; establishing certain education and experience requirements to qualify
9 for a license to practice clinical professional art therapy; requiring the Board to
10 waive certain requirements under certain circumstances; providing that a
11 license authorizes certain individuals to practice clinical professional art
12 therapy while a license is effective; authorizing the Board to adopt certain
13 regulations allowing certain individuals to practice as licensed graduate
14 professional art therapists under certain supervision; establishing certain
15 requirements to qualify for a license to practice as a licensed graduate
16 professional art therapist; authorizing certain individuals to practice graduate
17 professional art therapy under certain supervision for a certain period of time;
18 prohibiting a licensee from surrendering a license under certain circumstances;
19 authorizing the Board to deny a license to an applicant, reprimand a licensee,
20 place a licensee on probation, or suspend or revoke a license under certain
21 circumstances; authorizing the State or the Board to maintain a certain action
22 to enjoin certain unauthorized practice or certain conduct; providing that
23 certain action is in addition to and not instead of certain prosecution;
24 authorizing certain committees or certain associations to be a counselor or

27 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
 28 MARYLAND, That the Laws of Maryland read as follows:

32 (b) “Alcohol and drug counseling” means assisting an individual, family, or
 33 group through the client–counselor relationship:

34 (1) To develop understanding of intrapersonal and interpersonal
 35 substance abuse problems;

36 (2) To define goals relating to substance abuse;

1 (3) To make decisions relating to substance abuse;

2 (4) To plan a course of action reflecting the needs, interests, and
3 abilities of the individual, family, or group relating to substance abuse; and

4 (5) To use informational and community substance abuse resources
5 relating to personal, social, emotional, educational, and vocational development and
6 adjustment.

7 (c) (1) “Appraisal” means:

8 (i) Selecting, administering, scoring, and interpreting
9 instruments designed to assess an individual’s aptitudes, attitudes, abilities,
10 achievements, interests, and personal characteristics; and

11 (ii) Using nonstandardized methods and techniques for
12 understanding human behavior in relation to coping with, adapting to, or changing life
13 situations.

14 (2) “Appraisal” does not include instruments which require specialized
15 psychological training for administration and interpretation unless the licensed
16 counselor or therapist has completed the training required under § 17–310 of this title.

17 **(D) “ART THERAPY” MEANS THE INTEGRATED USE OF**
18 **PSYCHOTHERAPEUTIC PRINCIPLES, ART MEDIA, AND THE CREATIVE PROCESS**
19 **TO ASSIST INDIVIDUALS, FAMILIES, OR GROUPS IN:**

20 **(1) INCREASING AWARENESS OF SELF AND OTHERS;**

21 **(2) COPING WITH SYMPTOMS, STRESS, AND TRAUMATIC**
22 **EXPERIENCES;**

23 **(3) ENHANCING COGNITIVE ABILITIES; AND**

24 **(4) IDENTIFYING AND ASSESSING CLIENTS’ NEEDS IN ORDER TO**
25 **IMPLEMENT THERAPEUTIC INTERVENTION TO MEET DEVELOPMENTAL,**
26 **BEHAVIORAL, MENTAL, AND EMOTIONAL NEEDS.**

27 **[(d)] (E)** “Board” means the State Board of Professional Counselors and
28 Therapists.

29 **[(e)] (F)** “Certificate” means a certificate issued by the Board to practice
30 professional counseling.

31 **[(f)] (G)** “Certified professional counselor” means a professional counselor
32 who is certified by the Board.

1 **[(g)] (H)** “Certified professional counselor–marriage and family therapist”
2 means an individual who is certified by the Board to practice marriage and family
3 therapy in the State.

4 **[(h)] (I)** (1) “Certified supervised counselor–alcohol and drug” means an
5 individual who is certified by the Board to practice alcohol and drug counseling in the
6 State pursuant to the limitations in § 17–404 of this title.

7 (2) “Certified associate counselor–alcohol and drug” means an
8 individual who is certified by the Board to practice alcohol and drug counseling in the
9 State pursuant to the limitations in § 17–403 of this title.

10 (3) “Certified professional counselor–alcohol and drug” means an
11 individual who is certified by the Board to practice alcohol and drug counseling in the
12 State.

13 **[(i)] (J)** “Counseling” means assisting an individual, family, or group
14 through the client–counselor relationship:

15 (1) To develop understanding of intrapersonal and interpersonal
16 problems;

17 (2) To define goals;

18 (3) To make decisions;

19 (4) To plan a course of action reflecting the needs, interests, and
20 abilities of the individual, family, or group; and

21 (5) To use informational and community resources, as these
22 procedures are related to personal, social, emotional, educational, and vocational
23 development and adjustment.

24 **[(j)] (K)** “Fund” means the State Board of Professional Counselors and
25 Therapists Fund.

26 **[(k)] (L)** “License” means, unless the context requires otherwise, one of six
27 types of licenses issued by the Board authorizing an individual to practice:

28 (1) Clinical alcohol and drug counseling;

29 (2) Clinical marriage and family therapy;

30 **(3) CLINICAL PROFESSIONAL ART THERAPY;**

- 1 ~~[(3)]~~ **(4)** Clinical professional counseling;
- 2 ~~[(4)]~~ **(5)** Graduate alcohol and drug counseling;
- 3 ~~[(5)]~~ **(6)** Graduate marriage and family therapy; ~~[or]~~
- 4 **(7)** **GRADUATE PROFESSIONAL ART THERAPY; OR**
- 5 ~~[(6)]~~ **(8)** Graduate professional counseling.

6 ~~[(l)]~~ **(M)** “Licensed graduate alcohol and drug counselor” means an
7 individual approved by the Board to practice graduate alcohol and drug counseling.

8 ~~[(m)]~~ **(N)** “Licensed graduate marriage and family therapist” means an
9 individual approved by the Board to practice graduate marriage and family therapy.

10 **(O)** **“LICENSED GRADUATE PROFESSIONAL ART THERAPIST” MEANS AN**
11 **INDIVIDUAL APPROVED BY THE BOARD TO PRACTICE GRADUATE**
12 **PROFESSIONAL ART THERAPY.**

13 ~~[(n)]~~ **(P)** “Licensed graduate professional counselor” means an individual
14 approved by the Board to practice graduate professional counseling.

15 ~~[(o)]~~ **(Q)** “Marriage and family therapy” means applying marriage and
16 family systems theory, principles, methods, therapeutic techniques, and research in:

17 (1) Resolving emotional conflict and modifying perception and
18 behavior in the context of marriage and family life; and

19 (2) The identification and assessment of client needs and the
20 implementation of therapeutic intervention.

21 ~~[(p)]~~ **(R)** “Practice alcohol and drug counseling” means to engage
22 professionally and for compensation in alcohol and drug counseling activities while
23 representing oneself to be a certified professional counselor–alcohol and drug, a
24 certified supervised counselor–alcohol and drug, or a certified associate counselor–
25 alcohol and drug.

26 ~~[(q)]~~ **(S)** “Practice clinical alcohol and drug counseling” means to engage
27 professionally and for compensation in alcohol and drug counseling and appraisal
28 activities by providing services involving the application of counseling principles and
29 methods in the diagnosis, prevention, treatment, and amelioration of psychological
30 problems and emotional or mental conditions of individuals or groups.

31 ~~[(r)]~~ **(T)** “Practice clinical marriage and family therapy” means to engage
32 professionally and for compensation in marriage and family therapy and appraisal

3 problems and emotional or mental conditions of individuals or groups.

4 **(U) “PRACTICE CLINICAL PROFESSIONAL ART THERAPY” MEANS TO**
5 **ENGAGE PROFESSIONALLY AND FOR COMPENSATION IN ART THERAPY AND**
6 **APPRAISAL ACTIVITIES BY PROVIDING SERVICES INVOLVING THE APPLICATION**
7 **OF ART THERAPY PRINCIPLES AND METHODS IN THE DIAGNOSIS, PREVENTION,**
8 **TREATMENT, AND AMELIORATION OF PSYCHOLOGICAL PROBLEMS AND**
9 **EMOTIONAL OR MENTAL CONDITIONS OF INDIVIDUALS OR GROUPS.**

10 **[(s)] (V)** “Practice clinical professional counseling” means to engage
11 professionally and for compensation in counseling and appraisal activities by
12 providing services involving the application of counseling principles and methods in
13 the diagnosis, prevention, treatment, and amelioration of psychological problems and
14 emotional or mental conditions of individuals or groups.

15 **[(t)] (W)** “Practice graduate alcohol and drug counseling” means to practice
16 clinical alcohol and drug counseling:

17 (1) Under the supervision of a licensed clinical alcohol and drug
18 counselor or another health care provider licensed under this article, as approved by
19 the Board; and

20 (2) While fulfilling the requirements for supervised experience under §
21 17–302 of this title.

22 **[(u)] (X)** “Practice graduate marriage and family therapy” means to practice
23 clinical marriage and family therapy:

24 (1) Under the supervision of a licensed clinical marriage and family
25 therapist or another health care provider licensed under this article, as approved by
26 the Board; and

27 (2) While fulfilling the requirements for supervised experience under §
28 17–303 of this title.

29 **(Y) “PRACTICE GRADUATE PROFESSIONAL ART THERAPY” MEANS TO**
30 **PRACTICE CLINICAL PROFESSIONAL ART THERAPY:**

31 **(1) UNDER THE SUPERVISION OF A LICENSED CLINICAL**
32 **PROFESSIONAL ART THERAPIST OR ANOTHER HEALTH CARE PROVIDER**
33 **LICENSED UNDER THIS ARTICLE, AS APPROVED BY THE BOARD; AND**

34 **(2) WHILE FULFILLING THE REQUIREMENTS FOR SUPERVISED**
35 **EXPERIENCE UNDER § 17–304.1 OF THIS TITLE.**

1 [(v)] (Z) “Practice graduate professional counseling” means to practice
2 clinical professional counseling:

3 (1) Under the supervision of a licensed clinical professional counselor
4 or another health care provider licensed under this article, as approved by the Board;
5 and

6 (2) While fulfilling the requirements for supervised experience under §
7 17–304 of this title.

8 [(w)] (AA) “Practice marriage and family therapy” means to engage
9 professionally and for compensation in marriage and family therapy activities while
10 representing oneself to be a certified professional counselor–marriage and family
11 therapist.

12 [(x)] (BB) “Practice professional counseling” means to engage professionally
13 and for compensation in counseling and appraisal activities while representing oneself
14 to be a certified professional counselor.

16 This title does not limit the right of an individual to practice a health occupation
17 that the individual is authorized to practice under this article.

19 There is a State Board of Professional Counselors and Therapists.

20 17–202.

21 (a) (1) The Board consists of ~~{13}~~ ~~11~~ members appointed by the Governor
22 with the advice of the Secretary.

23 (2) Of the ~~{13}~~ ~~11~~ Board members:

24 (i) [Five] ~~THREE~~ FOUR shall be licensed as clinical
25 professional counselors;

26 (ii) ~~{Three}~~ ~~TWO~~ shall be licensed as clinical marriage and
27 family therapists;

28 (iii) ~~{Three}~~ ~~TWO~~ shall be licensed as clinical alcohol and drug
29 counselors; [and]

1 (IV) ~~TWO~~ ONE SHALL BE LICENSED AS A CLINICAL

4 (3) The composition of the Board as to the race and sex of its members
5 shall reflect the composition of the population of the State.

8 professional counselors, marriage and family therapists, [or] alcohol and drug
9 counselors, **OR PROFESSIONAL ART THERAPISTS** may submit recommendations for
10 Board members to the Secretary.

11 (b) The consumer members of the Board:

12 (1) Shall be members of the general public;

13 (2) May not be or ever have been certified or licensed as a counselor or
14 therapist or in training to become certified or licensed as a counselor or therapist;

15 (3) May not have a household member who is certified or licensed as a
16 counselor or therapist or in training to become certified or licensed as a counselor or
17 therapist;

18 (4) May not participate or ever have participated in a commercial or
19 professional field related to professional counseling, marriage and family therapy, [or]
20 alcohol and drug counseling, **OR PROFESSIONAL ART THERAPY**;

21 (5) May not have a household member who participates in a
22 commercial or professional field related to professional counseling, marriage and
23 family therapy, [or] alcohol and drug counseling, **OR PROFESSIONAL ART THERAPY**;

24 (6) May not have had within 2 years before appointment a substantial
25 financial interest in a person regulated by the Board; and

26 (7) While members of the Board, may not have a substantial financial
27 interest in a person regulated by the Board.

28 (c) Before taking office, each appointee to the Board shall take the oath
29 required by Article I, § 9 of the Maryland Constitution.

30 (d) (1) The term of a member is 4 years.

31 (2) The terms of the members of the Board are staggered as required
32 by the terms of the members of the Board serving on July 1, 1988.

1 (3) At the end of a term, a member continues to serve until a successor
2 is appointed and qualifies.

3 (4) A member may not serve more than 2 consecutive full terms.

4 (5) To the extent practicable, the Governor shall fill any vacancy on
5 the Board within 60 days of the date of the vacancy.

6 (e) (1) The Governor may remove a member for incompetency,
7 misconduct, or neglect of duty.

8 (2) Upon the recommendation of the Secretary, the Governor may
9 remove a member whom the Secretary finds to have been absent from 2 successive
10 Board meetings without adequate reason.

31 individual who is duly licensed under this article.
