### An Act to Update Maine's Domestic Violence and Stalking Laws

(EMERGENCY)

1           **Emergency preamble.** Whereas, acts and resolves of the Legislature do not  
2 become effective until 90 days after adjournment unless enacted as emergencies; and

3           **Whereas**, on June 27, 2023, the United States Supreme Court issued a decision in  
4 *Counterman v. Colorado*, which has raised questions as to the constitutionality of several  
5 of Maine's statutes; and

6           **Whereas**, the statutes implicated include critical components of the State's public  
7 safety response, specifically including its response to domestic violence and stalking; and

8           **Whereas**, citizens of the State rely on the Legislature to ensure a constitutionally  
9 sound criminal and civil justice system and failure to timely align the statutes with the new  
10 federal standard may result in unnecessary litigation in the State's already overburdened  
11 state court system; and

12           **Whereas**, in the judgment of the Legislature, these facts create an emergency within  
13 the meaning of the Constitution of Maine and require the following legislation as  
14 immediately necessary for the preservation of the public peace, health and safety; now,  
15 therefore,

16           **Be it enacted by the People of the State of Maine as follows:**

17           **Sec. 1. 17-A MRSA §210, sub-§1**, as amended by PL 2003, c. 143, §4, is further  
18 amended to read:

19           **1.** A person is guilty of terrorizing if that person ~~in fact~~ intentionally, knowingly or  
20 recklessly communicates to any person a threat to commit or to cause to be committed a  
21 crime of violence dangerous to human life, against the person to whom the communication  
22 is made or another, ~~and~~ consciously disregarding a risk that the natural and probable  
23 consequence of such a threat, whether or not such consequence in fact occurs, is:

24           A. To place the person to whom the threat is communicated or the person threatened  
25 in reasonable fear that the crime will be committed. Violation of this paragraph is a  
26 Class D crime; or

27           B. To cause evacuation of a building, place of assembly or facility of public transport  
28 or to cause the occupants of a building to be moved to or required to remain in a  
29 designated secured area. Violation of this paragraph is a Class C crime.

30           **Sec. 2. 17-A MRSA §210-A, sub-§2, ¶A**, as amended by PL 2007, c. 685, §1, is  
31 repealed and the following enacted in its place:

32           A. "Course of conduct" means 2 or more acts, including but not limited to acts in which  
33 the actor, by any action, method, device or means, directly or indirectly:

34                   (1) Follows, monitors, tracks, observes, surveils or harasses a person;

35                   (2) Interferes with a person's property;

36                   (3) Threatens a person, consciously disregarding a risk that the actor's conduct  
37 would cause a reasonable person to experience any of the effects identified in  
38 subsection 1, paragraph A; or

39                   (4) Communicates to or about a person, consciously disregarding a risk that the  
40 actor's conduct would cause a reasonable person to experience any of the effects  
41 identified in subsection 1, paragraph A.

1 "Course of conduct" also includes, but is not limited to, threats implied by conduct and  
2 gaining unauthorized access to personal, medical, financial or other identifying or  
3 confidential information.

4 **Sec. 3. 17-A MRSA §506, sub-§1, ¶A,** as amended by PL 2017, c. 397, §1, is  
5 repealed and the following enacted in its place:

6 A. By means of telephone or electronic communication device the person  
7 intentionally, knowingly or recklessly makes any comment, request, suggestion or  
8 proposal without the consent of the person called or contacted:

9 (1) That is, in fact, obscene; or

10 (2) With conscious disregard of a risk that a reasonable person would find the  
11 comment, request, suggestion or proposal offensively coarse.

12 Violation of this paragraph is a Class E crime;

13 **Sec. 4. 19-A MRSA §4102, sub-§1, ¶B,** as enacted by PL 2021, c. 647, Pt. A, §3  
14 and affected by Pt. B, §65, is amended to read:

15 B. Attempting to place or placing another in fear of bodily injury, ~~regardless of intent,~~  
16 through any course of conduct, including, but not limited to, threatening, harassing or  
17 tormenting behavior. When the course of conduct violates this paragraph based on the  
18 content of the actor's speech, the actor must have consciously disregarded a risk that  
19 the speech would place a reasonable person in fear of bodily injury;

20 **Sec. 5. 19-A MRSA §4102, sub-§1, ¶E,** as enacted by PL 2021, c. 647, Pt. A, §3  
21 and affected by Pt. B, §65, is amended to read:

22 E. Communicating to a person a threat to commit, or to cause to be committed, a crime  
23 of violence dangerous to human life against the person to whom the communication is  
24 made or another, ~~and~~ with conscious disregard of a risk that the natural and probable  
25 consequence of the threat, whether or not that consequence in fact occurs, is to place  
26 the person to whom the threat is communicated, or the person against whom the threat  
27 is made, in reasonable fear that the crime will be committed;

28 **Emergency clause.** In view of the emergency cited in the preamble, this legislation  
29 takes effect when approved.

### 30 SUMMARY

31 This bill aligns the laws of this State with the new federal standard set by *Counterman*  
32 *v. Colorado*, 600 U.S. 66 (2023). It amends relevant sections of the Maine Criminal Code  
33 and the protection from abuse laws to provide that, with respect to a violation of the abuse  
34 laws or the crime of terrorizing, stalking or harassment by telephone based on the content  
35 of the actor's speech, the actor must have consciously disregarded a risk that the actor's  
36 speech would place a reasonable person in fear of bodily injury.
