

HOUSE SUBSTITUTE FOR
SENATE BILL NO. 628

A bill to amend 1990 PA 345, entitled
"State survey and remonumentation act,"
by amending section 12 (MCL 54.272), as amended by 2014 PA 166.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 12. (1) Money in the fund shall be used by the department
2 for the following purposes:

3 (a) Annual grants to the various counties to implement their
4 monumentation and remonumentation plans described in section
5 8(2) (a).

6 (b) The implementation of county plans that are initiated and
7 contracted for by the department under section 8(3).

8 (c) Annual grants to counties to implement their perpetual
9 monument maintenance ~~plan~~**plans** described in section 8(2) (d).



1 (d) The payment of contracts that are entered into by the
2 department under section 10.

3 (e) Other activities necessary, incidental, or appropriate to
4 implement this act.

5 (2) In addition to the purposes described in subsection (1),
6 money in the fund shall be used to pay the costs of expediting a
7 plan or to reimburse the cost described in section 8(4) ~~for a~~
8 county that has elected to expend or borrow money to expedite the
9 implementation of the county's plan.

10 (3) ~~Of Expenditures by the department for a county for the~~
11 ~~following purposes shall be in an amount not less than the~~
12 ~~following percentages of the money collected in that county and~~
13 ~~remitted to the state treasurer for deposit in the fund under~~

 23 boundary line pursuant to the Michigan and Indiana ~~Michigan-Indiana~~
 24 state line monumentation act, **the legislature may appropriate from**
 25 **the fund a total amount of not more than \$500,000.00 that was**
 26 **appropriated or transferred to the fund after November 1, 2021.** ~~7~~
