1.7	Section 1. Minnesota Statutes 2018, section 13.82, subdivision 15, is amended to read:
1.8	Subd. 15. Public benefit data. Any law enforcement agency may make any data
1.9	classified as confidential or protected nonpublic pursuant to subdivision 7 or as private or
1.10	nonpublic under section 13.825 or 626.19 accessible to any person, agency, or the public
1.11	if the agency determines that the access will aid the law enforcement process, promote
1.12	public safety, or dispel widespread rumor or unrest.

1.15	Subd. 32. Unmanned aerial vehicles. Section 626.19 governs data collected, created,

1.17	Sec. 3. [626.19] USE OF UNMANNED AERIAL VEHICLES.
1.18	Subdivision 1. Application; definitions. (a) This section applies to unmanned aerial
1.19	vehicle data collected, created, or maintained by a law enforcement agency and to law
1.20	enforcement agencies that maintain, use, or plan to use an unmanned aerial vehicle in
1.21	investigations, training, or in response to emergencies, incidents, and requests for service.

2.1	Unmanned aerial vehicle data collected, created, or maintained by a government entity is
2.2	classified under chapter 13.
2.3	(b) For purposes of this section, the following terms have the meanings given:
2.4	(1) "government entity" has the meaning given in section 13.02, subdivision 7a, except
2.5	that it does not include a law enforcement agency;
2.6	(2) "law enforcement agency" has the meaning given in section 626.84, subdivision 1;
2.7	(3) "unmanned aerial vehicle" or "UAV" means an aircraft that is operated without the
2.8	possibility of direct human intervention from within or on the aircraft; and

2.11	Subd. 2. Use of unmanned aerial vehicles limited. Except as provided in subdivision
2.12	3, a law enforcement agency must not use a UAV without a search warrant issued under

2.14	Subd. 3. Authorized use. A law enforcement agency may use a UAV:
2.15	(1) during or in the aftermath of an emergency situation that involves the risk of death
2.16	or bodily harm to a person;
2.17	(2) over a public event where there is a heightened risk to the safety of participants or

2.19	(3) to counter the risk of a terrorist attack by a specific individual or organization if the
2.20	agency determines that credible intelligence indicates a risk;
2.21	(4) to prevent the loss of life and property in natural or man-made disasters and to

2.23	disasters;

2.27	(7) to collect information for crash reconstruction purposes after a serious or deadly

2.29	(8) over a public area for officer training or public relations purposes; and

3.8	(c) A law enforcement agency must not deploy a UAV with facial recognition or other
3.9	biometric-matching technology unless expressly authorized by a warrant.
3.10	(d) A law enforcement agency must not equip a UAV with weapons.
3.11	(e) A law enforcement agency must not use a UAV to collect data on public protests or
3.12	demonstrations unless expressly authorized by a warrant or an exception applies under
3.13	subdivision 3.
3.14	Subd. 5. Documentation required. A law enforcement agency must document each
3.15	use of a UAV, connect each deployment to a unique case number, provide a factual basis
3.16	for the use of a UAV, and identify the applicable exception under subdivision 3 unless a
3.17	warrant was obtained.
3.18	Subd. 6. Data classification; retention. (a) Data collected by a UAV are private data
3.19	on individuals or nonpublic data, subject to the following:
3.20	(1) if the individual requests a copy of the recording, data on other individuals who do
3.21	not consent to its release must be redacted from the copy;
3.22	(2) UAV data may be disclosed as necessary in an emergency situation under subdivision

Information obtained or collected by a law enforcement agency in 4.4 violation of this section is not admissible as evidence in a criminal, administrative, or civil 4.5 proceeding against the data subject. 4.6 Subd. 8. (d) By June 15 of each year, the state court administrator shall submit to the chairs and ranking minority members of the senate and house of representatives committees having jurisdiction over data practices and public safety and post on the supreme court's website a full and complete report concerning the number of applications for warrants authorizing or approving use of UAVs or disclosure of information from the use of UAVs under this section and the number of warrants and extensions granted or denied under this section during the preceding calendar year. The report must include a summary and analysis of the data required to be filed with the state court administrator under paragraph (c).
