The bill was read for the first time and referred to the Committee on Finance

1.1 A bill for an act
1.2 relating to motor vehicles; authorizing issuance of special veterans plates for
1.3 recipient of silver star or bronze star; amending Minnesota Statutes 2008, section
1.4 168.123, subdivisions 1, 2.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2008, section 168.123, subdivision 1, is amended to read:

1.7 Subdivision 1. **General requirements; fees.** (a) On payment of a fee of \$10 for
1.8 each set of two plates, or for a single plate in the case of a motorcycle plate, payment of
1.9 the registration tax required by law, and compliance with other applicable laws relating to
1.10 vehicle registration and licensing, as applicable, the commissioner shall issue:

1.11 (1) special veteran's plates to an applicant who served in the active military service
1.12 in a branch of the armed forces of the United States or of a nation or society allied with the
1.13 United States in conducting a foreign war, was discharged under honorable conditions,
1.14 and is a registered owner of a passenger automobile, recreational motor vehicle, or
1.15 truck resembling a pickup truck and having a manufacturer's nominal rated capacity
1.16 of one ton, but which is not a commercial motor vehicle as defined in section 169.011,
1.17 subdivision 16; or

1.18 (2) a veteran's special motorcycle plate as described in subdivision 2, paragraph (a),
1.19 (f), (h), ~~or~~ (i), (j), or (k), or another special plate designed by the commissioner to an
1.20 applicant who is a registered owner of a motorcycle and meets the criteria listed in this
1.21 paragraph and in subdivision 2, paragraph (a), (f), (h), ~~or~~ (i), (j), or (k). Plates issued under
1.22 this clause must be the same size as regular motorcycle plates. Special motorcycle license
1.23 plates issued under this clause are not subject to section 168.1293.

2.1 (b) The additional fee of \$10 is payable for each set of veteran's plates, is payable
2.2 only when the plates are issued, and is not payable in a year in which stickers are issued
2.3 instead of plates.

2.4 (c) The veteran must have a certified copy of the veteran's discharge papers,
2.5 indicating character of discharge, at the time of application. If an applicant served in the
2.6 active military service in a branch of the armed forces of a nation or society allied with the
2.7 United States in conducting a foreign war and is unable to obtain a record of that service
2.8 and discharge status, the commissioner of veterans affairs may certify the applicant as
2.9 qualified for the veterans' plates provided under this section.

2.10 (d) For license plates issued for one-ton trucks described in paragraph (a), clause
2.11 (1), the commissioner shall collect a surcharge of \$5 on each \$10 fee collected under
2.12 paragraph (a). The surcharge must be deposited in the vehicle services operating account
2.13 in the special revenue fund.

2.14 **EFFECTIVE DATE.** This section is effective July 1, 2010.

2.15 Sec. 2. Minnesota Statutes 2008, section 168.123, subdivision 2, is amended to read:

2.16 Subd. 2. **Design.** The commissioner of veterans affairs shall design the emblem for
2.17 the veterans' special plates, subject to the approval of the commissioner, that satisfy the
2.18 following requirements:

2.19 (a) For a Vietnam veteran who served after July 1, 1961, and before July 1, 1978,
2.20 in the active military service in a branch of the armed forces of the United States or a
2.21 nation or society allied with the United States the special plates must bear the inscription
2.22 "VIETNAM VET" and the letters "V" and "V" with the first letter directly above the
2.23 second letter and both letters just preceding the first numeral of the special plate number.

2.24 (b) For a veteran stationed on the island of Oahu, Hawaii, or offshore, during the
2.25 attack on Pearl Harbor on December 7, 1941, the special plates must bear the inscription
2.26 "PEARL HARBOR SURVIVOR" and the letters "P" and "H" with the first letter directly
2.27 above the second letter and both letters just preceding the first numeral of the special
2.28 plate number.

2.29 (c) For a veteran who served during World War I or World War II, the plates must
2.30 bear the inscription "WORLD WAR VET" and:

2.31 (1) for a World War I veteran, the characters "W" and "I" with the first character
2.32 directly above the second character and both characters just preceding the first numeral
2.33 of the special plate number; or

3.1 (2) for a World War II veteran, the characters "W" and "II" with the first character
3.2 directly above the second character and both characters just preceding the first numeral of
3.3 the special plate number.

3.4 (d) For a veteran who served during the Korean Conflict, the special plates must
3.5 bear the inscription "KOREAN VET" and the letters "K" and "V" with the first letter
3.6 directly above the second letter and both letters just preceding the first numeral of the
3.7 special plate number.

3.8 (e) For a combat wounded veteran who is a recipient of the purple heart medal, the
3.9 plates must bear the inscription "COMBAT WOUNDED VET" and have a facsimile on an
3.10 emblem of the official purple heart medal and the letters "C" over "W" with the first letter
3.11 directly over the second letter just preceding the first numeral of the special plate number.

3.12 (f) For a Persian Gulf War veteran, the plates must bear the inscription "GULF
3.13 WAR VET" and the letters "G" and "W" with the first letter directly above the second
3.14 letter and both letters just preceding the first numeral of the special plate number. For
3.15 the purposes of this section, "Persian Gulf War veteran" means a person who served on
3.16 active duty after August 1, 1990, in a branch of the armed forces of the United States or
3.17 a nation or society allied with the United States or the United Nations during Operation
3.18 Desert Shield, Operation Desert Storm, or other military operation in the Persian Gulf
3.19 area combat zone as designated in United States Presidential Executive Order No. 12744,
3.20 dated January 21, 1991.

3.21 (g) For a veteran who served in the Laos War after July 1, 1961, and before July 1,
3.22 1978, the special plates must bear the inscription "LAOS WAR VET" and the letters "L"
3.23 and "V" with the first letter directly above the second letter and both letters just preceding
3.24 the first numeral of the special plate number.

3.25 (h) For a veteran who is the recipient of:

3.26 (1) the Iraq Campaign Medal, the special plates must be inscribed with a facsimile of
3.27 that medal and must bear the inscription "IRAQ WAR VET" directly below the special
3.28 plate number;

3.29 (2) the Afghanistan Campaign Medal, the special plates must be inscribed with a
3.30 facsimile of that medal and must bear the inscription "AFGHAN WAR VET" directly
3.31 below the special plate number; or

3.32 (3) the Global War on Terrorism Expeditionary Medal, the special plates must
3.33 be inscribed with a facsimile of that medal and must bear the inscription "GWOT
3.34 VETERAN" directly below the special plate number.

3.35 (i) For a veteran who is the recipient of the Global War on Terrorism Service Medal,
3.36 the special plates must be inscribed with a facsimile of that medal and must bear the

4.1 inscription "GWOT VETERAN" directly below the special plate number. In addition,
4.2 any member of the National Guard or other military reserves who has been ordered to
4.3 federally funded state active service under United States Code, title 32, as defined in
4.4 section 190.05, subdivision 5b, and who is the recipient of the Global War on Terrorism
4.5 Service Medal, is eligible for the license plate described in this paragraph, irrespective of
4.6 whether that person qualifies as a veteran under section 197.447.

4.7 (j) For a veteran who is a recipient of the Silver Star Medal, the plates must bear
4.8 the inscription "SILVER STAR" directly below the special plate number and must be
4.9 inscribed with a facsimile of that medal.

4.10 (k) For a veteran who is a recipient of the Bronze Star Medal, the plates must bear
4.11 the inscription "BRONZE STAR" directly below the special plate number and must be
4.12 inscribed with a facsimile of that medal.

4.13 **EFFECTIVE DATE.** This section is effective July 1, 2010.
