1.6	Section 1. [604.25] RIGHT OF PUBLICITY; CAUSE OF ACTION.
1.7	Subdivision 1. Definitions. "Photograph" means a film or digital photograph or
1.8	photographic reproduction, still or moving, or a videotape or live television transmission.
1.9	Subd. 2. Cause of action for right of publicity. (a) A person is liable in a civil
1.10	action for violating an individual's right of publicity if that person uses another individual
1.11	or a deceased individual's name, voice, signature, photograph, or likeness, in any manner,
1.12	without consent from the person or persons consistent with paragraph (b):
1.13	(1) on or in products, merchandise, goods, or services;
1.14	(2) for purposes of advertising or selling; or
1.15	(3) for soliciting purchases of products, merchandise, goods, or services.
1.16	(b) A person must have the prior consent of an individual to use their likeness for
1.17	any of the purposes listed in paragraph (a). When an individual has assigned or licensed
