2.3 Subd. 2. **Additional revenues; priority.** (a) If on the basis of a forecast of general fund
2.4 revenues and expenditures, the commissioner of management and budget determines that
2.5 there will be a positive unrestricted budgetary general fund balance at the close of the
2.6 biennium, the commissioner of management and budget must allocate money to the following
2.7 accounts and purposes in priority order:

2.8 (1) the cash flow account established in subdivision 1 until that account reaches
2.9 \$350,000,000;

2.10 (2) the budget reserve account established in subdivision 1a until that account reaches
2.11 \$1,596,522,000;

2.12 (3) the amount necessary to increase the aid payment schedule for school district aids

2.23 (b) The amounts necessary to meet the requirements of this section are appropriated
2.24 from the general fund within two weeks after the forecast is released or, in the case of
2.25 transfers under paragraph (a), clauses (3) ~~and~~₂ (4), and (5), as necessary to meet the
2.26 appropriations schedules otherwise established in statute.

2.27 (c) The commissioner of management and budget shall certify the total dollar amount

2.30 reduce the property tax shift percentage, and increase the special education aid payment

3.5 Subd. 13. **Aid payment percentage.** (a) Except as provided in subdivisions 11, 12, 12a,
3.6 and 14, each fiscal year, all education aids and credits in this chapter and chapters 120A,
3.7 120B, 121A, 122A, 123A, 123B, 124D, 124E, 125A, 125B, 126C, 134, and section 273.1392,
3.8 shall be paid at the current year aid payment percentage of the estimated entitlement during
3.9 the fiscal year of the entitlement.

3.10 (b) For the purposes of this subdivision, a district's estimated entitlement for special
3.11 education aid under section 125A.76 ~~for fiscal year 2014 and later~~ equals 97.4 percent of
3.12 the district's entitlement for the current fiscal year.

3.13 (c) The final adjustment payment, according to subdivision 9, must be the amount of
3.14 the actual entitlement, after adjustment for actual data, minus the payments made during
3.15 the fiscal year of the entitlement.
