1.1 A bill for an act

1.2 relating to capital investment; creating a new green infrastructure grant program;

1.3 amending criteria for certain projects funded through the clean water and drinking

1.4 water revolving funds; requiring rules and the prioritization of clean water and

1.5 drinking water projects in certain project priority lists to factor in new criteria;

1.6 appropriating money; amending Minnesota Statutes 2022, sections 116.182,

1.7 subdivision 5; 446A.07, subdivisions 1a, 7, 8; 446A.081, subdivisions 1, 12;

1.8 Minnesota Statutes 2023 Supplement, section 446A.081, subdivisions 8, 9;

1.9 proposing coding for new law in Minnesota Statutes, chapter 116.

1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2022, section 116.182, subdivision 5, is amended to read:

1.12 Subd. 5. **Rules.** The agency shall adopt rules for the administration of the financial  
1.13 assistance program. For wastewater treatment projects, the rules must include:

1.14 (1) application requirements;

1.15 (2) criteria for the ranking of projects in order of priority based on factors including:

1.16 (i) the type of project ~~and~~;

1.17 (ii) the degree of environmental impact, ~~and~~;

1.18 (iii) scenic and wild river standards; and

1.19 (iv) affordability criteria, as defined under section 446A.07, subdivision 1a, paragraph

1.20 (b); and

1.21 (3) criteria for determining essential project components.

2.1 Sec. 2. [116.196] GREEN INFRASTRUCTURE GRANT PROGRAM.

2.2 Subdivision 1. Establishment of program. The commissioner shall establish a green  
2.3 infrastructure grant program to provide grants for green infrastructure projects.

2.4 Subd. 2. Definitions. (a) For the purposes of this section, the following terms have the  
2.5 meanings given.

2.6 (b) "Commissioner" means the commissioner of the Pollution Control Agency.

2.7 (c) "Green infrastructure" has the meaning given in United States Code, title 33, section  
2.8 1362, as amended through December 31, 2019, and also includes trails, bridges, roads, and  
2.9 recreational amenities designed to mitigate stormwater impacts.

2.10 (d) "Political subdivision" means a county, home rule charter or statutory city, town, or  
2.11 other political subdivision of the state.

2.12 (e) "Project" means a green infrastructure project or stormwater infrastructure project  
2.13 to be owned and administered by a political subdivision.

2.14 (f) "Stormwater infrastructure" means a project that does one or more of the following:

2.15 (1) increases stormwater capacity or stormwater storage;

2.16 (2) addresses environmental damage caused by weather extremes;

2.17 (3) prevents localized flooding;

2.18 (4) creates stormwater systems that can manage flows from heavy rains;

2.19 (5) addresses public safety concerns caused by undersized stormwater systems; or

2.20 (6) ensures continuation of critical services during severe weather.

2.21 Subd. 3. Eligibility. A political subdivision is eligible to apply for and receive a grant  
2.22 under this section.

2.23 Subd. 4. Application. An application by a political subdivision for a grant under this  
2.24 section must be made at the time and in the form and manner prescribed by the commissioner.  
2.25 The commissioner must consult with the commissioner of management and budget on the  
2.26 form of the application, the content of a request for proposals published to solicit applications  
2.27 for the program under this section, and any prioritization criteria the commissioner intends  
2.28 to apply to the program.

2.29 Subd. 5. Eligible project. A grant may be used to acquire land or an interest in land,  
2.30 predesign, design, renovate, construct, furnish, and equip a project that is qualified to be  
2.31 funded by state general obligation bonds under the Minnesota Constitution, article XI,

3.1 section 5, paragraph (a). Money from the general fund may also be used for green  
 3.2 infrastructure and stormwater infrastructure that would not qualify to be funded by state  
 3.3 general obligation bonds.

3.4 Subd. 6. **Grants.** (a) To be eligible for a grant under this section, a political subdivision  
 3.5 must timely submit an application to the commissioner and pass a resolution in support of  
 3.6 the project. The commissioner may give priority to a political subdivision that provides a  
 3.7 local match of funds for the project.

3.8 (b) A grant awarded under this section must be no less than the amount required to  
 3.9 complete the project, less any local funds committed to the project as required by section  
 3.10 16A.502.

3.11 (c) A grant under this section is in addition to any loan, principal forgiveness, or grant  
 3.12 awarded by the Public Facilities Authority under section 446A.07, subdivision 8, paragraph  
 3.13 (a), clause (8), or 446A.081, subdivision 9, paragraph (a), clause (9).

3.14 Subd. 7. **Cancellation.** A grant under this section is available until the project is  
 3.15 completed or abandoned subject to section 16A.642.

3.16 **EFFECTIVE DATE.** This section is effective July 1, 2023.

3.18 Subd. 1a. **Definitions.** (a) For the purposes of this section, the terms in this subdivision  
 3.19 have the meanings given ~~them~~.

3.20 (b) "Affordability criteria," pursuant to section 603(i)(2) of the federal Clean Water Act,  
 3.21 means a project service area that includes, in whole or in part, a census tract where at least  
 3.22 three of the following apply as determined using the most recently published data from the  
 3.23 United States Census Bureau or United States Centers for Disease Control and Prevention:

3.24 (1) 20 percent or more of the residents have income below the federal poverty thresholds;

3.25 (2) the tract has a United States Centers for Disease Control and Prevention Social  
 3.26 Vulnerability Index greater than 0.80;

3.27 (3) the upper limit of the lowest quintile of household income is less than the state upper  
 3.28 limit of the lowest quintile;

3.29 (4) the housing vacancy rate is greater than the state average; or

3.30 (5) the percent of the population receiving Supplemental Nutrition Assistance Program  
 3.31 (SNAP) benefits is greater than the state average.

 4.4 Act, as amended, United States Code, title 33, sections 1251 et seq.

4.5 (e) "Green infrastructure" has the meaning given in section 116.196, subdivision 2,  
 4.6 paragraph (c).

4.7 Sec. 4. Minnesota Statutes 2022, section 446A.07, subdivision 7, is amended to read:

4.8 Subd. 7. **Loan conditions.** (a) When making loans from the clean water revolving fund,  
 4.9 the authority shall comply with the conditions of the Federal Water Pollution Control Act,  
 4.10 including the criteria in this subdivision.

4.11 (b) Loans must be made at or below market interest rates, including interest-free loans,  
 4.12 for terms not to exceed those allowed under the Federal Water Pollution Control Act.

4.13 (c) The annual principal and interest payments must begin no later than one year after  
 4.14 completion of the project. Loans must be fully amortized no later than 20 years after project  
 4.15 completion, unless the recipient's ~~average annual residential wastewater system cost after~~  
 4.16 ~~completion of the project would exceed 1.4 percent of median household income in the~~  
 4.17 ~~recipient governmental unit or entity~~ project meets affordability criteria, in which case the  
 4.18 loan must be fully amortized no later than 30 years after project completion.

 4.23 specifically allowed by the Federal Water Pollution Control Act.

4.24 (g) A loan made by the authority must be secured by notes or bonds of the eligible  
 4.25 recipient of the loan.

4.26 (h) Notwithstanding Minnesota Rules, part 7380.0272, the interest rate for loans made  
 4.27 for the purposes of green infrastructure is zero percent.

5.2 where debt was incurred and construction begun after March 7, 1985, at or below market

5.6 (3) to provide a source of revenue or security for the payment of principal and interest  
5.7 on revenue or general obligation bonds issued by the authority if the bond proceeds are

5.21 (8) to provide loans, principal forgiveness, or grants, including grants under section

5.29 for project components directly related to green infrastructure, water or energy efficiency  
5.30 improvements, or other environmentally innovative activities, up to a maximum of  
5.31 \$1,000,000. The authority must use the maximum amount of federal funds available for the  
5.32 purposes of green infrastructure each fiscal year beginning in fiscal year 2024. If in any  
5.33 fiscal year there is no maximum amount stated in federal law, regulation, or guidance as

 6.2 20 percent of the federal funds in the clean water revolving fund for green infrastructure

 6.28 to read:

6.29 Subd. 8. **Loan conditions.** (a) When making loans from the drinking water revolving  
 6.30 fund, the authority shall comply with the conditions of the federal Safe Drinking Water Act,  
 6.31 including the criteria in this subdivision.

7.1 (b) Loans must be made at or below market interest rates, including zero interest loans,  
7.2 for terms not to exceed those allowed under the federal Safe Drinking Water Act.

7.3 (c) The annual principal and interest payments must begin no later than one year after  
7.4 completion of the project. Loans must be amortized no later than 20 years after project  
7.5 completion, unless the ~~recipient's average annual residential drinking water system cost~~  
7.6 ~~after completion of the project would exceed 1.2 percent of median household income in~~  
7.7 ~~the recipient governmental unit or entity~~ project is identified as being located in a  
7.8 disadvantaged community, in which case the loan must be fully amortized no later than 30  
7.9 years after project completion.

7.10 (d) A loan recipient must identify and establish a dedicated source of revenue for  
7.11 repayment of the loan, and provide for a source of revenue to properly operate, maintain,  
7.12 and repair the water system.

7.13 (e) The fund must be credited with all payments of principal and interest on all loans,  
7.14 except the costs as permitted under section 446A.04, subdivision 5, paragraph (a).

7.15 (f) A loan may not be used to pay operating expenses or current obligations, unless  
7.16 specifically allowed by the federal Safe Drinking Water Act.

7.17 (g) A loan made by the authority must be secured by notes or bonds of the governmental  
7.18 unit and collateral to be determined by the authority for private borrowers.

7.19 (h) Notwithstanding any law or rule to the contrary, for projects to replace lead service  
7.20 lines, loan and grant agreements must not exceed ten years. The interest rate for loans to  
7.21 replace lead service lines shall be zero percent with principal payments commencing not  
7.22 later than 18 months after completion of the project.

7.23 (j) Notwithstanding Minnesota Rules, part 7380.0272, the interest rate for loans made  
7.24 for the purposes of green infrastructure is zero percent.

7.27 Subd. 9. **Other uses of fund.** (a) The drinking water revolving loan fund may be used  
7.28 as provided in the act, including the following uses:

7.29 (1) to buy or refinance the debt obligations, at or below market rates, of public water  
7.30 systems for drinking water systems, where the debt was incurred after the date of enactment  
7.31 of the act, for the purposes of construction of the necessary improvements to comply with  
7.32 the national primary drinking water regulations under the federal Safe Drinking Water Act;

- 8.1 (2) to purchase or guarantee insurance for local obligations to improve credit market  
8.2 access or reduce interest rates;
- 8.3 (3) to provide a source of revenue or security for the payment of principal and interest

 9.8 being available for the purposes of green infrastructure, the authority must use no less than  
 9.9 20 percent of the federal funds in the drinking water revolving loan fund for green  
 9.10 infrastructure and stormwater infrastructure projects eligible for funding through the green  
 9.11 infrastructure grant program under section 116.196.

9.13 Subd. 12. **Rules of the department.** (a) The Department of Health shall adopt rules  
 9.14 relating to the procedures for administration of the Department of Health's duties under the  
 9.15 act and this section.

9.16 (b) Rules that establish criteria for ranking new or upgraded water supply system projects  
 9.17 in order of priority must assign priority points for projects located in disadvantaged  
 9.18 communities.

9.19 Sec. 10. **INTERIM PROJECT PRIORITY LIST RECOMMENDATIONS;**  
 9.20 **POLLUTION CONTROL AGENCY.**

9.21 Until rules factoring in affordability criteria are adopted under Minnesota Statutes,  
 9.22 section 116.182, subdivision 5, the commissioner of the Pollution Control Agency must  
 9.23 review each project priority list developed and provide recommendations to the Public  
 9.24 Facilities Authority that prioritize the projects based on affordability criteria. The Public  
 9.25 Facilities Authority must use the recommendations when developing the intended use plan  
 9.26 developed under Minnesota Statutes, section 446A.07.

9.27 Sec. 11. **INTERIM PROJECT PRIORITY LIST RECOMMENDATIONS;**  
 9.28 **COMMISSIONER OF HEALTH.**

9.29 Until rules factoring in disadvantaged communities are adopted under Minnesota Statutes,  
 9.30 section 446A.081, subdivision 12, the commissioner of health must review each project  
 9.31 priority list developed and provide recommendations to the Public Facilities Authority that  
 9.32 prioritize the projects based on being located in a disadvantaged community. The Public

10.1 Facilities Authority must use the recommendations when developing the intended use plan  
 10.2 developed under Minnesota Statutes, section 446A.081, subdivision 5.

10.3 **Sec. 12. APPROPRIATIONS; GREEN INFRASTRUCTURE PROGRAM.**

10.4 Subdivision 1. Appropriation; state general obligation bonds. \$..... is appropriated  
 10.5 from the bond proceeds fund to the Pollution Control Agency for grants under Minnesota  
 10.6 Statutes, section 116.196.

10.7 Subd. 2. Appropriation; general fund. \$..... in fiscal year 2025 is appropriated from  
 10.8 the general fund to the Pollution Control Agency for grants under Minnesota Statutes, section  
 10.9 116.196.

10.10 Subd. 3. Bond sale. To provide the money appropriated in this section from the bond  
 10.11 proceeds fund, the commissioner of management and budget shall sell and issue bonds of  
 10.12 the state in an amount up to \$..... in the manner, upon the terms, and with the effect  
 10.13 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota  
 10.14 Constitution, article XI, sections 4 to 7.

10.15 **EFFECTIVE DATE.** This section is effective July 1, 2024.

10.16 **Sec. 13. APPROPRIATION; GREEN INFRASTRUCTURE PROJECTS.**

10.17 (a) Of an appropriation in fiscal year 2025 for the green infrastructure grant program  
 10.18 under Minnesota Statutes, section 116.196, the Pollution Control Agency must award grants  
 10.19 to:

10.20 (1) the Minneapolis Park and Recreation Board to replace, relocate, and improve public  
 10.21 park and water management infrastructure along Shingle, Bassett's, and Minnehaha Creeks  
 10.22 in Minneapolis; and

10.23 (2) Dakota County for a green infrastructure pilot project on a 2.4-mile segment of the  
 10.24 Mississippi River Greenway.

10.25 (b) A grant awarded under this section must be no less than the amount required to  
 10.26 complete the project, less any local money committed to the project, as required by Minnesota  
 10.27 Statutes, section 16A.502.

10.28 (c) The Pollution Control Agency must not award a grant under this section unless the  
 10.29 application required under Minnesota Statutes, section 116.196, subdivision 4, has been  
 10.30 completed.

10.31 **EFFECTIVE DATE.** This section is effective July 1, 2024.
