1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. Minnesota Statutes 2018, section 609.341, subdivision 10, is amended to read:
1.8	Subd. 10. Position of authority. "Position of authority" includes but is not limited to
1.9	any person who is a parent or acting in the place of a parent and charged with any of a
1.10	parent's rights, duties or responsibilities to a child, or a person who is charged with any duty
1.11	or responsibility for the health, welfare, or supervision of a child, either independently or
1.12	through another, no matter how brief, at the time of the act. For the purposes of subdivision
1.13	11, "position of authority" includes a psychotherapist. For the purposes of sections 609.344,
1.14	subdivision 1, paragraph (e), clause (2), and 609.345, subdivision 1, paragraph (e), clause
1.15	(2), the term extends to a person having the described authority over a student in a secondary
1.16	school who is at least 16 but less than 21 years of age under the circumstances described in
1.17	those two clauses.

Subdivision 1. Crime defined. A person who engages in sexual penetration with another
person is guilty of criminal sexual conduct in the third degree if any of the following
circumstances exists:

(a) the complainant is under 13 years of age and the actor is no more than 36 months
older than the complainant. Neither mistake as to the complainant's age nor consent to the
act by the complainant shall be a defense;

(b) the complainant is at least 13 but less than 16 years of age and the actor is more than
2.15 24 months older than the complainant. In any such case if the actor is no more than 120
2.16 months older than the complainant, it shall be an affirmative defense, which must be proved

age shall not be a defense;

6.22 Sections 1 to 5 are effective August 1, 2019, and apply to crimes committed on or after
6.23 <u>that date.</u>
