The department may not issue an enhanced identification card to an individual who is under 16 years of age, not a resident of this state, or not a citizen of the United States of America. The card must bear: (1) a distinguishing number assigned to the applicant; (2) a colored photograph or an electronically produced image of the applicant; (3) the applicant's full name and date of birth; (4) either (i) the licensee's residence address, or (ii) the designated address under section 5B.05; (5) a description of the applicant in the manner as the commissioner deems necessary; (6) the usual signature of the applicant; and (7) designations and markings provided under this section.

- (b) If the United States Postal Service will not deliver mail to (1) the applicant's residence address as listed on the Minnesota identification card, or (2) the applicant's designated secondary mailing address, then the applicant shall must provide verification from the United States Postal Service that mail will not be delivered to the applicant's residence address or designated secondary mailing address and that mail will be delivered to a specified alternate mailing address, which must be distinct from a designated secondary mailing address in section 171.06, subdivision 3c.
