1.7	Section 1. Minnesota Statutes 2008, section 16C.16, is amended by adding a
1.8	subdivision to read:
1.9	Subd. 6a. Veteran-owned businesses. (a) The commissioner shall award up to a
1.10	six percent preference, but no less than the percentage awarded to any other group under
1.11	this section, in the amount bid on state procurement to certified small businesses that
1.12	are majority-owned and operated either:
1.13	(1) by veterans, as indicated by the person's United States Department of Defense
1.14	form DD-214 or by the commissioner of veterans affairs; or
1.15	(2) by veterans having service-connected disabilities, as determined at any time by
1.16	the United States Department of Veterans Affairs.
1.17	(b) The purpose of this designation is to facilitate the transition of veterans from
1.18	military to civilian life, and to help compensate veterans for their sacrifices, including but
1.19	not limited to their sacrifice of health and time, to the state and nation during their military
1.20	service, as well as to enhance economic development within Minnesota.
1.21	(c) For purposes of this section and section 16C.19, the following terms have the
1.22	meanings given them:
1.23	(1) "veteran" has the meaning given in section 197.447;

2.8	businesses, and small businesses located in economically disadvantaged areas are eligible

- to participate under the requirements of sections 16C.16 to 16C.21. The commissioner shall adopt by rule standards and procedures for hearing appeals and grievances and other rules necessary to carry out the duties set forth in sections 16C.16 to 16C.21.

 (b) The commissioner may make rules which exclude or limit the participation of
 - nonmanufacturing business, including third-party lessors, brokers, franchises, jobbers, manufacturers' representatives, and others from eligibility under sections 16C.16 to 16C.21.
 - (c) The commissioner may make rules that set time limits and other eligibility limits on business participation in programs under sections 16C.16 to 16C.21.
 - (d) Notwithstanding paragraphs (b) and (c), for purposes of sections 16C.16 to 16C.21, a veteran-owned small business or service-disabled veteran-owned small business, the principal place of business of which is in Minnesota, is certified if it has been verified by the United States Department of Veterans Affairs as being a veteran-owned small business or service disabled veteran-owned small business in accordance with Public Law 109-461 and Code of Federal Regulations, title 38, part 74.
