1.8	Subdivision 1. Definitions. (a) For the purposes of this section, the following terms have
1.9	the meanings given.
1.10	(b) "Eligible school" means a school district or school site operated by a school district,
1.11	charter school, or Tribal contract or grant school eligible for state aid under Minnesota
1.12	Statutes, section 124D.83, or cooperative unit under Minnesota Statutes, section 123A.24,

1.14	(c) "Eligible service-learning partnership" means a partnership that includes an eligible
1.15	school and at least one community-based organization, community education program, state
1.16	or federal agency, or political subdivision. An eligible service-learning partnership may

2.1 Subd. 2. Establishment; eligibility criteria; application requirements. (a) A technical 2.2 assistance and grant program is established to initiate or expand and strengthen innovative 2.3 service-learning opportunities for students in kindergarten through grade 12; increase student 2.4 engagement and academic achievement; help close the academic achievement gap and the 2.5 community, college, and career opportunity gaps; and create a positive school climate and 2.6 safer schools and communities.

(b) At least one teacher, administrator, or program staff member and at least one 2.7 service-learning specialist, service-learning coordinator, curriculum specialist, or other 2.8 qualified employee employed by an eligible school and designated to develop and share 2.9 expertise in implementing service-learning best practices must work with students to form 2.10 a student-adult partnership. Before developing and submitting a grant application to the 2.11 department, a participating student must work with at least one adult who is part of the 2.12 initial partnership to identify a need or opportunity to pursue through a service-learning 2.13 partnership and invite at least one partner to collaborate in developing and submitting a 2.14 grant application. The fiscal agent for the grant to an eligible service-learning partnership 2.15 is an eligible school that is a member of the partnership or has a program that is a member 2.16 of the partnership. 2.17

(1) include at least two or more enrolled students; two or more school employees of an

- (d) An eligible service-learning partnership interested in receiving a grant must apply 3.1 to the commissioner of education in the form and manner determined by the commissioner. 3.2 The partnership must work with an eligible school. Consistent with this subdivision, the 3.3

application must describe the eligible service-learning partnership plan to: 3.4

- (1) incorporate student-designed and student-led service-learning into the school 3.5 curriculum or specific courses or across subject areas; 3.6
- (2) provide students with instruction and experiences using service-learning best practices 3.7 during the regular school day with an option to supplement their service-learning experiences 3.8 outside of the school day; 3.9

Grant awards must 3.26 be equitably distributed throughout Minnesota by congressional district. The commissioner 3.27 may designate start-up or leader grant categories with differentiated maximum grant dollar 3.28 amounts up to \$50,000 \$75,000. A grantee designated as a leader grantee may be required 3.29 to meet additional leader grant requirements as established by the commissioner in the grant 3.30 application criteria developed by the commissioner. In order to receive a grant, a partnership 3.31 must provide a 50 percent match in funds or in-kind contributions unless the commissioner 3.32 waives the match requirement for an applicant serving a high number of students whose 3.33 families meet federal poverty guidelines. A partnership grantee must allocate the grant 3.34

amount according to its grant application. The partnership must convey 50 percent of the
actual grant amount to at least one community-based organization, community education

A grantee must report to the commissioner on the educational and 4.7 4.8 developmental outcomes of participating students and the eligible school's progress toward meeting at least one goal of the world's best workforce comprehensive achievement and 4.9 academic readiness goals in accordance with Minnesota Statutes, section 120B.11, or the 4.10 state plan submitted and approved under the most recent reauthorization of the Elementary 4.11 and Secondary Education Act. A grantee must report on the community outcomes achieved 4.12 through student service-learning experiences and the corresponding student service activities. 4.13 The commissioner must submit a report on participating student and community outcomes 4.14 under this section to the legislative committees with jurisdiction over kindergarten through 4.15 grade 12 education by February 15, 2025 in each odd-numbered year. 4.16
