1.2 relating to health care coverage; providing a temporary program to help pay for

1.3 health insurance premiums; requiring audits by the legislative auditor; modifying

1.4 requirements for health maintenance organizations; modifying provisions governing

1.15 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.16 **ARTICLE 1**

1.17 **PREMIUM SUBSIDY PROGRAM**

1.18 Section 1. **DEFINITIONS.**

1.19 Subdivision 1. **Scope.** For purposes of sections 1 to 6, the following terms have the

1.20 meanings given.

1.21 Subd. 2. **Commissioner.** "Commissioner" means the commissioner of Minnesota

1.22 Management and Budget.

1.23 Subd. 3. **Eligible individual.** "Eligible individual" means a Minnesota resident who:

1.24 (1) is not receiving a premium tax credit under Code of Federal Regulations, title 26,

1.25 section 1.36B-2, as of the date their coverage is effectuated;

2.1 (2) is not enrolled in public program coverage under Minnesota Statutes, section
2.2 256B.055, or 256L.04; and

2.3 (3) purchased an individual health plan from a health carrier in the individual market.

2.4 Subd. 4. **Gross premium.** "Gross premium" means the amount billed for a health plan
2.5 purchased by an eligible individual prior to a premium subsidy in a calendar year.

2.6 Subd. 5. **Health carrier.** "Health carrier" has the meaning given in Minnesota Statutes,
2.7 section 62A.011, subdivision 2.

2.8 Subd. 6. **Individual health plan.** "Individual health plan" has the meaning given in
2.9 Minnesota Statutes, section 62A.011, subdivision 4.

2.10 Subd. 7. **Individual market.** "Individual market" has the meaning given in Minnesota
2.11 Statutes, section 62A.011, subdivision 5.

2.12 Subd. 8. **Net premium.** "Net premium" means the gross premium less the premium
2.13 subsidy.

2.14 Subd. 9. **Premium subsidy.** "Premium subsidy":

2.15 (1) is a payment made on behalf of eligible individuals for the promotion of general
2.16 welfare, and is not compensation for any services;

2.17 (2) is equal to 25 percent of the monthly gross premium otherwise paid by or on behalf
2.18 of the eligible individual for coverage purchased in the individual market, that covers the
2.19 eligible individual and the eligible individual's spouse and dependents, or the percentage
2.20 established by the commissioner under section 2, subdivision 3, paragraph (c); and

2.21 (3) is excluded from any calculation used to determine eligibility within any of the
2.22 Department of Human Services programs.

2.23 Sec. 2. **PAYMENT TO HEALTH CARRIERS ON BEHALF OF ELIGIBLE**
2.24 **INDIVIDUALS.**

2.25 Subdivision 1. **Program established.** The commissioner of Minnesota Management
2.26 and Budget, in consultation with the commissioner of commerce and the commissioner of
2.27 human services, shall establish and administer the premium subsidy program authorized by
2.28 this act, to help eligible individuals pay for coverage in the individual market in 2017.

2.29 Subd. 2. **Premium subsidy provided.** As soon as practicable, but no later than April
2.30 30, 2017, health carriers shall begin paying a premium subsidy to each eligible individual
2.31 who purchases a health plan in the individual market, for all the months for which the net

3.1 premium is paid. An eligible individual shall pay the net premium amount to the health
3.2 carrier.

3.3 Subd. 3. **Payments to health carriers.** (a) The commissioner shall make payments to
3.4 health carriers on behalf of eligible individuals effectuating coverage for calendar year 2017,
3.5 for the months in that year for which the individual has paid the net premium amount to the
3.6 health carrier. Payments to health carriers shall be based on the premium subsidy available
3.7 to eligible individuals in the individual market, regardless of the cost of coverage purchased.
3.8 The commissioner shall not withhold payments because a health carrier cannot prove an
3.9 enrollee is an eligible individual.

3.10 (b) Health carriers seeking reimbursement from the commissioner must submit an invoice
3.11 and supporting information to the commissioner, using a form developed by the
3.12 commissioner, in order to be eligible for payment. The commissioner shall finalize the form
3.13 by March 1, 2017.

3.14 (c) Total state payments to health carriers must be made within the limits of the available
3.15 appropriation. The commissioner shall reimburse health carriers at the full requested amount
3.16 up to the level of the appropriation. The commissioner, by July 15, 2017, shall determine
3.17 whether the available appropriation will be sufficient to provide premium subsidies equal
3.18 to 25 percent of the gross premium for the period September 1, 2017, through December
3.19 31, 2017. If the commissioner determines that the available appropriation is not sufficient,
3.20 the commissioner shall reduce the premium subsidy percentage, beginning September 1,
3.21 2017, through the remainder of the calendar year, by an amount sufficient to ensure that the
3.22 total amount of premium subsidies provided for the calendar year does not exceed the
3.23 available appropriation. The commissioner shall notify health carriers of any reduced
3.24 premium subsidy percentage within five days of making a determination. Health carriers
3.25 shall provide enrollees with at least 30 days' notice of any reduction in the premium subsidy
3.26 percentage.

3.27 (d) The commissioner shall consider health carriers as vendors under Minnesota Statutes,
3.28 section 16A.124, subdivision 3, and each monthly invoice shall represent the completed
3.29 delivery of the service.

3.30 Subd. 4. **Data practices.** (a) The definitions in Minnesota Statutes, section 13.02, apply
3.31 to this subdivision.

3.32 (b) Government data on an enrollee or health carrier under this section are private data
3.33 on individuals or nonpublic data, except that the total reimbursement requested by a health
3.34 carrier and the total state payment to the health carrier are public data.

4.1 (c) Notwithstanding Minnesota Statutes, section 138.17, government data on an enrollee
4.2 or health carrier under this section must be destroyed by June 30, 2018, or upon completion
4.3 by the legislative auditor of the audits required by section 3, whichever is later.

4.4 **Sec. 3. AUDITS.**

4.5 (a) The legislative auditor shall conduct audits of the health carriers' supporting data, as
4.6 prescribed by the commissioner, to determine whether payments align with criteria
4.7 established in sections 1 and 2. The commissioner of human services shall provide data as
4.8 necessary to the legislative auditor to complete the audit. The commissioner shall withhold
4.9 or charge back payments to the health carriers to the extent they do not align with the criteria
4.10 established in sections 1 and 2, as determined by the audit.

4.11 (b) The legislative auditor shall audit the extent to which health carriers provided premium
4.12 subsidies to persons meeting the residency and other eligibility requirements specified in
4.13 section 1, subdivision 3. The legislative auditor shall report to the commissioner the amount
4.14 of premium subsidies provided by each health carrier to persons not eligible for a premium
4.15 subsidy. The commissioner, in consultation with the commissioners of commerce and health,
4.16 shall develop and implement a process to recover from health carriers the amount of premium
4.17 subsidies received for enrollees determined to be ineligible for premium subsidies by the
4.18 legislative auditor. The legislative auditor, when conducting the required audit, and the
4.19 commissioner, when determining the amount of premium subsidy to be recovered, may
4.20 take into account the extent to which a health carrier makes use of the Minnesota eligibility
4.21 system, as defined in Minnesota Statutes, section 62V.055, subdivision 1.

4.22 **Sec. 4. APPLICABILITY OF GROSS PREMIUM.**

4.23 Notwithstanding premium subsidies provided under section 2, the premium base for
4.24 calculating the amount of any applicable premium taxes under Minnesota Statutes, chapter
4.25 297I, shall be the gross premium for health plans purchased by eligible individuals in the
4.26 individual market.

4.27 **Sec. 5. SUNSET.**

4.28 This article sunsets June 30, 2018.

4.29 **Sec. 6. TRANSFER.**

4.30 \$326,945,000 in fiscal year 2017 is transferred from the budget reserve account in
4.31 Minnesota Statutes, section 16A.152, subdivision 1a, to the general fund.

5.1 Sec. 7. **APPROPRIATIONS.**

5.2 (a) \$311,788,000 in fiscal year 2017 is appropriated from the general fund to the
5.3 commissioner of management and budget for premium assistance under section 2. This
5.4 appropriation is onetime and is available through June 30, 2018.

5.5 (b) \$157,000 in fiscal year 2017 is appropriated from the general fund to the legislative
5.6 auditor for purposes of section 3. This appropriation is onetime.

5.7 (c) Any unexpended amount from the appropriation in paragraph (a) after June 30, 2018,
5.8 shall be transferred on July 1, 2018, from the general fund to the budget reserve account
5.9 under Minnesota Statutes, section 16A.152, subdivision 1a.

5.10 Sec. 8. **EFFECTIVE DATE.**

5.11 Sections 1 to 7 are effective the day following final enactment.

5.13 **INSURANCE MARKET REFORMS**

5.14 Section 1. Minnesota Statutes 2016, section 60A.08, subdivision 15, is amended to read:

5.15 Subd. 15. **Classification of insurance filings data.** (a) All forms, rates, and related
5.16 information filed with the commissioner under section 61A.02 shall be nonpublic data until
5.17 the filing becomes effective.

5.18 (b) All forms, rates, and related information filed with the commissioner under section
5.19 62A.02 shall be nonpublic data until the filing becomes effective.

5.20 (c) All forms, rates, and related information filed with the commissioner under section
5.21 62C.14, subdivision 10, shall be nonpublic data until the filing becomes effective.

5.22 (d) All forms, rates, and related information filed with the commissioner under section
5.23 70A.06 shall be nonpublic data until the filing becomes effective.

5.24 (e) All forms, rates, and related information filed with the commissioner under section
5.25 79.56 shall be nonpublic data until the filing becomes effective.

5.26 (f) Notwithstanding paragraphs (b) and (c), for all rate increases subject to review under
5.27 section 2794 of the Public Health Services Act and any amendments to, or regulations, or
5.28 guidance issued under the act that are filed with the commissioner on or after September 1,
5.29 2011, the commissioner:

5.30 (1) may acknowledge receipt of the information;

6.1 (2) may acknowledge that the corresponding rate filing is pending review;

6.2 (3) must provide public access from the Department of Commerce's Web site to parts I
6.3 and II of the Preliminary Justifications of the rate increases subject to review; and

6.4 (4) must provide notice to the public on the Department of Commerce's Web site of the
6.5 review of the proposed rate, which must include a statement that the public has 30 calendar
6.6 days to submit written comments to the commissioner on the rate filing subject to review.

6.7 (g) Notwithstanding paragraphs (b) and (c), for all proposed premium rates filed with
6.8 the commissioner for individual health plans, as defined in section 62A.011, subdivision 4,
6.9 and small group health plans, as defined in section 62K.03, subdivision 12, the commissioner
6.10 must provide public access on the Department of Commerce's Web site to compiled data
6.11 of the proposed changes to rates, separated by health plan and geographic rating area, within
6.12 ten business days after the deadline by which health carriers, as defined in section 62A.011,
6.13 subdivision 2, must submit proposed rates to the commissioner for approval.

6.14 **EFFECTIVE DATE.** This section is effective 30 days following final enactment.

6.15 Sec. 2. Minnesota Statutes 2016, section 60A.235, subdivision 3, is amended to read:

6.16 Subd. 3. **Health plan policies issued as stop loss coverage.** (a) An insurance company
6.17 or health carrier issuing or renewing an insurance policy or other evidence of coverage, that
6.18 provides coverage to an employer for health care expenses incurred under an
6.19 employer-sponsored plan provided to the employer's employees, retired employees, or their
6.20 dependents, shall issue the policy or evidence of coverage as a health plan if the policy or
6.21 evidence of coverage:

6.22 (1) has a specific attachment point for claims incurred per individual that is lower than
6.23 \$20,000; or

6.24 ~~(2) has an aggregate attachment point, for groups of 50 or fewer, that is lower than the~~
6.25 ~~greater of:~~

6.26 ~~(i) \$4,000 times the number of group members;~~

6.27 ~~(ii) 120 percent of expected claims; or~~

6.28 ~~(iii) \$20,000; or~~

6.29 ~~(3)~~ (2) has an aggregate attachment point for groups of 51 or more that is lower than
6.30 110 percent of expected claims.

7.1 (b) An insurer shall determine the number of persons in a group, for the purposes of this
 7.2 section, on a consistent basis, at least annually. Where the insurance policy or evidence of
 7.3 coverage applies to a contract period of more than one year, the dollar amounts set forth in
 7.4 paragraph (a), ~~clauses clause (1) and (2)~~, must be multiplied by the length of the contract
 7.5 period expressed in years.

7.6 ~~(e) The commissioner may adjust the constant dollar amounts provided in paragraph~~
 7.7 ~~(a), clauses (1), (2), and (3), on January 1 of any year, based upon changes in the medical~~
 7.8 ~~component of the Consumer Price Index (CPI). Adjustments must be in increments of \$100~~
 7.9 ~~and must not be made unless at least that amount of adjustment is required. The commissioner~~
 7.10 ~~shall publish any change in these dollar amounts at least six months before their effective~~
 7.11 ~~date.~~

7.12 ~~(d)~~ (c) A policy or evidence of coverage issued by an insurance company or health carrier
 7.13 that provides direct coverage of health care expenses of an individual including a policy or
 7.14 evidence of coverage administered on a group basis is a health plan regardless of whether
 7.15 the policy or evidence of coverage is denominated as stop loss coverage.

7.16 **EFFECTIVE DATE.** This section is effective June 1, 2017, and applies to policies or
 7.17 evidence of coverage offered, issued, or renewed to an employer on or after that date.

7.18 Sec. 3. Minnesota Statutes 2016, section 60A.236, is amended to read:

7.19 **60A.236 STOP LOSS REGULATION; SMALL EMPLOYER COVERAGE.**

7.20 A contract providing stop loss coverage, issued or renewed to a small employer, as
 7.21 defined in section 62L.02, subdivision 26, or to a plan sponsored by a small employer, must
 7.22 include a claim settlement period no less favorable to the small employer or plan than
 7.23 coverage of all the following:

7.24 (1) claims incurred during the contract period regardless of when the claims are; and

7.25 (2) paid by the plan during the contract period or within three months after expiration
 7.26 of the contract period.

7.27 **EFFECTIVE DATE.** This section is effective June 1, 2017, and applies to policies or
 7.28 evidence of coverage offered, issued, or renewed to an employer on or after that date.

7.29 Sec. 4. Minnesota Statutes 2016, section 62D.02, subdivision 4, is amended to read:

7.30 Subd. 4. **Health maintenance organization.** ~~(a)~~ "Health maintenance organization"
 7.31 means a nonprofit foreign or domestic corporation organized under chapter 317A, or a local

8.1 governmental unit as defined in subdivision 11, controlled and operated as provided in
 8.2 sections 62D.01 to 62D.30, which provides, either directly or through arrangements with
 8.3 providers or other persons, comprehensive health maintenance services, or arranges for the
 8.4 provision of these services, to enrollees on the basis of a fixed prepaid sum without regard
 8.5 to the frequency or extent of services furnished to any particular enrollee.

8.6 (b) [~~Expired~~]

8.7 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.8 Sec. 5. Minnesota Statutes 2016, section 62D.03, subdivision 1, is amended to read:

8.9 Subdivision 1. **Certificate of authority required.** Notwithstanding any law of this state
 8.10 to the contrary, any ~~nonprofit~~ foreign or domestic corporation organized to do so or a local
 8.11 governmental unit may apply to the commissioner of health for a certificate of authority to
 8.12 establish and operate a health maintenance organization in compliance with sections 62D.01
 8.13 to 62D.30. No person shall establish or operate a health maintenance organization in this
 8.14 state, nor sell or offer to sell, or solicit offers to purchase or receive advance or periodic
 8.15 consideration in conjunction with a health maintenance organization or health maintenance
 8.16 contract unless the organization has a certificate of authority under sections 62D.01 to
 8.17 62D.30.

8.18 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.19 Sec. 6. Minnesota Statutes 2016, section 62D.05, subdivision 1, is amended to read:

8.20 Subdivision 1. **Authority granted.** Any ~~nonprofit~~ corporation or local governmental
 8.21 unit may, upon obtaining a certificate of authority as required in sections 62D.01 to 62D.30,
 8.22 operate as a health maintenance organization.

8.23 **EFFECTIVE DATE.** This section is effective the day following final enactment.

8.24 Sec. 7. Minnesota Statutes 2016, section 62D.06, subdivision 1, is amended to read:

8.25 Subdivision 1. **Governing body composition; enrollee advisory body.** The governing
 8.26 body of any health maintenance organization which is a ~~nonprofit~~ corporation may include
 8.27 enrollees, providers, or other individuals; provided, however, that after a health maintenance
 8.28 organization which is a ~~nonprofit~~ corporation has been authorized under sections 62D.01
 8.29 to 62D.30 for one year, at least 40 percent of the governing body shall be composed of
 8.30 enrollees and members elected by the enrollees and members from among the enrollees and
 8.31 members. For purposes of this section, "member" means a consumer who receives health

9.1 care services through a self-insured contract that is administered by the health maintenance

 9.21 commissioner of health shall implement and enforce this section by rules adopted under
 9.22 this section.

9.23 In an effort to achieve the stated purposes of sections 62D.01 to 62D.30; ~~in order to~~
 9.24 ~~safeguard the underlying nonprofit status of health maintenance organizations;~~ and to ensure
 9.25 that the payment of health maintenance organization money to major participating entities
 9.26 results in a corresponding benefit to the health maintenance organization and its enrollees,
 9.27 when determining whether an organization has incurred an unreasonable expense in relation

10.8 Sec. 10. **[62H.18] AGRICULTURAL COOPERATIVE HEALTH PLAN.**

10.9 Subdivision 1. **Definitions.** (a) The definitions in this subdivision apply to this section.

10.10 (b) "Agricultural cooperative" means a cooperative organized under chapter 308A or
 10.11 308B that meets the requirements of subdivision 2.

10.12 (c) "Broker" means an insurance agent engaged in brokerage business according to
 10.13 section 60K.49.

10.14 (d) "Employee Retirement Income Security Act" means the Employee Retirement Income
 10.15 Security Act of 1974, United States Code, title 29, sections 1001, et seq.

10.16 (e) "Enrollee" means a natural person covered by a joint self-insurance plan operating
 10.17 under this section.

10.18 (f) "Insurance agent" has the meaning given to insurance agent in section 60A.02,
 10.19 subdivision 7.

10.20 (g) "Joint self-insurance plan" or "plan" means a plan or any other arrangement established
 10.21 for the benefit of two or more entities authorized to transact business in the state, in order
 10.22 to jointly self-insure through a single employee welfare benefit plan funded through a trust,
 10.23 to provide health, dental, or other benefits as permitted under the Employee Retirement
 10.24 Income Security Act.

10.25 (h) "Service plan administrator" means a vendor of risk management services licensed
 10.26 under section 60A.23.

10.27 (i) "Trust" means a trust established to accept and hold assets of the joint self-insurance
 10.28 plan in trust and use and disperse funds in accordance with the terms of the written trust
 10.29 document and joint self-insurance plan for the sole purposes of providing benefits and
 10.30 defraying reasonable administrative costs of providing the benefits.

11.1 Subd. 2. **Exemption.** A joint self-insurance plan, its service plan administrator, stop loss
11.2 carrier, and any broker assisting the agricultural cooperative are exempt from sections
11.3 62H.01 to 62H.17, and are governed by the requirements of this section, if the joint
11.4 self-insurance plan is administrated through a trust established by an agricultural cooperative
11.5 that:

11.6 (1) has members who (i) actively work in production agriculture in Minnesota and file
11.7 either Form 1065 or Schedule F with the member's income tax return; or (ii) provide direct
11.8 services to production agriculture in Minnesota;

11.9 (2) specifies criteria for membership in the agricultural cooperative in their articles of
11.10 organization or bylaws, however criteria cannot be based on health status factors of the
11.11 individuals to be covered through the joint self-insurance plan; and

11.12 (3) grants at least 51 percent of the aggregate voting power on matters for which all
11.13 members may vote to members who satisfy clause (1) and any additional criteria in the
11.14 agricultural cooperative's articles of organization and bylaws.

11.15 Subd. 3. **Plan requirements.** A joint self-insurance plan operating under this section
11.16 must:

11.17 (1) offer health coverage to members of the agricultural cooperative that establishes the
11.18 plan and their dependents, to employees of members of the agricultural cooperative that
11.19 establishes the plan and their dependents, or to employees of the agricultural cooperative
11.20 that establishes the plan and their dependents. Health coverage may be offered only to those
11.21 individuals who meet certain criteria described in the joint self-insurance plan governing
11.22 documents, however the criteria cannot be based on health status factors of the individuals

62D.12 PROHIBITED PRACTICES.

Subd. 9. **Net earnings.** All net earnings of the health maintenance organization shall be devoted to the nonprofit purposes of the health maintenance organization in providing comprehensive health care. No health maintenance organization shall provide for the payment, whether directly or indirectly, of any part of its net earnings, to any person as a dividend or rebate; provided, however, that health maintenance organizations may make payments to providers or other persons based upon the efficient provision of services or as incentives to provide quality care. (1) Minnesota Statutes, section 62H.02, paragraph (b), does not apply;

If the plan fails to secure replacement coverage within 150 days after receipt of the notice of cancellation or nonrenewal, the commissioner shall issue an order providing for the orderly termination of the plan;

(7) the cooperative must establish a reserve fund, certified by an actuary to be sufficient to cover unpaid claim liability for incurred but not reported liabilities in the event of plan termination. Actuarial certification must include all maximum funding requirements for plan fixed cost requirements and current claims liability requirements and must include calculation for the reserve levels needed to fund all incurred but not reported liabilities in the event of member or plan termination. All such reserve funds will be held in protection of a cooperative trust, in accordance with the plan bylaws. An initial deposit shall be made to the trust fund in an amount equal to the annual estimated reserve amount for each of the members required for initial approval as provided by clause (5).
