OFFICIAL STATUS

1.1 A bill for an act
1.2 relating to capital investment; appropriating money for new law enforcement and
1.3 government facilities in Lake of the Woods County; authorizing the sale and
1.4 issuance of state bonds.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. **LAKE OF THE WOODS COUNTY; LAW ENFORCEMENT AND**
1.7 **GOVERNMENT FACILITIES.**

1.8 Subdivision 1. **Appropriation.** \$6,000,000 is appropriated from the bond proceeds fund
1.9 to the commissioner of public safety for one or more grants to Lake of the Woods County
1.10 to design, engineer, construct, furnish, and equip new law enforcement and government
1.11 facilities to improve public safety, accessibility, delivery of public services, and energy
1.12 efficiency. This appropriation includes money for expanded mental health and emergency
1.13 operations facilities; and accessibility, energy efficiency, safety, and security improvements
1.14 at the facilities. Improvements and betterments of a capital nature funded by this appropriation
1.15 are exempt from the requirements under Minnesota Statutes, section 16B.325.

1.16 Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond
1.17 proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.18 the state in an amount up to \$6,000,000 in the manner, upon the terms, and with the effect
1.19 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
1.20 Constitution, article XI, sections 4 to 7.

1.21 **EFFECTIVE DATE.** This section is effective the day following final enactment.
