1.9	Section 1. [256.952] PRESCRIPTION DRUG REIMPORTATION PROGRAM.
1.10	Subdivision 1. Establishment. The commissioner of human services shall develop a
1.11	program to make discounted prescription drugs reimported from Canada available to
1.12	Minnesotans. The commissioner shall implement the program by July 1, 2020.
1.13	Subd. 2. Price negotiation; contracts. (a) The commissioner shall negotiate prescription
1.14	drug prices with Canadian pharmacies licensed under section 151.19, subdivision 1, and
1.15	shall contract with the pharmacies to make these prices available to eligible entities. The
1.16	commissioner shall require pharmacies, as a condition of contract, to verify:
1.17	(1) the business location;
1.18	(2) licensure by a Canadian province;

Multistate agreements. The commissioner may enter into agreements with 3.20 other states to jointly negotiate prescription drug prices with Canadian pharmacies and 3.21 jointly administer a multistate prescription drug reimportation program. 3.22 Subd. 10. MinnesotaCare tax. Prescription drugs reimported under this section are 3.23 subject to any tax imposed under section 295.52. 3.24 Subd. 11. **Implementation plan.** The commissioner shall develop an implementation 3.25 plan for the prescription drug reimportation program, and shall present this plan and any 3.26 necessary draft legislation to the legislature by December 15, 2019.
