1.22 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.23 Section 1. Minnesota Statutes 2022, section 5B.06, is amended to read:

1.24 **5B.06 VOTING BY PROGRAM PARTICIPANT; ABSENTEE BALLOT.**

1.25 A program participant who is otherwise eligible to vote may register with the secretary

1.26 of state as a permanent absentee voter. Notwithstanding section 203B.04, subdivision 5,

1.27 the secretary of state is not required to send an absentee ballot application prior to each

1.28 election to a program participant registered as a permanent absentee voter under this section.

1.29 As soon as practicable before each election, the secretary of state shall determine the precinct

1.30 in which the residential address of ~~the~~ a program participant is located ~~and~~. Upon making

2.1 a precinct determination, the secretary of state shall either (1) request from and receive from
 2.2 the county auditor or other election official the ballot for that precinct and ~~shall forward~~
 2.3 mail the absentee ballot to the program participant ~~with the other,~~ or (2) using the Minnesota
 2.4 statewide voter registration system, prepare the program participant's ballot for that precinct
 2.5 and mail the absentee ballot to the program participant. The secretary of state shall include
 2.6 with each mailed absentee ballot all corresponding materials for absentee balloting as
 2.7 required by Minnesota law. The program participant shall complete the ballot and return it
 2.8 to the secretary of state, who shall review the ballot in the manner provided by section
 2.9 203B.121, subdivision 2. If the ballot and ballot materials comply with the requirements of
 2.10 that section, the ballot must be certified by the secretary of state as the ballot of a program
 2.11 participant, and must be forwarded to the appropriate electoral jurisdiction for tabulation
 2.12 along with all other ballots. The name and address of a program participant must not be
 2.13 listed in the statewide voter registration system.

2.14 Sec. 2. Minnesota Statutes 2022, section 201.061, subdivision 1, is amended to read:

2.15 Subdivision 1. **Prior to election day.** (a) At any time except during the 20 days
 2.16 immediately preceding any regularly scheduled election, an eligible voter or any individual
 2.17 who will be an eligible voter at the time of the next election may register to vote in the
 2.18 precinct in which the voter maintains residence by completing a voter registration application
 2.19 as described in section 201.071, subdivision 1. A completed application may be submitted:

2.20 (1) in person or by mail to the county auditor of that county or to the Secretary of State's
 2.21 Office; or

2.22 (2) electronically through a secure website that shall be maintained by the secretary of
 2.23 state for this purpose, if the applicant has an email address and provides the applicant's
 2.24 verifiable Minnesota driver's license number, Minnesota state identification card number,
 2.25 or the last four digits of the applicant's Social Security number.

2.26 (b) A registration that is received in person or by mail no later than 5:00 p.m. on the
 2.27 21st day preceding any election, or a registration received electronically through the secretary
 2.28 of state's secure website no later than 11:59 p.m. on the 21st day preceding any election,
 2.29 shall be accepted. An improperly addressed or delivered registration application shall be
 2.30 forwarded within two working days after receipt to the county auditor of the county where
 2.31 the voter maintains residence. A state or local agency or an individual that accepts completed
 2.32 voter registration applications from a voter must submit the completed applications to the
 2.33 secretary of state or the appropriate county auditor within ten calendar days after the
 2.34 applications are dated by the voter.

3.1 ~~(b)~~(c) An application submitted electronically under paragraph (a), clause (2), may only
3.2 be transmitted to the county auditor for processing if the secretary of state has verified the
3.3 application information matches the information in a government database associated with
3.4 the applicant's driver's license number, state identification card number, or Social Security
3.5 number. The secretary of state must review all unverifiable voter registration applications
3.6 submitted electronically for evidence of suspicious activity and must forward any such
3.7 application to an appropriate law enforcement agency for investigation.

3.8 (d) An individual may not electronically submit a voter registration application on behalf
3.9 of any other individual, except that the secretary of state may provide features on the secure
3.10 website established under paragraph (a), clause (2), that allow third parties to connect
3.11 application programming interfaces that facilitate an individual's submission of voter
3.12 registration information while interacting with the third party.

3.13 ~~(e)~~(e) For purposes of this section, mail registration is defined as a voter registration
3.14 application delivered to the secretary of state, county auditor, or municipal clerk by the
3.15 United States Postal Service or a commercial carrier.

3.16 Sec. 3. Minnesota Statutes 2022, section 201.061, subdivision 3, is amended to read:

3.17 Subd. 3. **Election day registration.** (a) An individual who is eligible to vote may register
3.18 on election day by appearing in person at the polling place for the precinct in which the
3.19 individual maintains residence, by completing a registration application, making an oath in
3.20 the form prescribed by the secretary of state and providing proof of residence. An individual
3.21 may prove residence for purposes of registering by:

3.22 (1) presenting a driver's license or Minnesota identification card issued pursuant to
3.23 section 171.07;

3.24 (2) presenting any document approved by the secretary of state as proper identification;

3.25 (3) presenting one of the following:

3.26 (i) a current valid student identification card from a postsecondary educational institution
3.27 in Minnesota, if a list of students from that institution has been prepared under section
3.28 135A.17 and certified to the county auditor in the manner provided in rules of the secretary
3.29 of state; or

3.30 (ii) a current student fee statement that contains the student's valid address in the precinct
3.31 together with a picture identification card; or

4.1 (4) having a voter who is registered to vote in the precinct, or an employee employed
4.2 by and working in a residential facility in the precinct and vouching for a resident in the
4.3 facility, sign an oath in the presence of the election judge vouching that the voter or employee
4.4 personally knows that the individual is a resident of the precinct. A voter who has been
4.5 vouched for on election day may not sign a proof of residence oath vouching for any other
4.6 individual on that election day. A voter who is registered to vote in the precinct may sign
4.7 up to eight proof-of-residence oaths on any election day. This limitation does not apply to
4.8 an employee of a residential facility described in this clause. The secretary of state shall
4.9 provide a form for election judges to use in recording the number of individuals for whom
4.10 a voter signs proof-of-residence oaths on election day. The form must include space for the
4.11 maximum number of individuals for whom a voter may sign proof-of-residence oaths. For
4.12 each proof-of-residence oath, the form must include a statement that the individual: (i) is
4.13 registered to vote in the precinct or is an employee of a residential facility in the precinct,
4.14 (ii) personally knows that the voter is a resident of the precinct, and (iii) is making the
4.15 statement on oath. The form must include a space for the voter's printed name, signature,
4.16 telephone number, and address.

4.17 The oath required by this subdivision and Minnesota Rules, part 8200.9939, must be
4.18 attached to the voter registration application.

4.19 (b) The operator of a residential facility shall prepare a list of the names of its employees
4.20 currently working in the residential facility and the address of the residential facility. The
4.21 operator shall certify the list and provide it to the appropriate county auditor no less than
4.22 20 days before each election for use in election day registration.

4.23 (c) "Residential facility" means transitional housing as defined in section 256E.33,
4.24 subdivision 1; a supervised living facility licensed by the commissioner of health under
4.25 section 144.50, subdivision 6; a nursing home as defined in section 144A.01, subdivision
4.26 5; ~~a residence registered with the commissioner of health as a housing with services~~
4.27 ~~establishment as defined in section 144D.01, subdivision 4~~ an assisted living facility licensed
4.28 by the commissioner of health under chapter 144G; a veterans home operated by the board
4.29 of directors of the Minnesota Veterans Homes under chapter 198; a residence licensed by
4.30 the commissioner of human services to provide a residential program as defined in section
4.31 245A.02, subdivision 14; a residential facility for persons with a developmental disability
4.32 licensed by the commissioner of human services under section 252.28; setting authorized
4.33 to provide housing support as defined in section 256I.03, subdivision 3; a shelter for battered
4.34 women as defined in section 611A.37, subdivision 4; ~~or~~ a supervised publicly or privately
4.35 operated shelter or dwelling designed to provide temporary living accommodations for the

5.1 homeless; a facility where a provider operates a residential treatment program as defined
5.2 in section 245.462, subdivision 23; or a facility where a provider operates an adult foster
5.3 care program as defined in section 245A.02, subdivision 6c.

5.4 (d) For tribal band members, an individual may prove residence for purposes of
5.5 registering by:

5.6 (1) presenting an identification card issued by the tribal government of a tribe recognized
5.7 by the Bureau of Indian Affairs, United States Department of the Interior, that contains the
5.8 name, address, signature, and picture of the individual; or

5.9 (2) presenting an identification card issued by the tribal government of a tribe recognized
5.10 by the Bureau of Indian Affairs, United States Department of the Interior, that contains the
5.11 name, signature, and picture of the individual and also presenting one of the documents
5.12 listed in Minnesota Rules, part 8200.5100, subpart 2, item B.

5.13 (e) A county, school district, or municipality may require that an election judge
5.14 responsible for election day registration initial each completed registration application.

5.15 Sec. 4. Minnesota Statutes 2022, section 201.071, subdivision 1, is amended to read:

5.16 Subdivision 1. **Form.** Both paper and electronic voter registration applications must
5.17 contain the same information unless otherwise provided by law. A voter registration
5.18 application must contain spaces for the following required information: voter's first name,
5.19 middle name, and last name; voter's previous name, if any; voter's current address; voter's
5.20 previous address, if any; voter's date of birth; voter's municipality and county of residence;
5.21 voter's telephone number, if provided by the voter; date of registration; current and valid
5.22 Minnesota driver's license number or Minnesota state identification number, or if the voter
5.23 has no current and valid Minnesota driver's license or Minnesota state identification, the
5.24 last four digits of the voter's Social Security number; and voter's signature. The paper
5.25 registration application may include the voter's email address, if provided by the voter. The
5.26 electronic voter registration application must include the voter's email address. The
5.27 registration application may include the voter's interest in serving as an election judge, if
5.28 indicated by the voter. The application must also contain the following certification of voter
5.29 eligibility:

5.30 "I certify that I:

5.31 (1) will be at least 18 years old on election day;

5.32 (2) am a citizen of the United States;

6.1 (3) will have ~~resided~~ maintained residence in Minnesota for 20 days immediately
6.2 preceding election day;

6.3 (4) maintain residence at the address given on the registration form;

6.4 (5) am not under court-ordered guardianship in which the court order revokes my right
6.5 to vote;

6.6 (6) have not been found by a court to be legally incompetent to vote;

6.7 (7) have the right to vote because, if I have been convicted of a felony, my felony sentence
6.8 has expired (been completed) or I have been discharged from my sentence; and

6.9 (8) have read and understand the following statement: that giving false information is a
6.10 felony punishable by not more than five years imprisonment or a fine of not more than
6.11 \$10,000, or both."

6.12 The certification must include boxes for the voter to respond to the following questions:

6.13 "(1) Are you a citizen of the United States?" and

6.14 "(2) Will you be 18 years old on or before election day?"

6.15 And the instruction:

6.16 "If you checked 'no' to either of these questions, do not complete this form."

6.17 The form of the voter registration application and the certification of voter eligibility
6.18 must be as provided in this subdivision and approved by the secretary of state. Voter
6.19 registration forms authorized by the National Voter Registration Act must also be accepted
6.20 as valid. The federal postcard application form must also be accepted as valid if it is not
6.21 deficient and the voter is eligible to register in Minnesota.

6.22 An individual may use a voter registration application to apply to register to vote in
6.23 Minnesota or to change information on an existing registration.

6.24 Sec. 5. Minnesota Statutes 2022, section 201.071, subdivision 8, is amended to read:

6.25 Subd. 8. **School district assistance.** School districts shall assist county auditors in
6.26 determining the school district in which a voter ~~resides~~ maintains residence.

6.27 Sec. 6. Minnesota Statutes 2022, section 201.091, subdivision 2, is amended to read:

6.28 Subd. 2. **Corrected list.** By February 15 of each year, the secretary of state shall prepare
6.29 the master list for each county auditor. The records in the statewide registration system must
6.30 be periodically corrected and updated by the county auditor. An updated master list for each

7.1 precinct must be available for absentee voting at least 46 days before each election. A final
7.2 corrected master list must be available ~~seven~~ 14 days before each election.

7.3 Sec. 7. Minnesota Statutes 2022, section 201.091, subdivision 4a, is amended to read:

7.4 Subd. 4a. **Presidential primary political party list.** The secretary of state must maintain
7.5 a list of the voters who voted in a presidential nomination primary and the political party
7.6 each voter selected. Information maintained on the list is private data on individuals as
7.7 defined under section 13.02, subdivision 12, except that the secretary of state must provide
7.8 ~~the list~~ to the chair of each major political party the list of voters who selected that party.

7.9 Sec. 8. Minnesota Statutes 2022, section 201.12, subdivision 2, is amended to read:

7.10 Subd. 2. **Moved within state.** If any nonforwardable mailing from an election official
7.11 is returned as undeliverable but with a permanent forwarding address in this state, the county
7.12 auditor may change the voter's status to "inactive" in the statewide registration system and
7.13 shall transmit a copy of the mailing to the auditor of the county in which the new address
7.14 is located. If an election is scheduled to occur in the precinct in which the voter ~~resides~~
7.15 maintains residence in the next 47 days, the county auditor shall promptly update the voter's
7.16 address in the statewide voter registration system. If there is not an election scheduled, the
7.17 auditor may wait to update the voter's address until after the next list of address changes is
7.18 received from the secretary of state. Once updated, the county auditor shall mail to the voter
7.19 a notice stating the voter's name, address, precinct, and polling place, except that if the
7.20 voter's record is challenged due to a felony conviction, noncitizenship, name change,
7.21 incompetence, or a court's revocation of voting rights of individuals under guardianship,
7.22 the auditor must not mail the notice. The notice must advise the voter that the voter's voting
7.23 address has been changed and that the voter must notify the county auditor within 21 days
7.24 if the new address is not the voter's address of residence. The notice must state that it must
7.25 be returned if it is not deliverable to the voter at the named address.

7.26 Sec. 9. Minnesota Statutes 2022, section 201.121, subdivision 1, is amended to read:

7.27 Subdivision 1. **Entry of registration information.** (a) At the time a voter registration
7.28 application is properly completed, submitted, and received in accordance with sections
7.29 201.061 and 201.071, the county auditor shall enter the information contained on it into the
7.30 statewide registration system. Voter registration applications completed before election day
7.31 must be entered into the statewide registration system within ten days after they have been
7.32 submitted to the county auditor. Voter registration applications completed on election day
7.33 must be entered into the statewide registration system within 42 days after the election,

8.1 unless the county auditor notifies the secretary of state before the deadline has expired that
8.2 the deadline will not be met. Upon receipt of a notification under this paragraph, the secretary
8.3 of state must extend the deadline for that county auditor by an additional 28 days. The
8.4 secretary of state may waive a county's obligations under this paragraph if, on good cause
8.5 shown, the county demonstrates its permanent inability to comply.

8.6 The secretary of state must post data on each county's compliance with this paragraph on
8.7 the secretary of state's website including, as applicable, the date each county fully complied
8.8 or the deadline by which a county's compliance must be complete.

8.9 (b) Upon receiving a completed voter registration application, the secretary of state may
8.10 electronically transmit the information on the application to the appropriate county auditor
8.11 as soon as possible for review by the county auditor before final entry into the statewide
8.12 registration system. The secretary of state may mail the voter registration application to the
8.13 county auditor.

8.14 (c) Within ten days after the county auditor has entered information from a voter
8.15 registration application into the statewide registration system, the secretary of state shall
8.16 compare the voter's name, date of birth, and driver's license number, state identification
8.17 number, or the last four digits of the Social Security number with the same information
8.18 contained in the Department of Public Safety database.

8.19 (d) The secretary of state shall provide a report to the county auditor on a weekly basis
8.20 that includes a list of voters whose name, date of birth, or identification number have been
8.21 compared with the same information in the Department of Public Safety database and cannot
8.22 be verified as provided in this subdivision. The report must list separately those voters who
8.23 have submitted a voter registration application by mail and have not voted in a federal
8.24 election in this state.

8.25 (e) The county auditor shall compile a list of voters for whom the county auditor and
8.26 the secretary of state are unable to conclude that information on the voter registration
8.27 application and the corresponding information in the Department of Public Safety database
8.28 relate to the same person.

8.29 (f) The county auditor shall send a notice of incomplete registration to any voter whose
8.30 name appears on the list and change the voter's status to "~~incomplete.~~" "challenged." A voter
8.31 who receives a notice of incomplete registration from the county auditor may either provide
8.32 the information required to ~~complete the registration~~ clear the challenge at least 21 days
8.33 before the next election or at the polling place on election day.

9.1 Sec. 10. Minnesota Statutes 2022, section 201.13, subdivision 3, is amended to read:

9.2 Subd. 3. **Use of change of address system.** (a) At least once each month the secretary
9.3 of state shall obtain a list of individuals registered to vote in this state who have filed with
9.4 the United States Postal Service a change of their permanent address. The secretary of state
9.5 may also periodically obtain a list of individuals with driver's licenses or state identification
9.6 cards to identify those who are registered to vote who have applied to the Department of
9.7 Public Safety for a replacement driver's license or state identification card with a different
9.8 address, and a list of individuals for whom the Department of Public Safety received
9.9 notification of a driver's license or state identification card cancellation due to a change of
9.10 residency out of state. However, the secretary of state shall not load data derived from these
9.11 lists into the statewide voter registration system within the 47 days before the state primary
9.12 or 47 days before a November general election.

9.13 (b) If the address is changed to another address in this state, the secretary of state shall
9.14 locate the precinct in which the voter ~~resides~~ maintains residence, if possible. If the secretary
9.15 of state is able to locate the precinct in which the voter ~~resides~~ maintains residence, the
9.16 secretary must transmit the information about the changed address by electronic means to
9.17 the county auditor of the county in which the new address is located. For addresses for
9.18 which the secretary of state is unable to determine the precinct, the secretary may forward
9.19 information to the appropriate county auditors for individual review. If the voter has not
9.20 voted or submitted a voter registration application since the address change, upon receipt
9.21 of the information, the county auditor shall update the voter's address in the statewide voter
9.22 registration system. The county auditor shall mail to the voter a notice stating the voter's
9.23 name, address, precinct, and polling place, unless the voter's record is challenged due to a
9.24 felony conviction, noncitizenship, name change, incompetence, or a court's revocation of
9.25 voting rights of individuals under guardianship, in which case the auditor must not mail the
9.26 notice. The notice must advise the voter that the voter's voting address has been changed
9.27 and that the voter must notify the county auditor within 21 days if the new address is not
9.28 the voter's address of residence. The notice must state that it must be returned if it is not
9.29 deliverable to the voter at the named address.

9.30 (c) If the change of permanent address is to an address outside this state, the secretary
9.31 of state shall notify by electronic means the auditor of the county where the voter formerly
9.32 ~~resided~~ maintained residence that the voter has moved to another state. If the voter has not
9.33 voted or submitted a voter registration application since the address change, the county
9.34 auditor shall promptly mail to the voter at the voter's new address a notice advising the voter
9.35 that the voter's status in the statewide voter registration system will be changed to "inactive"

10.1 unless the voter notifies the county auditor within 21 days that the voter is retaining the
 10.2 former address as the voter's address of residence, except that if the voter's record is
 10.3 challenged due to a felony conviction, noncitizenship, name change, incompetence, or a
 10.4 court's revocation of voting rights of individuals under guardianship, the auditor must not
 10.5 mail the notice. If the notice is not received by the deadline, the county auditor shall change
 10.6 the voter's status to "inactive" in the statewide voter registration system.

10.7 (d) If, in order to maintain voter registration records, the secretary of state enters an
 10.8 agreement to share information or data with an organization governed exclusively by a
 10.9 group of states, the secretary must first determine that the data security protocols are sufficient
 10.10 to safeguard the information or data shared. If required by such an agreement, the secretary
 10.11 of state may share the following data from the statewide voter registration system and data
 10.12 released to the secretary of state under section 171.12, subdivision 7a:

10.13 (1) name;

10.14 (2) date of birth;

10.15 (3) address;

10.16 (4) driver's license or state identification card number;

10.17 (5) the last four digits of an individual's Social Security number; and

10.18 (6) the date that an individual's record was last updated.

10.19 If the secretary of state enters into such an agreement, the secretary and county auditors
 10.20 must process changes to voter records based upon that data in accordance with this section.
 10.21 Except as otherwise provided in this subdivision, when data is shared with the secretary of
 10.22 state by another state, the secretary of state must maintain the same data classification that
 10.23 the data had while it was in the possession of the state providing the data.

10.24 Sec. 11. Minnesota Statutes 2022, section 201.145, subdivision 3, is amended to read:

10.25 Subd. 3. **Commissioner of corrections report; state court administrator report.** (a)
 10.26 ~~The state court administrator must report on individuals 17 years of age or older who have~~
 10.27 ~~been convicted of a felony.~~

10.28 ~~(b)~~ The commissioner of corrections must report on individuals ~~17~~ 16 years of age or
 10.29 older who are currently:

10.30 ~~(1) serving incarcerated for felony sentences under the commissioner's jurisdiction; or~~

11.1 ~~(2) on probation for felony offenses that resulted in the loss of civil rights, as indicated~~
 11.2 ~~by the statewide supervision system established under section 241.065.~~

11.3 ~~(e)~~ (b) Each report under this subdivision must include the following information for
 11.4 each individual: name, address or last known residential address that is not a correctional
 11.5 facility, and date of birth. If available, each report must also include the individual's:
 11.6 corrections' state identification number, last four digits of the Social Security number,
 11.7 driver's license or state identification card number, ~~date of sentence, effective date of the~~
 11.8 ~~sentence, county in which the conviction occurred, and date of discharge~~ and most recent
 11.9 date of incarceration.

11.10 ~~(d)~~ (c) No later than seven calendar days after receiving a report under this subdivision,
 11.11 the secretary of state must determine ~~if a person identified under paragraph (a) is registered~~
 11.12 ~~to vote and must prepare a list of those registrants for the county auditor. No later than seven~~
 11.13 ~~calendar days after receiving a report under this subdivision, the secretary of state must~~
 11.14 ~~determine~~ if any data newly indicates that a person identified under paragraph ~~(b)~~ (a) is
 11.15 registered to vote and must prepare a list of those registrants for the county auditor. No later
