5B.06 VOTING BY PROGRAM PARTICIPANT; ABSENTEE BALLOT.

- 1.25 A program participant who is otherwise eligible to vote may register with the secretary
- 1.26 of state as a permanent absentee voter. Notwithstanding section 203B.04, subdivision 5,
- 1.27 the secretary of state is not required to send an absentee ballot application prior to each
- 1.28 election to a program participant registered as a permanent absentee voter under this section.
- 1.29 As soon as practicable before each election, the secretary of state shall determine the precinct

The program participant shall complete the ballot and return it 2.7 to the secretary of state, who shall review the ballot in the manner provided by section 2.8 203B.121, subdivision 2. If the ballot and ballot materials comply with the requirements of 2.9 that section, the ballot must be certified by the secretary of state as the ballot of a program 2.10 participant, and must be forwarded to the appropriate electoral jurisdiction for tabulation 2.11 along with all other ballots. The name and address of a program participant must not be 2.12 listed in the statewide voter registration system. 2.13

2.14 Sec. 2. Minnesota Statutes 2022, section 201.061, subdivision 1, is amended to read:

Subdivision 1. Prior to election day. (a) At any time except during the 20 days
immediately preceding any regularly scheduled election, an eligible voter or any individual
who will be an eligible voter at the time of the next election may register to vote in the
precinct in which the voter maintains residence by completing a voter registration application
as described in section 201.071, subdivision 1. A completed application may be submitted:

2.20 (1) in person or by mail to the county auditor of that county or to the Secretary of State's2.21 Office; or

(2) electronically through a secure website that shall be maintained by the secretary of
state for this purpose, if the applicant has an email address and provides the applicant's
verifiable Minnesota driver's license number, Minnesota state identification card number,
or the last four digits of the applicant's Social Security number.

(b) A registration that is received in person or by mail no later than 5:00 p.m. on the 2.26 21st day preceding any election, or a registration received electronically through the secretary 2.27 of state's secure website no later than 11:59 p.m. on the 21st day preceding any election, 2.28 shall be accepted. An improperly addressed or delivered registration application shall be 2.29 forwarded within two working days after receipt to the county auditor of the county where 2.30 the voter maintains residence. A state or local agency or an individual that accepts completed 2.31 voter registration applications from a voter must submit the completed applications to the 2.32 secretary of state or the appropriate county auditor within ten calendar days after the 2.33 applications are dated by the voter. 2.34

3.1 (b)(c) An application submitted electronically under paragraph (a), clause (2), may only 3.2 be transmitted to the county auditor for processing if the secretary of state has verified the 3.3 application information matches the information in a government database associated with 3.4 the applicant's driver's license number, state identification card number, or Social Security 3.5 number. The secretary of state must review all unverifiable voter registration applications 3.6 submitted electronically for evidence of suspicious activity and must forward any such 3.7 application to an appropriate law enforcement agency for investigation.

3.8 (d) An individual may not electronically submit a voter registration application on behalf
 3.9 of any other individual, except that the secretary of state may provide features on the secure
 3.10 website established under paragraph (a), clause (2), that allow third parties to connect
 3.11 application programming interfaces that facilitate an individual's submission of voter
 3.12 registration information while interacting with the third party.

An individual 3.21 may prove residence for purposes of registering by:

3.22 (1) presenting a driver's license or Minnesota identification card issued pursuant to

3.24 (2) presenting any document approved by the secretary of state as proper identification;

3.25 (3) presenting one of the following:

(i) a current valid student identification card from a postsecondary educational institution

(4) having a voter who is registered to vote in the precinct, or an employee employed 4.1 by and working in a residential facility in the precinct and vouching for a resident in the 4.2 facility, sign an oath in the presence of the election judge vouching that the voter or employee 4.3 personally knows that the individual is a resident of the precinct. A voter who has been 4.4 vouched for on election day may not sign a proof of residence oath vouching for any other 4.5 individual on that election day. A voter who is registered to vote in the precinct may sign 4.6 up to eight proof-of-residence oaths on any election day. This limitation does not apply to 4.7 an employee of a residential facility described in this clause. The secretary of state shall 4.8 provide a form for election judges to use in recording the number of individuals for whom 4.9 a voter signs proof-of-residence oaths on election day. The form must include space for the 4.10 maximum number of individuals for whom a voter may sign proof-of-residence oaths. For 4.11 each proof-of-residence oath, the form must include a statement that the individual: (i) is 4.12 registered to vote in the precinct or is an employee of a residential facility in the precinct, 4.13 (ii) personally knows that the voter is a resident of the precinct, and (iii) is making the 4.14 statement on oath. The form must include a space for the voter's printed name, signature, 4.15 telephone number, and address. 4.16

4.17 The oath required by this subdivision and Minnesota Rules, part 8200.9939, must be4.18 attached to the voter registration application.

4.19 (b) The operator of a residential facility shall prepare a list of the names of its employees
4.20 currently working in the residential facility and the address of the residential facility. The
4.21 operator shall certify the list and provide it to the appropriate county auditor no less than
4.22 days before each election for use in election day registration.
