**OFFICIAL STATUS**

1.1 A bill for an act  
1.2 relating to education finance; linking extended time revenue to increases in the  
1.3 general education basic formula allowance; appropriating money; amending  
1.4 Minnesota Statutes 2024, section 126C.10, subdivision 2a.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2024, section 126C.10, subdivision 2a, is amended to read:

1.7 Subd. 2a. **Extended time revenue.** (a) A school district's extended time allowance equals  
1.8 \$5,117 for fiscal ~~year 2023 and later~~ years 2024 and 2025. A school district's extended time  
1.9 allowance for fiscal year 2026 and later equals the extended time formula allowance for the  
1.10 previous year times the greater of one or the ratio of the basic formula allowance under  
1.11 subdivision 2 for the current year to the basic formula allowance for the previous year.

1.12 (b) A school district's extended time revenue is equal to the product of the extended time  
1.13 allowance in paragraph (a) and the sum of the adjusted pupil units of the district for each  
1.14 pupil in average daily membership in excess of 1.0 and less than 1.2 according to section  
1.15 126C.05, subdivision 8.

1.16 (c) Extended time revenue for pupils placed in an on-site education program at the Prairie  
1.17 Lakes Education Center or the Lake Park School, located within the borders of Independent  
1.18 School District No. 347, Willmar, for instruction provided after the end of the preceding  
1.19 regular school year and before the beginning of the following regular school year equals  
1.20 membership hours divided by the minimum annual instructional hours in section 126C.05,  
1.21 subdivision 15, not to exceed 0.20, times the pupil unit weighting in section 126C.05,  
1.22 subdivision 1, times the extended time allowance in paragraph (a).

2.1 (d) A school district qualifies for extended time revenue for instruction provided after  
 2.2 the end of the preceding regular school year and before the beginning of the following  
 2.3 regular school year for (1) every pupil attending a day treatment program, and (2) every  
 2.4 pupil placed in a children's residential facility, whether the education services are provided  
 2.5 on-site or off-site. Extended time revenue under this paragraph equals total membership  
 2.6 hours in summer instruction divided by the minimum annual instructional hours in section  
 2.7 126C.05, subdivision 15, not to exceed 0.20, times the pupil unit weighting in section  
 2.8 126C.05, subdivision 1, times the extended time allowance.

2.9 (e) For purposes of this subdivision, "children's residential facility" means a residential  
 2.10 facility for children, including a psychiatric residential treatment facility, licensed by the  
 2.11 Department of Human Services or the Department of Corrections and subject to Minnesota  
 2.12 Rules, chapter 2960, or an inpatient hospitalization that includes mental health services.

2.13 (f) For purposes of this subdivision, "day treatment program" means:

2.14 (1) a site-based structured mental health program consisting of psychotherapy for three  
 2.15 or more individuals and individual or group skills training provided by a team, under the  
 2.16 treatment supervision of a mental health professional; or

2.17 (2) any other day treatment program designated by the commissioner of education  
 2.18 consistent with the Minnesota Automated Reporting Student System manual, procedure 27.

2.19 (g) A school district's extended time revenue may be used for extended day programs,  
 2.20 extended week programs, summer school, vacation break academies such as spring break  
 2.21 academies and summer term academies, and other programming authorized under the  
 2.22 learning year program.

2.23 **EFFECTIVE DATE.** This section is effective for revenue for fiscal year 2026 and later.

2.24 Sec. 2. **APPROPRIATION; GENERAL EDUCATION AID.**

2.25 Subdivision 1. Department of Education. The sums indicated in this section are  
 2.26 appropriated from the general fund to the Department of Education in the fiscal years  
 2.27 designated.

2.28 Subd. 2. General education aid. For general education aid under Minnesota Statutes,  
 2.29 section 126C.13, subdivision 4:
