1.10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.11 Section 1. Minnesota Statutes 2008, section 504B.285, subdivision 1, is amended to  
1.12 read:

1.13 Subdivision 1. **Grounds.** The person entitled to the premises may recover  
1.14 possession by eviction when:

1.15 (1) any person holds over real property:

1.16 (i) after a sale of the property on an execution or judgment; or

1.17 (ii) after the expiration of the time for redemption on foreclosure of a mortgage, or

1.18 after termination of contract to convey the property, provided that if the person holding the

1.19 real property after the expiration of the time for redemption or termination was a tenant

1.20 during the redemption or termination period, ~~the person entered into the~~ under a lease of

1.21 any duration and the lease began after the date of the notice of ~~the mortgage foreclosure or~~

1.22 contract for deed ~~cancellation and was executed but~~ prior to the expiration of the time for

1.23 redemption or termination, and the person has received:

1.24 (A) at least two months' written notice to vacate no sooner than one month after the

1.25 expiration of the time for redemption or termination, provided that the tenant pays the

7.1 (3) an affidavit by the person foreclosing the mortgage, or that person's attorney, or  
7.2 someone knowing the facts, setting forth the facts relating to the military service status of  
7.3 the owner of the mortgaged premises at the time of sale;

7.4 (4) an affidavit by the person foreclosing the mortgage, or that person's attorney,  
7.5 or someone having knowledge of the facts, setting forth the fact of service of notice of  
7.6 sale upon the secretary of the Treasury of the United States or the secretary's delegate in  
7.7 accordance with the provisions of Section 7425 of the Internal Revenue Code of 1954  
7.8 as amended by Section 109 of the Federal Tax Lien Act of 1966, and also setting forth  
7.9 the fact of service of notice of sale upon the commissioner of revenue of the state of  
7.10 Minnesota in accordance with the provisions of section 270C.63, subdivision 11. Any

7.16 (6) one or more affidavits by the person foreclosing the mortgage, or that person's  
7.17 attorney or a person having knowledge of the facts, stating:

7.18 (i) whether section 580.021, 580.04, 580.041, 580.042, 582.039, 582.041, or 582.042  
7.19 apply to the foreclosure proceedings; and

7.20 (ii) if any or all of those sections apply, that all notices required under those sections  
7.21 have been provided.

7.22 Such affidavits and returns shall be recorded by the county recorder and they and the  
7.23 records thereof, and certified copies of such records, shall be prima facie evidence of the  
7.24 facts therein contained.

7.25 The affidavit provided for in clause (3) hereof may be made and recorded for the  
7.26 purpose of complying with the provisions of the Servicemembers Civil Relief Act, and  
7.27 may be made and recorded at any time subsequent to the date of the mortgage foreclosure  
7.28 sale.

7.29 **EFFECTIVE DATE.** This section is effective for sales conducted on or after  
7.30 August 1, 2009.
