1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. FAMILY FOSTER CARE AND ADOPTION LEGISLATIVE TASK
1.6	FORCE.
1.7	Subdivision 1. Establishment; duties. The Family Foster Care and Adoption Legislative
1.8	Task Force is established to evaluate and make recommendations on improving foster care
1.9	licensing and adoption or kinship placement processes and ensuring that children with severe
1.10	disabilities have necessary specialized care in out-of-home placements. The task force must
1.11	evaluate and make recommendations on:
1.12	(1) establishing required timelines under which agencies must complete foster care
1.13	licensing steps, adoption studies, and medical disclosures to prospective foster and kinship
1.14	caregivers and adoptive parents;
1.15	(2) providing specialized case managers with relevant experience and expertise to
1.16	represent the interests of children in out-of-home placement who are medically fragile or
1.17	who have severe disabilities;
1.18	(3) ensuring that foster caregivers with whom a child with severe disabilities is placed
1.19	receive additional support and training on caring for children with severe disabilities; and
1.20	(4) providing additional channels through which prospective foster care licensees and
1.21	kinship or adoptive parents may express concerns or submit complaints about foster care
