1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. **[13D.013] PUBLIC COMMENT REQUIRED.**

1.13 (a) At an open meeting of a public body subject to this chapter, the body must allow a

1.14 public comment period to permit members of the public to directly address the body on any

1.15 agenda item before or during the body's consideration of that item. A public body is not

1.16 required to allow public comment during any closed meeting.

1.17 (b) A public body may adopt reasonable rules and regulations regarding public comments,

1.18 including but not limited to regulations limiting the total amount of time allocated for public

1.19 comments on a particular issue or for each individual speaker. A public body may limit the

1.20 scope of public comments to the specific agenda item currently before the body.

1.22 Subd. 2. **Conditions.** An entity listed in subdivision 1 may conduct a meeting governed

1.23 by this section and section 13D.01, subdivisions 1, 2, 4, and 5, by telephone or other

1.24 electronic means so long as the following conditions are met:

2.1 (1) all members of the entity participating in the meeting, wherever their physical location,
2.2 can hear one another and can hear all discussion and testimony;

2.3 (2) members of the public present at the regular meeting location of the entity can hear
2.4 all discussion and all votes of members of the entity and participate in testimony or public
2.5 comment periods;

2.6 (3) at least one member of the entity is physically present at the regular meeting location;
2.7 and

2.8 (4) all votes are conducted by roll call, so each member's vote on each issue can be
2.9 identified and recorded.

2.10 Sec. 3. Minnesota Statutes 2020, section 13D.015, subdivision 4, is amended to read:

2.11 Subd. 4. **Monitoring from remote site; costs.** If telephone or another electronic means
2.12 is used to conduct a meeting, the entity, to the extent practical, shall allow a person to
2.13 monitor the meeting electronically from a remote location as well as participate in testimony
2.14 or public comment periods. The entity may require the person making a connection to pay
2.15 for documented marginal costs that the entity incurs as a result of the additional connection.

2.16 Sec. 4. Minnesota Statutes 2020, section 13D.02, subdivision 1, is amended to read:

2.17 Subdivision 1. **Conditions.** (a) A meeting governed by section 13D.01, subdivisions 1,
2.18 2, 4, and 5, and this section may be conducted by interactive television so long as:

2.19 (1) all members of the body participating in the meeting, wherever their physical location,
2.20 can hear and see one another and can hear and see all discussion and testimony presented
2.21 at any location at which at least one member is present;

2.22 (2) members of the public present at the regular meeting location of the body can hear
2.23 and see all discussion and testimony and all votes of members of the body as well as
2.24 participate in testimony or public comment periods;

2.25 (3) at least one member of the body is physically present at the regular meeting location;

2.26 (4) all votes are conducted by roll call so each member's vote on each issue can be
2.27 identified and recorded; and

2.28 (5) each location at which a member of the body is present is open and accessible to the
2.29 public.

2.30 (b) A meeting satisfies the requirements of paragraph (a), although a member of the
2.31 public body participates from a location that is not open or accessible to the public, if the

3.1 member has not participated more than three times in a calendar year from a location that
3.2 is not open or accessible to the public, and:

3.3 (1) the member is serving in the military and is at a required drill, deployed, or on active
3.4 duty; or

3.5 (2) the member has been advised by a health care professional against being in a public
3.6 place for personal or family medical reasons. This clause only applies when a state of
3.7 emergency has been declared under section 12.31, and expires 60 days after the removal of
3.8 the state of emergency.

3.10 Subdivision 1. **Conditions.** A meeting governed by this section and section 13D.01,
3.11 subdivisions 1, 2, 4, and 5, may be conducted by telephone or other electronic means so
3.12 long as the following conditions are met:

3.13 (1) the presiding officer, chief legal counsel, or chief administrative officer for the
3.14 affected governing body determines that an in-person meeting or a meeting conducted under
3.15 section 13D.02 is not practical or prudent because of a health pandemic or an emergency
3.16 declared under chapter 12;

3.17 (2) all members of the body participating in the meeting, wherever their physical location,
3.18 can hear one another and can hear all discussion and testimony;

3.19 (3) members of the public present at the regular meeting location of the body can hear
3.20 all discussion and testimony and all votes of the members of the body as well as participate
3.21 in testimony or public comment periods, unless attendance at the regular meeting location
3.22 is not feasible due to the health pandemic or emergency declaration;

3.23 (4) at least one member of the body, chief legal counsel, or chief administrative officer
3.24 is physically present at the regular meeting location, unless unfeasible due to the health
3.25 pandemic or emergency declaration; and

3.26 (5) all votes are conducted by roll call, so each member's vote on each issue can be
3.27 identified and recorded.

3.28 Sec. 6. Minnesota Statutes 2020, section 13D.021, subdivision 3, is amended to read:

3.29 Subd. 3. **Monitoring from remote site; costs.** If telephone or another electronic means
3.30 is used to conduct a meeting, to the extent practical, the body shall allow a person to monitor
3.31 the meeting electronically from a remote location and to participate in testimony or public

4.1 comment periods. The body may require the person making a connection to pay for the
4.2 documented additional cost that the body incurs as a result of the additional connection.

4.3 Sec. 7. Minnesota Statutes 2020, section 35.0661, subdivision 1, is amended to read:

4.4 Subdivision 1. **Disastrous animal disease outbreaks; declaration of emergency.** (a)
4.5 If the board determines that a confirmed case of a disease in this state presents a substantial
4.6 and imminent threat to the state's domestic animal population, it shall certify the case to the
4.7 governor. After receiving certification from the board, the governor may declare an
4.8 emergency under this section for purposes of allowing the board to establish quarantine
4.9 zones of control to protect the health of domestic animals from animal diseases of potentially
4.10 disastrous proportions. The governor may declare an emergency under this section without
4.11 declaring a peacetime emergency under section 12.31. A declaration under this section may
4.12 specify that it applies to all or certain units of state or local government, must specify the
4.13 time period for which it applies, and must be filed with the secretary of state. This section
4.14 is in addition to and does not limit authority granted to the governor or local government
4.15 officials by chapter 12 or other law.

4.16 (b) The board may meet by electronic means without violating state open meeting laws
4.17 for the purpose of declaring that a confirmed case of a disease in this state presents a
4.18 substantial and imminent threat to the state's domestic animal population. If the board meets
4.19 by electronic means for this purpose, it shall comply with the emergency meeting notice
4.20 provisions of section 13D.04, subdivision 3, and, to the fullest extent possible, provide
4.21 public and media access to the meeting, including the ability to participate in testimony or
4.22 public comment periods.

9.2 one-half of the members shall be coterminous with the governor and the terms of the
