1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2022, section 120B.13, is amended to read:
1.7	120B.13 ADVANCED PLACEMENT, CAMBRIDGE ASSESSMENT
1.8	INTERNATIONAL EDUCATION, AND INTERNATIONAL BACCALAUREATE
1.9	PROGRAMS.
1.10	Subdivision 1. Program structure; training programs for teachers. Critical to schools'
1.11	educational success is ongoing advanced placement, Cambridge Assessment International
1.12	Education, and international baccalaureate-approved teacher training. A secondary teacher
1.13	assigned by a district to teach an advanced placement, Cambridge Assessment International
1.14	Education, or international baccalaureate course or other interested educator may participate
1.15	in a training program offered by The College Board, Cambridge Assessment International
1.16	Education, or International Baccalaureate North America, Inc. The state may pay a portion
1.17	of the tuition, room, board, and out-of-state travel costs a teacher or other interested educator
1.18	incurs in participating in a training program. The commissioner shall determine application
1.19	procedures and deadlines, select teachers and other interested educators to participate in the
1.20	training program, and determine the payment process and amount of the subsidy. The
1.21	procedures determined by the commissioner shall, to the extent possible, ensure that advanced
1.22	placement, Cambridge Assessment International Education, and international baccalaureate
1.23	courses become available in all parts of the state and that a variety of course offerings are

available in school districts. This subdivision does not prevent teacher or other interested
educator participation in training programs offered by The College Board, <u>Cambridge</u>
<u>Assessment International Education</u>, or International Baccalaureate North America, Inc.,
when tuition is paid by a source other than the state.

Subd. 2. Support programs. The commissioner shall provide support programs during
the school year for teachers who attended the training programs and teachers experienced
in teaching advanced placement, Cambridge Assessment International Education, or
international baccalaureate courses. The support programs shall provide teachers with
opportunities to share instructional ideas with other teachers. The state may pay the costs
of participating in the support programs, including substitute teachers, if necessary, and
program affiliation costs.

Subd. 3. Subsidy for examination fees. The state may pay all or part of the fee for 2.12 advanced placement, Cambridge Assessment International Education, or international 2.13 baccalaureate examinations. The commissioner shall pay all examination fees for all public 2.14 and nonpublic students of low-income families, as defined by the commissioner, and to the 2.15 limit of the available appropriation, shall also pay a portion or all of the examination fees 2.16 for other public and nonpublic students sitting for an advanced placement examination, 2.17 Cambridge Assessment International Education examination, or international baccalaureate 2.18 examination, or both. The commissioner shall determine procedures for state payments of 2.19 fees. 2.20

Subd. 3a. College credit. The colleges and universities of the Minnesota State Colleges
and Universities system must award, and the University of Minnesota and private
postsecondary institutions are encouraged to award, college credit to high school students
who receive a score of three or higher on an advanced placement, grades of E/e for AS and
<u>A level on Cambridge Assessment International Education exams</u>, or four or higher on the
international baccalaureate program examination.

Subd. 4. Rigorous course taking information; AP, IB, <u>Cambridge Assessment</u>
<u>International Education</u>, and PSEO. The commissioner shall submit the following
information on rigorous course taking, disaggregated by student subgroup, school district,
and postsecondary institution, to the education committees of the legislature each year by

Subd. 2. Application and review process; funding priority. (a) Charter schools and 4.21 school districts in which eligible schools under subdivision 1 are located may apply to the 4.22 commissioner, in the form and manner the commissioner determines, for competitive funding 4.23 to further raise students' academic achievement. The application must detail the specific 4.24 efforts the applicant intends to undertake in further raising students' academic achievement, 4.25 consistent with subdivision 1, and a proposed budget detailing the district or charter school's 4.26 current and proposed expenditures for advanced placement, preadvanced placement, 4.27 Cambridge Assessment International Education, and international baccalaureate courses 4.28 and programs. The proposed budget must demonstrate that the applicant's efforts will support 4.29 implementation of advanced placement, preadvanced placement, Cambridge Assessment 4.30 International Education, and international baccalaureate courses and programs. Expenditures 4.31 for administration must not exceed five percent of the proposed budget. Priority for advanced 4.32 placement grants must be given to grantees who add or expand offerings of advanced 4.33

- (b) Each school district and charter school that receives a grant under this section annually 7.1 must report to the commissioner, consistent with the Uniform Financial Accounting and 7.2 Reporting Standards, its actual expenditures for advanced placement, preadvanced placement, 7.3 Cambridge Assessment International Education, and international baccalaureate courses 7.4 and programs. The report must demonstrate that the school district or charter school has 7.5 maintained its effort from other sources for advanced placement, preadvanced placement, 7.6 Cambridge Assessment International Education, and international baccalaureate courses 7.7 and programs compared with the previous fiscal year, and the district or charter school has 7.8 expended all grant funds, consistent with its approved budget. 7.9

- 7.11 three years from the date of the grant if the district or charter school meets the annual
- 7.12 benchmarks in its plan under subdivision 1.
