1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. APPROPRIATIONS; TEACHER APPRENTICESHIPS.
1.6	(a) \$ in fiscal year 2026 and \$ in fiscal year 2027 are appropriated from the
1.7	workforce development fund to the commissioner of education for registered apprenticeships
1.8	for teachers. Of these amounts, \$ each year is for reimbursing school districts for the
1.9	costs of teacher apprenticeship programs. This is a onetime appropriation.
1.10	(b) A selected program must include the following five components required for a
1.11	registered apprenticeship:
1.12	(1) involvement by school districts to ensure apprentices develop the skills needed to
1.13	be effective teachers;
1.14	(2) structured on-the-job training from an experienced mentor;
1.15	(3) related instruction from a teacher training program approved by the Professional
1.16	Educator Licensing and Standards Board;
1.17	(4) increases in wages for participants as they gain higher skill levels; and
1.18	(5) a sequence of training and instruction resulting in a Tier 3 license issued by the
1.19	Professional Educator Licensing and Standards Board.
1.20	(c) School districts are eligible for funding under this section and are encouraged to
1.21	partner with institutions of higher education, other school districts, charter schools, and
