Sec. 4. STUDENT AND EMPLOYER CONNECTION INFORMATION SYSTEM.

The commissioner of the Office of Higher Education shall issue a request for proposal no later than July 1, 2016, for a Web-based job and intern-seeking software tool that matches the needs of employers located in Minnesota with the individual profiles of high school seniors and postsecondary students attending Minnesota high schools and postsecondary institutions. The commissioner shall no later than October 1, 2016, select a provider. The selected provider must have experience that demonstrates both prior similar software development ability and implementation outcomes of successful matching of job candidates and employers. The commissioner may contract for the development of the system.
