1.18	Federal Deposit Insurance Corporation.
1.19	Subd. 4. Immediate family member. "Immediate family member" means a spouse,
1.20	child, sibling, a parent, grandparent, or grandchild. This includes stepparents, stepchildren,
1.21	stepsiblings, and adoptive relationships.
1.22	Subd. 5. Individual. "Individual" means a natural person.

2.1	Subd. 6. Loan processor or underwriter. "Loan processor or underwriter" means
2.2	an individual who performs clerical or support duties as an employee at the direction
2.3	of and subject to the supervision and instruction of a person licensed or exempt from
2.4	licensing under chapter 58. For purposes of this subdivision, the term "clerical or support
2.5	duties" may include after the receipt of an application:
2.6	(1) the receipt, collection, distribution, and analysis of information common for the
2.7	processing or underwriting of a residential mortgage loan; and
2.8	(2) communicating with a consumer to obtain the information necessary for the
2.9	processing or underwriting of a loan, to the extent that the communication does not include
2.10	offering or negotiating loan rates or terms, or counseling consumers about residential
2.11	mortgage loan rates or terms.
2.12	Subd. 7. Mortgage loan originator. "Mortgage loan originator":
2.13	(1) means an individual who for compensation or gain or in the expectation of
2.14	compensation or gain:
2.15	(i) takes a residential mortgage loan application; or
2.16	(ii) offers or negotiates terms of a residential mortgage loan;
2.17	(2) does not include an individual engaged solely as a loan processor or underwriter
2.18	except as otherwise provided in section 58A.03, subdivision 3;
2.19	(3) does not include a person or entity that only performs real estate brokerage
2.20	activities and is licensed or registered according to Minnesota law, unless the person or
2.21	entity is compensated by a lender, a mortgage broker, or other mortgage loan originator or
2.22	by an agent of the lender, mortgage broker, or other mortgage loan originator; and
2.23	(4) does not include a person or entity solely involved in extensions of credit relating
2.24	to timeshare plans, as that term is defined in United States Code, title 11, section 101(53D).
2.25	Subd. 8. Nationwide Mortgage Licensing System and Registry. "Nationwide
2.26	Mortgage Licensing System and Registry" means a mortgage licensing system developed
2.27	and maintained by the Conference of State Bank Supervisors and the American
2.28	Association of Residential Mortgage Regulators for the licensing and registration of
2.29	licensed mortgage loan originators.
2.30	Subd. 9. Nontraditional mortgage product. "Nontraditional mortgage product"
2.31	means a mortgage product other than a 30-year fixed rate mortgage loan.
2.32	Subd. 10. Person. "Person" means a natural person, corporation, company, limited
2.33	liability company, partnership, or association.
2.34	Subd. 11. Real estate brokerage activity. "Real estate brokerage activity" means
2.35	an activity that involves offering or providing real estate brokerage services to the public,
2.36	including:

3.1	(1) acting as a real estate agent or real estate broker for a buyer, seller, lessor,
3.2	or lessee of real property;
3.3	(2) bringing together parties interested in the sale, purchase, lease, rental, or
3.4	exchange of real property;
3.5	(3) negotiating, on behalf of a party, a portion of a contract relating to the sale,
3.6	purchase, lease, rental, or exchange of real property other than in connection with
3.7	providing financing with respect to the transaction;
3.8	(4) engaging in an activity for which a person engaged in the activity is required to
3.9	be registered or licensed as a real estate agent or real estate broker under any applicable
3.10	law; and
3.11	(5) offering to engage in any activity, or act in any capacity, described in clause
3.12	(1), (2), (3), or (4).
3.13	Subd. 12. Registered mortgage loan originator. "Registered mortgage loan
3.14	originator" means an individual who:
3.15	(1) meets the definition of mortgage loan originator and is an employee of:
3.16	(i) a depository institution;
3.17	(ii) a subsidiary that is owned and controlled by a depository institution and
3.18	regulated by a federal banking agency; or
3.19	(iii) an institution regulated by the Farm Credit Administration; and
3.20	(2) is registered with, and maintains a unique identifier through, the Nationwide
3.21	Mortgage Licensing System and Registry.
3.22	Subd. 13. Residential mortgage loan. "Residential mortgage loan" means a loan
3.23	primarily for personal, family, or household use that is secured by a mortgage, deed of
3.24	trust, or other equivalent consensual security interest on a dwelling, as defined in United
3.25	States Code, title 15, section 1602(v), or residential real estate upon which a dwelling is
3.26	constructed or intended to be constructed.
3.27	Subd. 14. Residential real estate. "Residential real estate" means real property
3.28	located in Minnesota, upon which a dwelling is constructed or is intended to be
3.29	constructed.
3.30	Subd. 15. Unique identifier. "Unique identifier" means a number or other identifier
3.31	assigned by protocols established by the Nationwide Mortgage Licensing System and
3.32	Registry.
3.33	Sec. 3. [58A.03] LICENSE AND REGISTRATION REQUIRED.
3.34	Subdivision 1. Generally. An individual, unless specifically exempted from this
3.35	chapter under subdivision 2, shall not engage in the business of a mortgage loan originator

4.1	with respect to a dwelling located in this state without first obtaining and maintaining a
4.2	license under this chapter. An individual may not engage in the mortgage loan business
4.3	unless the individual is employed and supervised by an entity which is either licensed
4.4	or exempt from licensing under chapter 58. A licensed mortgage loan originator must
4.5	register with and maintain a valid unique identifier issued by the Nationwide Mortgage

4.19	Subd. 3. Independent contractor loan processors or underwriters. A loan
4.20	processor or underwriter who is an independent contractor may not engage in the activities
4.21	of a loan processor or underwriter unless the independent contractor loan processor
4.22	or underwriter obtains and maintains a license under subdivision 1. An independent
4.23	contractor loan processor or underwriter licensed as a mortgage loan originator must have
4.24	and maintain a valid unique identifier issued by the Nationwide Mortgage Licensing
4.25	System and Registry.
4.26	<b>EFFECTIVE DATE.</b> In order to facilitate an orderly transition to licensing and
4.27	minimize disruption in the mortgage marketplace, the effective date for subdivision 1
4.28	is July 31, 2010, or a later date approved by the Secretary of the U.S. Department of
4.29	Housing and Urban Development, under the authority granted in Public Law 110-289,
4.30	section 1508(a).
4.31	Sec. 4. [58A.04] STATE LICENSE AND REGISTRATION APPLICATION AND
4.32	ISSUANCE.
4.33	Subdivision 1. Application form. An applicant for a license shall apply in a form

4.34 <u>as prescribed by the commissioner. The form must contain content as set forth by rule,</u>

5.1	instruction, or procedure of the commissioner and may be changed or updated as necessary
5.2	by the commissioner in order to carry out the purposes of this chapter.

5.34	Subd. 6. Agent for purposes of requesting and distributing noncriminal
5.35	information. For the purposes of this section and in order to reduce the points of contact
5.36	which the commissioner may have to maintain for purposes of subdivision 4, clause $(2)(i)$

- 6.1 and (ii), the commissioner may use the Nationwide Mortgage Licensing System and
- 6.2 <u>Registry as a channeling agent for requesting and distributing information to and from any</u>

	1 for a state must be accepted as credit toward completion of prelicensing education

	Subd. 6. Relicensing education requirements. A person previously licensed under
	this chapter after the effective date of this chapter applying to be licensed again must
	prove that the person has completed all of the continuing education requirements for
	the year in which the license was last held.
