1.23 Section 1. REVISOR INSTRUCTION.

1.24 The revisor of statutes shall remove the terms "child care assistance program," "basic

1.25 sliding fee child care," and "MFIP child care," or similar terms wherever the terms appear

1.26 in Minnesota Statutes. The revisor shall also make technical and other necessary changes

1.27 to sentence structure to preserve the meaning of the text.
