BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. CITY OF BLACKDUCK; TAXES AUTHORIZED. 1.5 Subdivision 1. Sales and use tax authorization. Notwithstanding Minnesota Statutes, 1.6 section 477A.016, or any other law, ordinance, or city charter, and if approved by the voters 1.7 at a general election as required under Minnesota Statutes, section 297A.99, subdivision 3, 1.8 the city of Blackduck may impose, by ordinance, a sales and use tax of up to one-half of 1.9 one percent for the purposes specified in subdivision 2. Except as otherwise provided in 1.10 this section, the provisions of Minnesota Statutes, section 297A.99, govern the imposition, 1.11 administration, collection, and enforcement of the tax authorized under this subdivision. 1.12 The tax imposed under this subdivision is in addition to any local sales and use tax imposed 1.13 1.14 under any other special law. Subd. 2. Use of sales and use tax revenues. Bonding authority. (a) The city of Blackduck may issue bonds under Minnesota 2.4 Statutes, chapter 475, to finance all or a portion of the costs of the projects authorized in 2.5 subdivision 2 and approved by the voters as required under Minnesota Statutes, section 2.6 297A.99, subdivision 3, paragraph (a). The aggregate principal amount of bonds issued 2.7 under this subdivision may not exceed: 2.8 (1) \$200,000 for the project listed in subdivision 2, clause (1), plus an amount to be 2.9 applied to the payment of the costs of issuing the bonds; 2.10 (2) \$250,000 for the project listed in subdivision 2, clause (2), plus an amount to be 2.11 applied to the payment of the costs of issuing the bonds; 2.12 (3) \$300,000 for the project listed in subdivision 2, clause (3), plus an amount to be 2.13 applied to the payment of the costs of issuing the bonds; 2.14 (4) \$150,000 for the project listed in subdivision 2, clause (4), plus an amount to be 2.15 applied to the payment of the costs of issuing the bonds; and 2.16 (5) \$100,000 for the project listed in subdivision 2, clause (5), plus an amount to be 2.17 applied to the payment of the costs of issuing the bonds. 2.18 (b) The bonds may be paid from or secured by any funds available to the county, including 2.19 the tax authorized under subdivision 1.
