1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2014, section 15B.32, subdivision 6, is amended to read:
1.7	Subd. 6. Duties. (a) The commission:
1.8	(1) shall exercise ongoing coordination of the restoration, protection, risk
1.9	management, and preservation of the Capitol building;
1.10	(2) shall consult with and advise the commissioner of administration, the board, and
1.11	the Minnesota Historical Society regarding their applicable statutory responsibilities
1.12	for and in the Capitol building;
1.13	(3) may assist in the selection of an architectural firm to assist in the preparation of
1.14	the predesign plan for the restoration of the Capitol building;
1.15	(4) shall develop a comprehensive, multiyear, predesign plan for the restoration
1.16	of the Capitol building, review the plan periodically, and, as appropriate, amend and
1.17	modify the plan. The predesign plan shall identify appropriate and required functions of
1.18	the Capitol building; identify and address space requirements for legislative, executive,
1.19	and judicial branch functions; and identify and address the long-term maintenance
1.20	and preservation requirements of the Capitol building. In developing the predesign
1.21	plan, the commission shall take into account the comprehensive plan for the Minnesota
1.22	State Capitol Area, as amended in 2010, the rules governing zoning and design for the
1.23	Capitol Area, citizen access, information technology needs, energy efficiency, security,

- educational programs including public and school tours, and any additional space needs
  for the efficient operation of state government;
  (5) shall develop and implement a plan to reopen the Minnesota State Capitol and
  reintroduce it to the citizens of Minnesota;
- 2.5 (5) (6) shall develop and implement a comprehensive financial plan to fund the
   2.6 preservation and restoration of the Capitol building;
- (6) (7) shall provide annual reports about the condition of the Capitol building and 2.7 its needs, as well as all activities related to the restoration of the Capitol building; and 2.8 (7) (8) may solicit gifts, grants, or donations of any kind from any private or 2.9 public source to carry out the purposes of this section. For purposes of this section, the 2.10 commissioner of administration may expend money appropriated by the legislature for 2.11 these purposes in the same manner as private persons, firms, corporations, and associations 2.12 make expenditures for these purposes. All gifts, grants, or donations received by the 2.13 commission shall be deposited in a State Capitol preservation account established in 2.14 2.15 the special revenue fund. Money in the account is appropriated to the commissioner of administration for the activities of clause (5), the commission, and implementation of the 2.16 predesign plan under this section. The gift acceptance procedures under sections 16A.013 2.17 to 16A.016 do not apply to this clause. Appropriations under this clause do not cancel 2.18 and are available until expended. 2.19 (b) By January 15 of each year, the commission shall report to the chairs and ranking 2.20
- 2.21 minority members of the legislative committees with jurisdiction over the commission 2.22 regarding the activities and efforts of the commission in the preceding calendar year, 2.23 including recommendations adopted by the commission, the comprehensive financial plan 2.24 required under paragraph (a), clause (5) (6), and any proposed draft legislation necessary
- 2.25 to implement the recommendations of the commission.
