<u>Subd. 9a.</u> Database of catalytic converter sales. (a) For the purpose of assisting criminal
justice agencies in the investigation and prosecution of criminal activity, the commissioner
<u>must develop and maintain a database of information related to the sale of detached catalytic</u>
<u>converters to scrap metal dealers. The system consists of data required to be recorded</u>
<u>pursuant to subdivision 1b, paragraph (b). Data in the system must be submitted and</u>
<u>maintained as provided in this subdivision and must be accessible to law enforcement</u>
<u>agencies through a secure website.</u>

- (b) Every scrap metal dealer, including an agent, employee, or representative of the 3.17 dealer, must provide the information recorded pursuant to subdivision 1b, paragraph (b), to 3.18 the commissioner by transferring the information electronically pursuant to requirements 3.19 established by the commissioner. All required records must be transmitted completely and 3.20 accurately. Any transmission that does not meet the requirements established by the 3.21 commissioner must be corrected and resubmitted the next business day. 3.22 (c) Every scrap metal dealer must display a sign notifying patrons that all transactions 3.23 involving catalytic converters are reported to the commissioner and made available to law 3.24 3.25 enforcement. Signs must be at least 8-1/2 inches by 11 inches and be posted in a conspicuous place in the premises.
