1.8	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.9 1.10	Section 1. Minnesota Statutes 2021 Supplement, section 16A.152, subdivision 2, is amended to read:
1.11	Subd. 2. Additional revenues; priority. (a) If on the basis of a forecast of general fund
1.12	revenues and expenditures, the commissioner of management and budget determines that
1.13	there will be a positive unrestricted budgetary general fund balance at the close of the
1.14	biennium, the commissioner of management and budget must allocate money to the following
1.15	accounts and purposes in priority order:
1.16	(1) the cash flow account established in subdivision 1 until that account reaches
1.17	\$350,000,000;
1.18	(2) the budget reserve account established in subdivision 1a until that account reaches
1.19	\$2,377,399,000;
1.20	(3) the amount necessary to increase the aid payment schedule for school district aids
1.21	and credits payments in section 127A.45 to not more than 90 95 percent rounded to the
1.22	nearest tenth of a percent without exceeding the amount available and with any remaining
1.23	funds deposited in the budget reserve;

2.1 (4) the amount necessary to restore all or a portion of the net aid reductions under section
2.2 127A.441 and to reduce the property tax revenue recognition shift under section 123B.75,
2.3 subdivision 5, by the same amount;

(5) the amount necessary to increase the Minnesota 21st century fund by not more than
the difference between \$5,000,000 and the sum of the amounts credited and canceled to it
in the previous 12 months under Laws 2020, chapter 71, article 1, section 11, until the sum
of all transfers under this section and all amounts credited or canceled under Laws 2020,

chapter 71, article 1, section 11, equals \$20,000,000; and

(6) for a forecast in November only, the amount remaining after the transfer under clause 2.9 (5) must be used to reduce the percentage of accelerated June liability sales tax payments 2.10 required under section 289A.20, subdivision 4, paragraph (b), until the percentage equals 2.11 zero, rounded to the nearest tenth of a percent. By March 15 following the November 2.12 forecast, the commissioner must provide the commissioner of revenue with the percentage 2.13 of accelerated June liability owed based on the reduction required by this clause. By April 2.14 15 each year, the commissioner of revenue must certify the percentage of June liability 2.15 owed by vendors based on the reduction required by this clause. 2.16

(b) The amounts necessary to meet the requirements of this section are appropriated
from the general fund within two weeks after the forecast is released or, in the case of
transfers under paragraph (a), clauses (3) and (4), as necessary to meet the appropriations
schedules otherwise established in statute.

(c) The commissioner of management and budget shall certify the total dollar amount
of the reductions under paragraph (a), clauses (3) and (4), to the commissioner of education.
The commissioner of education shall increase the aid payment percentage and reduce the
property tax shift percentage by these amounts and apply those reductions to the current
fiscal year and thereafter.

subdivision 2, and payments to school districts by the commissioner of revenue pursuant
to chapter 298.

(c) "Payment date" means the date on which state payments to districts are made by the
electronic funds transfer method. If a payment date falls on a Saturday, a Sunday, or a
weekday which is a legal holiday, the payment shall be made on the immediately preceding
business day. The commissioner may make payments on dates other than those listed in
subdivision 3, but only for portions of payments from any preceding payment dates which
could not be processed by the electronic funds transfer method due to documented
extenuating circumstances.

3.17 Subd. 3. **Payment dates and percentages.** (a) The commissioner shall pay to a district 3.18 on the dates indicated an amount computed as follows: the cumulative amount guaranteed 3.19 minus the sum of (1) the district's other district receipts through the current payment, and 3.20 (2) the aid and credit payments through the immediately preceding payment. For purposes 3.21 of this computation, the payment dates and the cumulative disbursement percentages are 3.22 as follows:

5.6 Sec. 4. Minnesota Statutes 2020, section 127A.45, subdivision 6a, is amended to read:

Subd. 6a. Cash flow adjustment. The board of directors of any eligible special education 57 charter school under section 124E.21, subdivision 2, may request that the commissioner of 5.8 education accelerate the school's cash flow under this section. The commissioner must 5.9 approve a properly submitted request within 30 days of its receipt. The commissioner must 5.10 accelerate the school's regular special education aid payments according to the schedule in 5.11 the school's request and modify the payments to the school under subdivision 3 accordingly. 5.12 A school must not receive current payments of regular special education aid exceeding 90 5.13 95 percent of its estimated aid entitlement for the fiscal year. The commissioner must delay 5.14 the special education aid payments to all other school districts and charter schools in 5.15 proportion to each district or charter school's total share of regular special education aid 5.16 such that the overall aid payment savings from the aid payment shift remains unchanged 5.17 for any fiscal year. 5.18

5.21 Subd. 7b. Advance final payment. (a) Notwithstanding subdivisions 3 and 7, if the 5.22 current year aid payment percentage, under subdivision 2, is less than <u>90 95</u>, then a school 5.23 district or charter school exceeding its expenditure limitations under section 123B.83 as of 5.24 June 30 of the prior fiscal year may receive a portion of its final payment for the current 5.25 fiscal year on June 20, if requested by the district or charter school. The amount paid under 5.26 this subdivision must not exceed the lesser of:

5.27 (1) the difference between <u>90_95</u> percent and the current year payment percentage in
5.28 subdivision 2, paragraph (d), in the current fiscal year times the sum of the district or charter
5.29 school's general education aid plus the aid adjustment in section 127A.50 for the current

(2) the amount by which the district's or charter school's net negative unreserved general

(b) The state total advance final payment under this subdivision for any year must not
exceed \$7,500,000. If the amount request exceeds \$7,500,000, the advance final payment
for each eligible district must be reduced proportionately.

6.6 Subd. 13. Aid payment percentage. Except as provided in subdivisions 11, 12, 12a,

6.7 and 14, each fiscal year, all education aids and credits in this chapter and chapters 120A,

6.8 120B, 121A, 122A, 123A, 123B, 124D, 124E, 125A, 125B, 126C, 134, and section 273.1392,

6.9 shall be paid at the current year aid payment percentage of the estimated entitlement during

6.10 the fiscal year of the entitlement. For the purposes of this subdivision, a district's estimated

6.11 entitlement for special education aid under section 125A.76 for fiscal year 2014 and later

6.12 to fiscal year 2022 equals 97.4 percent of the district's entitlement for the current fiscal year.

6.13 For the purposes of this subdivision, a district's estimated entitlement for special education

6.14 aid under section 125A.76 for fiscal years 2023 and later equals 100 percent of the district's

6.15 entitlement for the current fiscal year. The final adjustment payment, according to subdivision

6.16 9, must be the amount of the actual entitlement, after adjustment for actual data, minus the

6.17 payments made during the fiscal year of the entitlement.

6.18 **EFFECTIVE DATE.** This section is effective July 1, 2022.
