Options; renew or restructure. Upon request from a receiver, the federal 2.16 home loan bank must provide the options available for an insurer-member subject to a 2.17 delinquency proceeding to renew or restructure a loan to defer associated prepayment fees, 2.18 subject to (1) market conditions, (2) the terms of any loans outstanding to the insurer-member, 2.19 (3) the federal home loan bank's applicable policies, and (4) the federal home loan bank's 2.20 compliance with federal laws and regulations. 2.21 Subd. 5. Void transfers prohibited.
