At a minimum, the written disclosure statement shall include a signature line, contact information for the department, and a statement that veterans benefits services are offered at no cost by federally chartered veterans service organizations and by county veterans service officers. Veterans benefits services disclosure requirements. Civil penalties 3.30 shall be assessed by the district court in an action initiated by the attorney general.
