BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 Section 1. Minnesota Statutes 2020, section 144.051, subdivision 6, is amended to read:

Subd. 6. **Release of private or confidential data.** For providers regulated pursuant to sections 144A.43 to 144A.482, 148.5185, and chapter 144G, the department may release private or confidential data, except Social Security numbers, to the appropriate state, federal, or local agency and law enforcement office to enhance investigative or enforcement efforts or further a public health protective process. Types of offices include Adult Protective Services, Office of the Ombudsman for Long-Term Care and Office of the Ombudsman for Mental Health and Developmental Disabilities, the health licensing boards, Department of Human Services, county or city attorney's offices, police, and local or county public health offices.

Sec. 2. [148.5185] AUDIOLOGY AND SPEECH-LANGUAGE PATHOLOGY INTERSTATE COMPACT.

Section 1. Definitions

1.20 As used in this Compact, and except as otherwise provided, the following definitions

2.15	means the national administrative body whose membership consists of all states that have
2.16	enacted the Compact.
2.17	G. "Audiology and speech-language pathology licensing board," "audiology licensing
2.18	board," "speech-language pathology licensing board," or "licensing board" means the agency
2.19	of a state that is responsible for the licensing and regulation of audiologists or
2.20	speech-language pathologists or both.
2.21	H. "Compact privilege" means the authorization granted by a remote state to allow a
2.22	licensee from another member state to practice as an audiologist or speech-language
2.23	pathologist in the remote state under its laws and rules. The practice of audiology or
2.24	speech-language pathology occurs in the member state where the patient, client, or student
2.25	is located at the time of the patient, client, or student encounter.
2.26	I. "Current significant investigative information" means investigative information that
2.27	a licensing board, after an inquiry or investigation that includes notification and an
2.28	opportunity for the audiologist or speech-language pathologist to respond, if required by
2.29	state law, has reason to believe is not groundless and, if proved true, would indicate more
2.30	than a minor infraction.
2.31	J. "Data system" means a repository of information about licensees, including, but not
2.32	limited to, continuing education, examination, licensure, investigation, compact privilege,
2.33	and adverse action.

<u>M. "H</u>	Home state" means the member state that is the licensee's primary state of residence.
N. "I	mpaired practitioner" means individuals whose professional practice is adversely
affected	by substance abuse, addiction, or other health-related conditions.
<u>O. "L</u>	cicensee" means an individual who currently holds an authorization from the state
licensing	g board to practice as an audiologist or speech-language pathologist.
<u>P. "M</u>	Iember state" means a state that has enacted the Compact.
Q. "P	rivilege to practice" means a legal authorization permitting the practice of audiology
or speecl	h-language pathology in a remote state.
<u>R.</u> "R	Remote state" means a member state other than the home state where a licensee is
exercisin	ng or seeking to exercise the compact privilege.
S. "R	ule" means a regulation, principle, or directive promulgated by the Commission

4.4	Section 2. State Participation in the Compact
4.5	A. A license issued to an audiologist or speech-language pathologist by a home state to
4.6	a resident in that state shall be recognized by each member state as authorizing an audiologist
4.7	or speech-language pathologist to practice audiology or speech-language pathology, under
4.8	a privilege to practice, in each member state.
4.9	B. A state must implement or utilize procedures for considering the criminal history
4.10	records of applicants for initial privilege to practice. These procedures shall include the
4.11	submission of fingerprints or other biometric-based information by applicants for the purpose
4.12	of obtaining an applicant's criminal history record information from the Federal Bureau of
4.13	Investigation and the agency responsible for retaining that state's criminal records.
4.14	1. A member state must fully implement a criminal background check requirement,

Section 6. Adverse Actions

- A. In addition to the other powers conferred by state law, a remote state shall have the authority, in accordance with existing state due process law, to:
- 1. Take adverse action against an audiologist's or speech-language pathologist's privilege to practice within that member state.
- 2. Issue subpoenas for both hearings and investigations that require the attendance and testimony of witnesses as well as the production of evidence. Subpoenas issued by a licensing board in a member state for the attendance and testimony of witnesses or the production of evidence from another member state shall be enforced in the latter state by any court of competent jurisdiction, according to the practice and procedure of that court applicable to subpoenas issued in proceedings pending before it. The issuing authority shall pay any witness fees, travel expenses, mileage and other fees required by the service statutes of the state in which the witnesses or evidence are located.
- B. Only the home state shall have the power to take adverse action against an audiologist's or speech-language pathologist's license issued by the home state.
- C. For purposes of taking adverse action, the home state shall give the same priority and effect to reported conduct received from a member state as it would if the conduct had occurred within the home state. In so doing, the home state shall apply its own state laws to determine appropriate action.
- D. The home state shall complete any pending investigations of an audiologist or speech-language pathologist who changes primary state of residence during the course of the investigations. The home state shall also have the authority to take appropriate action(s) and shall promptly report the conclusions of the investigations to the administrator of the data system. The administrator of the data system shall promptly notify the new home state of any adverse actions.
- E. If otherwise permitted by state law, the member state may recover from the affected audiologist or speech-language pathologist the costs of investigations and disposition of cases resulting from any adverse action taken against that audiologist or speech-language pathologist.
- F. The member state may take adverse action based on the factual findings of the remote state, provided that the home state follows its own procedures for taking the adverse action.

10.2	1. In addition to the authority granted to a member state by its respective audiology or
10.3	speech-language pathology practice act or other applicable state law, any member state may
10.4	participate with other member states in joint investigations of licensees.

- b. The employment, compensation, discipline, or other matters, practices, or procedures
 related to specific employees or other matters related to the Commission's internal personnel
 practices and procedures;
- c. Current, threatened, or reasonably anticipated litigation;

9. The Commission shall not incur obligations of any kind prior to securing the funds adequate to meet the same; nor shall the Commission pledge the credit of any of the member states, except by and with the authority of the member state.

10. The Commission shall keep accurate accounts of all receipts and disbursements. The receipts and disbursements of the Commission shall be subject to the audit and accounting procedures established under its bylaws. However, all receipts and disbursements of funds handled by the Commission shall be audited yearly by a certified or licensed public accountant, and the report of the audit shall be included in and become part of the annual report of the Commission.

F. Qualified Immunity, Defense, and Indemnification

- 1. The members, officers, executive director, employees and representatives of the Commission shall be immune from suit and liability, either personally or in their official capacity, for any claim for damage to or loss of property or personal injury or other civil liability caused by or arising out of any actual or alleged act, error, or omission that occurred, or that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of Commission employment, duties, or responsibilities; provided that nothing in this paragraph shall be construed to protect any person from suit or liability for any damage, loss, injury, or liability caused by the intentional or willful or wanton misconduct of that person.
- 2. The Commission shall defend any member, officer, executive director, employee, or representative of the Commission in any civil action seeking to impose liability arising out of any actual or alleged act, error, or omission that occurred within the scope of Commission employment, duties, or responsibilities, or that the person against whom the claim is made had a reasonable basis for believing occurred within the scope of Commission employment, duties, or responsibilities; provided that nothing herein shall be construed to prohibit that person from retaining his or her own counsel; and provided further, that the actual or alleged act, error, or omission did not result from that person's intentional or willful or wanton misconduct.
- 3. The Commission shall indemnify and hold harmless any member, officer, executive director, employee, or representative of the Commission for the amount of any settlement or judgment obtained against that person arising out of any actual or alleged act, error or omission that occurred within the scope of Commission employment, duties, or responsibilities, or that person had a reasonable basis for believing occurred within the scope of Commission employment, duties, or responsibilities, provided that the actual or alleged

16.3	Section 8. Data System
16.4	A. The Commission shall provide for the development, maintenance, and utilization of
16.5	a coordinated database and reporting system containing licensure, adverse action, and

16.7	B. Notwithstanding any other provision of state law to the contrary, a member state shall
16.8	submit a uniform data set to the data system on all individuals to whom this Compact is

The revision may be challenged only on grounds that the revision results in a material change to a rule. A challenge shall be made in writing and delivered to the chair of the Commission prior to the end of the notice period. If no challenge is made, the revision shall take effect without further action. If the revision is challenged, the revision may not take effect without the approval of the Commission. Section 10. Oversight, Dispute Resolution, and Enforcement A. Dispute Resolution 1. Upon request by a member state, the Commission shall attempt to resolve disputes related to the Compact that arise among member states and between member and non-member states. 2. The Commission shall promulgate a rule providing for both mediation and binding dispute resolution for such disputes as appropriate. B. Enforcement 1. The Commission, in the reasonable exercise of its discretion, shall enforce the provisions and rules of this Compact. 2. By majority vote, the Commission may initiate legal action in the United States District Court for the District of Columbia or the federal district where the Commission has its principal offices against a member state in default to enforce compliance with the provisions of the Compact and its promulgated rules and bylaws. The relief sought may include both injunctive relief and damages. In the event judicial enforcement is necessary, the prevailing member shall be awarded all costs of litigation, including reasonable attorney's fees. 3. The remedies herein shall not be the exclusive remedies of the Commission. The Commission may pursue any other remedies available under federal or state law. Section 11. Date of Implementation of the Interstate Commission for Audiology and Speech-Language Pathology Practice and Associated Rules, Withdrawal, and Amendment A. The Compact shall come into effect on the date on which the Compact statute is enacted into law in the tenth member state. The provisions, which become effective at that time, shall be limited to the powers granted to the Commission relating to assembly and the promulgation of rules. Thereafter, the Commission shall meet and exercise rulemaking powers necessary to the implementation and administration of the Compact.
