OFFICIAL STATUS

1.1 A bill for an act
1.2 relating to capital investment; appropriating money for campus improvements at
1.3 Minnesota West Community and Technical College; authorizing the sale and
1.4 issuance of state bonds.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. **MINNESOTA WEST COMMUNITY AND TECHNICAL COLLEGE.**

1.7 Subdivision 1. **Appropriation.** \$9,672,000 is appropriated from the bond proceeds fund
1.8 to the Board of Trustees of the Minnesota State Colleges and Universities to design, renovate,
1.9 and equip nursing spaces at the Granite Falls and Worthington campuses; and to design,
1.10 renovate, and equip student services space at the Granite Falls campus of Minnesota West
1.11 Community and Technical College.

1.12 Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond
1.13 proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.14 the state in an amount up to \$9,672,000 in the manner, upon the terms, and with the effect
1.15 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
1.16 Constitution, article XI, sections 4 to 7.

1.17 **EFFECTIVE DATE.** This section is effective the day following final enactment.
