2.24 **ARTICLE 1**

2.25 **MISCELLANEOUS**

2.26 Section 1. Minnesota Statutes 2020, section 12.27, subdivision 3, is amended to read:

2.27 Subd. 3. **Local delegation of authority.** (a) ~~No later than 90 days after August 1, 1996,~~
 2.28 The governing body of a political subdivision shall designate a city administrator or manager,
 2.29 public safety director, police chief, fire chief, public works director, or other officer who,
 2.30 exercising discretion and considering the needs of the political subdivision and its inhabitants,
 2.31 may dispatch equipment and personnel as considered necessary if a danger of fire, hazard,
 2.32 casualty, or another similar occurrence exists outside the political subdivision and by its
 2.33 suddenness it would be impractical for the governing body itself to authorize the dispatch
 2.34 of equipment and personnel to combat that emergency or disaster.

2.35 (b) Action under this subdivision is an act of the political subdivision. All provisions
 2.36 for compensation of personnel, rental of equipment, liability insurance coverage, workers'
 2.37 compensation insurance, and other matters pertaining to the political subdivision, its
 2.38 equipment, and personnel, apply in each case as if specifically authorized and directed.

2.39 (c) The officer shall end the use of equipment and personnel when the need no longer
 2.40 exists or earlier at the officer's discretion if it appears to be in the best interest of the political
 2.41 subdivision.

3.1 Sec. 2. Minnesota Statutes 2020, section 12.381, subdivision 1, is amended to read:

3.2 Subdivision 1. **Powers for safe disposition.** Notwithstanding chapter 149A and
3.3 ~~Minnesota Rules, chapter 4610~~, in connection with deaths related to a declared emergency,
3.4 the governor may:

3.5 (1) direct measures to provide for the safe disposition of dead human bodies as may be
3.6 reasonable and necessary for emergency response. Measures may include, but are not limited
3.7 to, transportation, preparation, temporary mass burial and other interment, disinterment,
3.8 and cremation of dead human bodies. Insofar as the emergency circumstances allow, the
3.9 governor shall respect the religious rites, cultural customs, family wishes, and predeath
3.10 directives of a decedent concerning final disposition. The governor may limit visitations or
3.11 funeral ceremonies based on public health risks;

3.12 (2) consult with coroners and medical examiners, take possession or control of any dead
3.13 human body, and order an autopsy of the body; and

3.14 (3) request any business or facility authorized to embalm, bury, cremate, inter, disinter,
3.15 transport, or otherwise provide for disposition of a dead human body under the laws of this
3.16 state to accept any dead human body or provide the use of its business or facility if the
3.17 actions are reasonable and necessary for emergency management purposes and are within
3.18 the safety precaution capabilities of the business or facility.

3.19 Sec. 3. Minnesota Statutes 2020, section 12.61, subdivision 1, is amended to read:

3.20 Subdivision 1. **Definitions.** For purposes of this section:

3.21 (a) "Emergency plan" includes:

3.22 (i) any plan for managing an emergency threatening public health developed by the
3.23 commissioner of health or a local public health agency;

3.24 (ii) any plan for managing an emergency threatening public health developed by one or
3.25 more hospitals, clinics, nursing homes, or other health care facilities or providers and
3.26 approved by the commissioner of health or local public health agency in consultation with
3.27 emergency management officials; or

3.28 (iii) any provision for assistance by out-of-state responders under interstate or
3.29 international compacts, including but not limited to the Emergency Management Assistance
3.30 Compact.

3.31 (b) "Regional hospital system" means all hospitals in one of the hospital bioterrorism
3.32 preparedness program geographic regions of the state set forth in the most recent hospital

4.1 preparedness plan available on the Department of Health website at
4.2 ~~www.health.state.mn.us/oep.~~

4.3 (c) "Responder" means any person or organization whether paid or volunteer that provides
4.4 health care or other health-related services in an emergency including, but not limited to,
4.5 physicians, physician assistants, registered and other nurses, certified nursing assistants, or
4.6 other staff within a health care provider organization, pharmacists, chiropractors, dentists,
4.7 emergency medical technicians, members of a specialized medical response unit, laboratory
4.8 technicians, morticians, registered first responders, mental health professionals, hospitals,
4.9 nursing and boarding care facilities, home health care agencies, other long-term care
4.10 providers, medical and dental clinics, medical laboratories, and ambulance service personnel,
4.11 dispatch services, and persons not registered as first responders but affiliated with a medical
4.12 response unit and dispatched to the scene of an emergency by a public safety answering
4.13 point or licensed ambulance service.

4.14 Sec. 4. Minnesota Statutes 2020, section 12A.07, subdivision 2, is amended to read:

4.15 Subd. 2. **Assistance.** Criteria and requirements must be locally established with the
4.16 approval of the commissioner. Local plans must specify the type of assistance to be provided
4.17 to eligible organizations. Within the limits of the available grant amounts, assistance may
4.18 be provided as loans with or without interest and as forgivable loans. The criteria must, at
4.19 a minimum, specify that an organization receiving a forgivable loan must remain in the
4.20 local community a minimum of five years after the date of the loan, after which the amount
4.21 of loan forgiveness must follow a schedule provided by the commissioner for an additional
4.22 five years. Loans made under this section must not be used to refinance debt that existed
4.23 on the date of the disaster. Repayment of loan amounts is made to the local community
4.24 consistent with subdivision 6. All assistance awards under this section must meet the
4.25 requirements of section 116J.8731, subdivision ~~8~~ 9.

4.26 Sec. 5. Minnesota Statutes 2020, section 13.3805, subdivision 3, is amended to read:

4.27 Subd. 3. **Office of Health Facility Complaints; investigative data.** Except for
4.28 investigative data under chapter 260E, all investigative data maintained by the Department
4.29 of Health's Office of Health Facility Complaints are subject to provisions of and classified
4.30 pursuant to section 626.557, subdivision 12b, paragraphs (b) to (d). Notwithstanding sections
4.31 260E.21, subdivision ~~4~~ 1; 260E.35; and 626.557, subdivision 12b, paragraph (b), data
4.32 identifying an individual substantiated as the perpetrator are public data. For purposes of
4.33 this subdivision, an individual is substantiated as the perpetrator if the commissioner of

5.1 health determines that the individual is the perpetrator and the determination of the
5.2 commissioner is upheld after the individual either exercises applicable administrative appeal
5.3 rights or fails to exercise these rights within the time allowed by law.

5.5 Subd. 2. **General.** (a) Data on individuals collected, maintained, used, or disseminated
5.6 by the welfare system are private data on individuals, and shall not be disclosed except:

5.7 (1) according to section 13.05;

5.8 (2) according to court order;

5.9 (3) according to a statute specifically authorizing access to the private data;

5.10 (4) to an agent of the welfare system and an investigator acting on behalf of a county,
5.11 the state, or the federal government, including a law enforcement person or attorney in the
5.12 investigation or prosecution of a criminal, civil, or administrative proceeding relating to the
5.13 administration of a program;

5.14 (5) to personnel of the welfare system who require the data to verify an individual's
5.15 identity; determine eligibility, amount of assistance, and the need to provide services to an
5.16 individual or family across programs; coordinate services for an individual or family;
5.17 evaluate the effectiveness of programs; assess parental contribution amounts; and investigate
5.18 suspected fraud;

5.19 (6) to administer federal funds or programs;

5.20 (7) between personnel of the welfare system working in the same program;

5.21 (8) to the Department of Revenue to assess parental contribution amounts for purposes
5.22 of section 252.27, subdivision 2a, administer and evaluate tax refund or tax credit programs
5.23 and to identify individuals who may benefit from these programs. The following information
5.24 may be disclosed under this paragraph: an individual's and their dependent's names, dates
5.25 of birth, Social Security numbers, income, addresses, and other data as required, upon
5.26 request by the Department of Revenue. Disclosures by the commissioner of revenue to the
5.27 commissioner of human services for the purposes described in this clause are governed by
5.28 section 270B.14, subdivision 1. Tax refund or tax credit programs include, but are not limited
5.29 to, the dependent care credit under section 290.067, the Minnesota working family credit
5.30 under section 290.0671, the property tax refund and rental credit under section 290A.04,
5.31 and the Minnesota education credit under section 290.0674;

6.1 (9) between the Department of Human Services, the Department of Employment and
6.2 Economic Development, and when applicable, the Department of Education, for the following
6.3 purposes:

6.4 (i) to monitor the eligibility of the data subject for unemployment benefits, for any
6.5 employment or training program administered, supervised, or certified by that agency;

6.6 (ii) to administer any rehabilitation program or child care assistance program, whether
6.7 alone or in conjunction with the welfare system;

6.8 (iii) to monitor and evaluate the Minnesota family investment program or the child care
6.9 assistance program by exchanging data on recipients and former recipients of Supplemental
6.10 Nutrition Assistance Program (SNAP) benefits, cash assistance under chapter 256, 256D,
6.11 256J, or 256K, child care assistance under chapter 119B, medical programs under chapter
6.12 256B or 256L, or a medical program formerly codified under chapter 256D; and

6.13 (iv) to analyze public assistance employment services and program utilization, cost,
6.14 effectiveness, and outcomes as implemented under the authority established in Title II,
6.15 Sections 201-204 of the Ticket to Work and Work Incentives Improvement Act of 1999.
6.16 Health records governed by sections 144.291 to 144.298 and "protected health information"
6.17 as defined in Code of Federal Regulations, title 45, section 160.103, and governed by Code
6.18 of Federal Regulations, title 45, parts 160-164, including health care claims utilization
6.19 information, must not be exchanged under this clause;

6.20 (10) to appropriate parties in connection with an emergency if knowledge of the
6.21 information is necessary to protect the health or safety of the individual or other individuals
6.22 or persons;

6.23 (11) data maintained by residential programs as defined in section 245A.02 may be
6.24 disclosed to the protection and advocacy system established in this state according to Part
6.25 C of Public Law 98-527 to protect the legal and human rights of persons with developmental
6.26 disabilities or other related conditions who live in residential facilities for these persons if
6.27 the protection and advocacy system receives a complaint by or on behalf of that person and
6.28 the person does not have a legal guardian or the state or a designee of the state is the legal
6.29 guardian of the person;

6.30 (12) to the county medical examiner or the county coroner for identifying or locating
6.31 relatives or friends of a deceased person;

7.1 (13) data on a child support obligor who makes payments to the public agency may be
7.2 disclosed to the Minnesota Office of Higher Education to the extent necessary to determine
7.3 eligibility under section 136A.121, subdivision 2, clause (5);

7.4 (14) participant Social Security numbers and names collected by the telephone assistance
7.5 program may be disclosed to the Department of Revenue to conduct an electronic data
7.6 match with the property tax refund database to determine eligibility under section 237.70,
7.7 subdivision 4a;

7.8 (15) the current address of a Minnesota family investment program participant may be
7.9 disclosed to law enforcement officers who provide the name of the participant and notify
7.10 the agency that:

7.11 (i) the participant:

7.12 (A) is a fugitive felon fleeing to avoid prosecution, or custody or confinement after
7.13 conviction, for a crime or attempt to commit a crime that is a felony under the laws of the
7.14 jurisdiction from which the individual is fleeing; or

7.15 (B) is violating a condition of probation or parole imposed under state or federal law;

7.16 (ii) the location or apprehension of the felon is within the law enforcement officer's
7.17 official duties; and

7.18 (iii) the request is made in writing and in the proper exercise of those duties;

7.19 (16) the current address of a recipient of general assistance may be disclosed to probation
7.20 officers and corrections agents who are supervising the recipient and to law enforcement
7.21 officers who are investigating the recipient in connection with a felony level offense;

7.22 (17) information obtained from a SNAP applicant or recipient households may be
7.23 disclosed to local, state, or federal law enforcement officials, upon their written request, for
7.24 the purpose of investigating an alleged violation of the Food and Nutrition Act, according
7.25 to Code of Federal Regulations, title 7, section 272.1(c);

7.26 (18) the address, Social Security number, and, if available, photograph of any member
7.27 of a household receiving SNAP benefits shall be made available, on request, to a local, state,
7.28 or federal law enforcement officer if the officer furnishes the agency with the name of the
7.29 member and notifies the agency that:

7.30 (i) the member:

7.31 (A) is fleeing to avoid prosecution, or custody or confinement after conviction, for a
7.32 crime or attempt to commit a crime that is a felony in the jurisdiction the member is fleeing;

8.1 (B) is violating a condition of probation or parole imposed under state or federal law;
8.2 or

8.3 (C) has information that is necessary for the officer to conduct an official duty related
8.4 to conduct described in subitem (A) or (B);

8.5 (ii) locating or apprehending the member is within the officer's official duties; and

8.6 (iii) the request is made in writing and in the proper exercise of the officer's official duty;

8.7 (19) the current address of a recipient of Minnesota family investment program, general
8.8 assistance, or SNAP benefits may be disclosed to law enforcement officers who, in writing,
8.9 provide the name of the recipient and notify the agency that the recipient is a person required
8.10 to register under section 243.166, but is not residing at the address at which the recipient is
8.11 registered under section 243.166;

8.12 (20) certain information regarding child support obligors who are in arrears may be
8.13 made public according to section 518A.74;

8.14 (21) data on child support payments made by a child support obligor and data on the
8.15 distribution of those payments excluding identifying information on obligees may be
8.16 disclosed to all obligees to whom the obligor owes support, and data on the enforcement
8.17 actions undertaken by the public authority, the status of those actions, and data on the income
8.18 of the obligor or obligee may be disclosed to the other party;

8.19 (22) data in the work reporting system may be disclosed under section 256.998,
8.20 subdivision 7;

8.21 (23) to the Department of Education for the purpose of matching Department of Education
8.22 student data with public assistance data to determine students eligible for free and
8.23 reduced-price meals, meal supplements, and free milk according to United States Code,
8.24 title 42, sections 1758, 1761, 1766, 1766a, 1772, and 1773; to allocate federal and state
8.25 funds that are distributed based on income of the student's family; and to verify receipt of
8.26 energy assistance for the telephone assistance plan;

8.27 (24) the current address and telephone number of program recipients and emergency
8.28 contacts may be released to the commissioner of health or a community health board as
8.29 defined in section 145A.02, subdivision 5, when the commissioner or community health
8.30 board has reason to believe that a program recipient is a disease case, carrier, suspect case,
8.31 or at risk of illness, and the data are necessary to locate the person;

8.32 (25) to other state agencies, statewide systems, and political subdivisions of this state,
8.33 including the attorney general, and agencies of other states, interstate information networks,

9.1 federal agencies, and other entities as required by federal regulation or law for the
9.2 administration of the child support enforcement program;

9.3 (26) to personnel of public assistance programs as defined in section 256.741, for access
9.4 to the child support system database for the purpose of administration, including monitoring
9.5 and evaluation of those public assistance programs;

9.6 (27) to monitor and evaluate the Minnesota family investment program by exchanging
9.7 data between the Departments of Human Services and Education, on recipients and former
9.8 recipients of SNAP benefits, cash assistance under chapter 256, 256D, 256J, or 256K, child
9.9 care assistance under chapter 119B, medical programs under chapter 256B or 256L, or a
9.10 medical program formerly codified under chapter 256D;

9.11 (28) to evaluate child support program performance and to identify and prevent fraud
9.12 in the child support program by exchanging data between the Department of Human Services,
9.13 Department of Revenue under section 270B.14, subdivision 1, paragraphs (a) and (b),
9.14 without regard to the limitation of use in paragraph (c), Department of Health, Department
9.15 of Employment and Economic Development, and other state agencies as is reasonably
9.16 necessary to perform these functions;

9.17 (29) counties and the Department of Human Services operating child care assistance
9.18 programs under chapter 119B may disseminate data on program participants, applicants,
9.19 and providers to the commissioner of education;

9.20 (30) child support data on the child, the parents, and relatives of the child may be
9.21 disclosed to agencies administering programs under titles IV-B and IV-E of the Social
9.22 Security Act, as authorized by federal law;

9.23 (31) to a health care provider governed by sections 144.291 to 144.298, to the extent
9.24 necessary to coordinate services;

9.25 (32) to the chief administrative officer of a school to coordinate services for a student
9.26 and family; data that may be disclosed under this clause are limited to name, date of birth,
9.27 gender, and address;

9.28 (33) to county correctional agencies to the extent necessary to coordinate services and
9.29 diversion programs; data that may be disclosed under this clause are limited to name, client
9.30 demographics, program, case status, and county worker information; or

9.31 (34) between the Department of Human Services and the Metropolitan Council for the
9.32 following purposes:

10.1 (i) to coordinate special transportation service provided under section 473.386 with
10.2 services for people with disabilities and elderly individuals funded by or through the
10.3 Department of Human Services; and

10.4 (ii) to provide for reimbursement of special transportation service provided under section
10.5 473.386.

10.6 The data that may be shared under this clause are limited to the individual's first, last, and
10.7 middle names; date of birth; residential address; and program eligibility status with expiration
10.8 date for the purposes of informing the other party of program eligibility.

10.9 (b) Information on persons who have been treated for drug or alcohol abuse may only
10.10 be disclosed according to the requirements of Code of Federal Regulations, title 42, sections
10.11 2.1 to 2.67.

10.12 (c) Data provided to law enforcement agencies under paragraph (a), clause (15), (16),
10.13 (17), or (18), or paragraph (b), are investigative data and are confidential or protected
10.14 nonpublic while the investigation is active. The data are private after the investigation
10.15 becomes inactive under section 13.82, subdivision ~~5~~ 7, ~~paragraph~~ clause (a) or (b).

10.16 (d) Mental health data shall be treated as provided in subdivisions 7, 8, and 9, but are
10.17 not subject to the access provisions of subdivision 10, paragraph (b).

(c) Except for initial appointments, the appointing authorities shall make appointments by the first Monday in January of each odd-numbered year.

- (5) request information from the Office of the United States Trade Representative necessary to conduct an appropriate review of government procurement agreements or other trade issues; and
- (6) receive information obtained by the United States Trade Representative's single point of contact for Minnesota.

Subd. 9. **Meeting.** The Trade Policy Advisory Council shall meet at least once per fiscal year.

Subd. 10. **Sunset.** The council shall sunset January 1, 2020.

161.203 CERTAIN PARK LANDS LITIGATION RIGHTS PRESERVED.

Nothing in section 161.202 shall be construed to amend, alter, or in any manner modify the rights, duties or obligations of any party to any litigation instituted on or before July 1, 1969 without the party's consent. Such litigation only concerns the proposed acquisition by the department of park lands in areas known as Minnehaha Park, Wilson Park, and North Mississippi Park located in the city of Minneapolis. The advisory committee shall meet at least quarterly the first year following January 1, 2015, and at least biannually thereafter and may meet more frequently as required by the commissioner. The advisory committee shall annually elect a chair from among its members, who shall work with the commissioner or the commissioner's designee to establish the agenda for each meeting. The commissioner, or the commissioner's designee, shall attend all advisory committee meetings.

- (1) four voting members who represent counties, utilizing the rural urban commuting area classification system. As defined in subdivision 17, these members shall be designated as follows:
 - (i) two counties within the 11-county metropolitan area;

(6) one voting member who represents an organization that contracts with state or local governments to coordinate transportation services for medical assistance enrollees;

(8) the commissioner of transportation or the commissioner's designee, who shall serve as a voting member;

(9) one voting member appointed by the Minnesota Ambulance Association; and

(b) Members of the advisory committee shall not be employed by the Department of Human Services. Members of the advisory committee shall receive no compensation.

256R.49 RATE ADJUSTMENTS FOR COMPENSATION-RELATED COSTS FOR MINIMUM WAGE CHANGES.

Subdivision 1. **Rate adjustments for compensation-related costs.** (a) Rate increases provided under this section before October 1, 2016, expire effective January 1, 2018, and rate increases provided on or after October 1, 2016, expire effective January 1, 2019.

(b) Nursing facilities that receive approval of the applications in subdivision 2 must receive rate adjustments according to subdivision 4. The rate adjustments must be used to pay compensation costs for nursing facility employees paid less than \$14 per hour.

Subd. 2. **Application process.** To receive a rate adjustment, nursing facilities must submit applications to the commissioner in a form and manner determined by the commissioner. The applications for the rate adjustments shall include specified data, and spending plans that describe how the funds from the rate adjustments will be allocated for compensation to employees paid less than \$14 per hour. The applications must be submitted within three months of the effective date of any operating payment rate adjustment under this section. The commissioner may request any additional information needed to determine the rate adjustment within three weeks of receiving a complete application. The nursing facility must provide any additional information requested by the commissioner within six months of the effective date of any operating payment rate adjustment under this section. The commissioner may waive the deadlines in this section under extraordinary circumstances.

Subd. 3. **Additional application requirements for facilities with employees represented by an exclusive bargaining representative.** For nursing facilities in which employees are represented by an exclusive bargaining representative, the commissioner shall approve the applications submitted under subdivision 2 only upon receipt of a letter or letters of acceptance of the spending plans in regard to members of the bargaining unit, signed by the exclusive bargaining agent and dated after May 31, 2014. Upon receipt of the letter or letters of acceptance, the commissioner shall deem all requirements of this section as having been met in regard to the members of the bargaining unit.

Subd. 4. **Determination of the rate adjustments for compensation-related costs.** Based on the application in subdivision 2, the commissioner shall calculate the allowable annualized compensation costs by adding the totals of clauses (1), (2), and (3). The result must be divided by the standardized or resident days from the most recently available cost report to determine per day amounts, which must be included in the operating portion of the total payment rate and allocated to direct care or other operating as determined by the commissioner:

(1) the sum of the difference between \$9.50 and any hourly wage rate less than \$9.50 for October 1, 2016; and between the indexed value of the minimum wage, as defined in section 177.24, subdivision 1, paragraph (f), and any hourly wage less than that indexed value for rate years beginning on and after October 1, 2017; multiplied by the number of compensated hours at that wage rate;

(2) using wages and hours in effect during the first three months of calendar year 2014, beginning with the first pay period beginning on or after January 1, 2014; 22.2 percent of the sum of items (i) to (viii) for October 1, 2016;

(i) for all compensated hours from \$8 to \$8.49 per hour, the number of compensated hours is multiplied by \$0.13;

(ii) for all compensated hours from \$8.50 to \$8.99 per hour, the number of compensated hours is multiplied by \$0.25;

(iii) for all compensated hours from \$9 to \$9.49 per hour, the number of compensated hours is multiplied by \$0.38;

(iv) for all compensated hours from \$9.50 to \$10.49 per hour, the number of compensated hours is multiplied by \$0.50;

(v) for all compensated hours from \$10.50 to \$10.99 per hour, the number of compensated hours is multiplied by \$0.40;

(vi) for all compensated hours from \$11 to \$11.49 per hour, the number of compensated hours is multiplied by \$0.30;

(vii) for all compensated hours from \$11.50 to \$11.99 per hour, the number of compensated hours is multiplied by \$0.20; and

(viii) for all compensated hours from \$12 to \$13 per hour, the number of compensated hours is multiplied by \$0.10; and

(3) the sum of the employer's share of FICA taxes, Medicare taxes, state and federal unemployment taxes, workers' compensation, pensions, and contributions to employee retirement accounts attributable to the amounts in clauses (1) and (2).

297A.71 CONSTRUCTION EXEMPTIONS.

Subd. 49. **Properties destroyed by fire.** Building materials and supplies used in, and equipment incorporated into, the construction or replacement of real property that is located in Madelia affected by the fire on February 3, 2016, are exempt. The tax must be imposed and collected as if the rate under section 297A.62, subdivision 1, applied and then refunded in the manner provided in section 297A.75.

473.5955 TERMINATION OF LEASE.

The lease between the Board of Regents of the University of Minnesota and the commission dated May 19, 1982, that requires the University of Minnesota football team to play its home football games at the Hubert H. Humphrey Metrodome until July 1, 2012, may be terminated by the board and the commission effective on or after the date designated by the board as the date of completion of the stadium on the University of Minnesota's east bank campus in the city of Minneapolis.

Subp. 36. **State health care program.** "State health care program" has the meaning given in Minnesota Statutes, section 256B.0751, subdivision 1, paragraph (f).
