1.5	Section 1. DISTANCE LEARNING AID FOR FAMILIES DUE TO COVID-19.
1.6	Subdivision 1. Program; eligible students. For the 2020-2021 and 2021-2022 school
1.7	years only, a public or nonpublic school student who qualifies for free and reduced-price
1.8	lunch and participated in a distance learning program is eligible for distance learning aid
1.9	for families.
1.10	Subd. 2. Application. The parent of an eligible student may apply to the student's resident
1.11	school district for distance learning aid for families. The parent may apply for up to \$450
1.12	per eligible student per school year.
1.13	Subd. 3. Eligible expenses. Eligible expenses include tutoring services, instructional
1.14	materials, online instructional content, software or other educational technology, internet
1.15	access and connectivity, classroom supplies, and pupil support services. A parent must
1.16	submit receipts for all eligible expenses.
1.17	Subd. 4. Distance learning aid for families; allotment. Each school year, the
1.18	commissioner must allot distance learning aid for families to school districts pursuant to
1.19	this section the actual amount of eligible expenses for each eligible student, not to exceed
1.20	\$450 per student per fiscal year.
1.21	Subd. 5. Vendor. The commissioner must select a vendor to administer the distance
