1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. NONPUBLIC SCHOOL SAFETY GRANTS.
1.6	Subdivision 1. Appropriation. (a) \$5,000,000 in fiscal year 2021 is appropriated from
1.7	the general fund to the commissioner of education for school safety facility and equipment
1.8	grants for improvements related to violence prevention and facility security in nonpublic
1.9	schools.
1.10	(b) Up to five percent of the appropriation is available to the commissioner to administer
1.11	the grants.
1.12	(c) This appropriation is available until June 30, 2023.
1.13	Subd. 2. Qualifying nonpublic schools. A nonpublic school that receives aid under
1.14	Minnesota Statutes, sections 123B.40 to 123B.48, is eligible to apply for a school safety
1.15	grant in the form and manner specified by the commissioner of education.
1.16	Subd. 3. Grant amount and awards. After consultation with the Department of Public
1.17	Safety's Minnesota School Safety Center, the commissioner of education may award a
1.18	school safety facility grant of no more than \$50,000 for each qualifying nonpublic school
1.19	building. The commissioner may divide the state into geographic regions and award grants
1.20	within each region for projects that meet the requirements of this subdivision on a first-come,
1.21	first-served basis. Before a grant is approved, a nonpublic school must provide documentation
1.22	acceptable to the commissioner of education specifying how the grant funds will be used.
