1.2 relating to state government; appropriating money for veterans and military affairs;

1.3 creating a Veterans Service Office grant program; requiring a report; amending

1.4 Minnesota Statutes 2020, sections 43A.183, subdivision 1; 197.608, subdivisions

1.5 4, 6; 197.79, subdivisions 1, 2, 3, 5, 10; proposing coding for new law in Minnesota

1.6 Statutes, chapter 197.

1.7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.8 **ARTICLE 1**

1.9 **VETERANS AND MILITARY AFFAIRS APPROPRIATIONS**

1.10 Section 1. **APPROPRIATIONS.**

1.11 The sums shown in the columns marked "Appropriations" are added to or, if shown in

1.12 parentheses, subtracted from the appropriations in Laws 2021, First Special Session chapter

1.13 12, article 1, to the agencies and for the purposes specified in this article. The appropriations

1.14 are from the general fund, or another named fund, and are available for the fiscal years

1.15 indicated for each purpose. The figures "2022" and "2023" used in this article mean that

1.16 the addition to or subtraction from the appropriation listed under them is available for the

1.17 fiscal year ending June 30, 2022, or June 30, 2023, respectively. "The first year" is the fiscal

1.18 year ending June 30, 2022. "The second year" is the fiscal year ending June 30, 2023.

1.19 Supplemental appropriations and reductions to appropriations for the fiscal year ending

1.20 June 30, 2022, are effective the day following final enactment.

3.12 **(c) Veterans Bonus Program. \$24,880,000**
3.13 in fiscal year 2023 is for service bonuses to
3.14 Post-9/11 Veterans and Gold Star families
3.15 under Minnesota Statutes, section 197.79. This
3.16 is a onetime appropriation and is available
3.17 until June 30, 2025.

3.18 **(d) Veterans Service Organizations Grant**
3.19 **Program. \$147,000 in fiscal year 2023 is for**
3.20 grants to congressionally chartered veterans
3.21 service organizations meeting eligibility
3.22 requirements under Minnesota Statutes,
3.23 section 197.61, subdivision 3, as designated
3.24 by the commissioner.

3.25 **(e) County Veterans Service Office Grant**
3.26 **Program. \$450,000 in fiscal year 2023 is for**
3.27 funding the County Veterans Service Office
3.28 grant program under Minnesota Statutes,
3.29 section 197.608.

3.30 **(f) Fisher House. \$500,000 in fiscal year 2023**
3.31 is for the purpose of supporting the creation
3.32 of a new Fisher House near the Fargo Veterans
3.33 Affairs (VA) Medical Center campus. The
3.34 facility will provide temporary
3.35 accommodations at no charge to families and

4.1 caregivers of veterans receiving care at the
4.2 Fargo VA Health Care System. This is a
4.3 onetime appropriation and is available until
4.4 the project is completed or abandoned, subject
4.5 to Minnesota Statutes, section 16A.642.

4.6 **(g) Redwood Falls State Veterans Cemetery.**
4.7 \$830,000 in fiscal year 2023 is for operations
4.8 of the state's veterans cemeteries, including
4.9 operations in Redwood County.

4.10 **(h) Minnesota Assistance Council for**
4.11 **Veterans. \$5,412,000 in fiscal year 2023 is**
4.12 **for a grant to the Minnesota Assistance**
4.13 **Council for Veterans to provide assistance**
4.14 **throughout Minnesota to veterans and former**
4.15 **service members and their families who are**
4.16 **homeless or in danger of homelessness,**
4.17 **including assistance with the following:**

4.18 (1) supportive services to maintain housing;

4.19 (2) employment;

4.20 (3) legal issues;

4.21 (4) housing and housing-related costs; and

4.22 (5) transportation.

4.23 The assistance authorized under this paragraph
4.24 must be made only to veterans or former
4.25 service members who have resided in
4.26 Minnesota for 30 days prior to application for
4.27 assistance and according to other guidelines
4.28 established by the commissioner. In order to
4.29 avoid duplication of services, the
4.30 commissioner must ensure that this assistance
4.31 is coordinated with all other available
4.32 programs for veterans.

5.1 This appropriation must be used for the
5.2 establishment and management of permanent
5.3 supportive housing options for homeless
5.4 veterans and former service members.

5.5 This is a onetime appropriation. Any
5.6 unencumbered balance remaining in this
5.7 subdivision in fiscal year 2023 is available in
5.8 fiscal years 2024 and 2025.

5.9 **(i) Increase Engagement and Outreach**
5.10 **Activities; Support Temporary Housing**
5.11 **Options.** \$1,714,000 in fiscal year 2023 is for
5.12 temporary alternative housing options for
5.13 homeless veterans and former service
5.14 members and for staff to increase outreach
5.15 activities to end homelessness. The
5.16 commissioner of veterans affairs may use
5.17 funds for personnel, research, marketing, and
5.18 professional or technical contracts.

5.19 **(j) Tenancy Supports and Landlord**
5.20 **Engagement.** \$1,100,000 in fiscal year 2023
5.21 is for incentives for landlords to assist in
5.22 housing homeless veterans and former service
5.23 members, staff, and funding to remove barriers
5.24 to permanent housing. The commissioner of
5.25 veterans affairs may use funds for financial
5.26 assistance, personnel, research, marketing, and
5.27 professional or technical contracts. The base
5.28 in fiscal year 2024 and each year thereafter is
5.29 \$950,000.

5.30 **(k) Veterans Campground Wastewater**
5.31 **System Upgrades.** \$774,000 in fiscal year
5.32 2023 is for one or more grants to the Veterans
5.33 Campground on Big Marine Lake, a 501(c)(3)
5.34 nonprofit organization, to design, engineer,
5.35 permit, and construct wastewater systems on

6.1 campground property to increase the capacity
 6.2 of wastewater systems. This is a onetime
 6.3 appropriation.

6.4 Sec. 4. **NEW VETERANS HOMES; BEMIDJI, MONTEVIDEO, AND PRESTON;**
 6.5 **APPROPRIATION.**

6.6 (a) \$10,329,000 in fiscal year 2022 is appropriated from the general fund to the
 6.7 commissioner of administration for new veterans homes in Bemidji, Montevideo, and
 6.8 Preston. This appropriation is in addition to the appropriation for the same purposes in Laws
 6.9 2018, chapter 214, article 1, section 19, subdivision 3, and is available until the project is
 6.10 completed or abandoned subject to Minnesota Statutes, section 16A.642.

6.11 (b) \$2,389,000 of this appropriation is to design, construct, furnish, and equip the veterans
 6.12 home in Bemidji.

6.13 (c) \$6,955,000 of this appropriation is to design, construct, furnish, and equip the veterans
 6.14 home in Montevideo.

6.15 (d) \$985,000 of this appropriation is to design, construct, furnish, and equip the veterans
 6.16 home in Preston.

6.17 **EFFECTIVE DATE.** This section is effective the day following final enactment.

6.18 Sec. 5. **APPROPRIATIONS GIVEN EFFECT ONCE.**

6.19 If an appropriation in this act is enacted more than once during the 2022 regular session,
 6.20 the appropriation is to be given effect only once.

6.21 **EFFECTIVE DATE.** This section is effective the day following final enactment.

6.22 **ARTICLE 2**

6.23 **VETERANS AND MILITARY AFFAIRS POLICY**

6.24 Section 1. Minnesota Statutes 2020, section 43A.183, subdivision 1, is amended to read:

6.25 Subdivision 1. **Payment required.** Each agency head shall pay to each eligible member
 6.26 an amount equal to the person's salary differential for each month or portion of month that
 6.27 the person is ordered to serve in active service.

6.28 This payment may be made only to a person for whom the amount in subdivision 2,
 6.29 paragraph (b), clause (1), is greater than the amount in subdivision 2, paragraph (b), clause
 6.30 (2). Payments must be made at the intervals at which the member received pay as a state

7.1 employee, except that any back pay due under this section may be paid as a lump sum.
 7.2 Payment under this section must not extend beyond four years from the date the employee
 7.3 reported for active service, plus any additional time the employee may be legally required
 7.4 to serve. An eligible member may apply for the salary differential benefits authorized under
 7.5 this section ~~prior to, during, or following the person's active service on or after May 29,~~
 7.6 ~~2003~~ no later than two years after completion of active service. The eligible member must
 7.7 be provided with notice as described in subdivision 4 of the two-year deadline. A copy of
 7.8 military orders showing active service must be provided prior to payment.

7.9 **EFFECTIVE DATE.** This section is effective the day following final enactment.

7.10 Sec. 2. Minnesota Statutes 2020, section 197.608, subdivision 4, is amended to read:

7.11 Subd. 4. **Grant process.** (a) The commissioner shall determine the process for awarding
 7.12 grants. A grant may be used only for the purpose of enhancing the operations of the County
 7.13 Veterans Service Office.

7.14 (b) The commissioner shall provide a list of qualifying uses for grant expenditures as
 7.15 developed in subdivision 5 and shall approve a grant under subdivision 6 only for a qualifying
 7.16 use and if there are sufficient funds remaining in the grant program to cover the full amount
 7.17 of the grant.

7.18 (c) The commissioner is authorized to use any unexpended funding for this program ~~to~~
 7.19 ~~provide training and education for county veterans service officers.~~ for the following
 7.20 purposes:

7.21 (1) to provide training and education for county veterans service officers; and

7.22 (2) to provide additional grants on a competitive basis to any county that proposes to
 7.23 provide programs and services that the commissioner determines to be new and innovative
 7.24 in serving veterans and their families.

7.25 Sec. 3. Minnesota Statutes 2020, section 197.608, subdivision 6, is amended to read:

7.26 Subd. 6. **Grant amount.** (a) Each county is eligible to receive an annual grant of \$7,500
 7.27 for the following purposes:

7.28 (1) to provide outreach to the county's veterans;

7.29 (2) to assist in the reintegration of combat veterans into society;

7.30 (3) to collaborate with other social service agencies, educational institutions, and other
 7.31 community organizations for the purposes of enhancing services offered to veterans;

8.1 (4) to reduce homelessness among veterans; and

8.2 (5) to enhance the operations of the county veterans service office.

8.3 (b) In addition to the grant amount in paragraph (a), each county is eligible to receive
8.4 an additional annual grant under this paragraph. The amount of each additional annual grant
8.5 must be determined by the commissioner and may not exceed:

8.6 (1) \$0, if the county's veteran population is less than 1,000;

8.7 (2) \$2,500, if the county's veteran population is 1,000 or more but less than 3,000;

8.8 (3) \$5,000, if the county's veteran population is 3,000 or more but less than ~~4,999~~ 5,000;

8.9 (4) \$7,500, if the county's veteran population is 5,000 or more but less than ~~9,999~~ 10,000;

8.10 (5) \$10,000, if the county's veteran population is 10,000 or more but less than ~~19,999~~
8.11 20,000;

8.12 (6) \$15,000, if the county's veteran population is 20,000 or more but less than ~~29,999~~
8.13 30,000; or

8.14 (7) \$20,000, if the county's veteran population is 30,000 or more.

8.15 (c) The Minnesota Association of County Veterans Service Officers is eligible to receive
8.16 an annual grant of ~~\$50,000~~ \$100,000. The grant shall be used for administrative costs of
8.17 the association, certification of mandated county veterans service officer training and
8.18 accreditation, and costs associated with reintegration services.

8.19 The veteran population of each county shall be determined by the figure supplied by the
8.20 United States Department of Veterans Affairs, as adopted by the commissioner.

8.21 **Sec. 4. [197.61] VETERANS SERVICE ORGANIZATIONS GRANT PROGRAM.**

8.22 Subdivision 1. **Grant program.** A veterans service organization grant program is
8.23 established to provide grants to congressionally chartered veterans service organizations
8.24 (VSO) to enhance the effectiveness of veterans services. The program shall be administered
8.25 by the commissioner of veterans affairs.

8.26 Subd. 2. **Definitions.** (a) For purposes of this section, the following terms have the
8.27 meanings given.

8.28 (b) "Accredited representation" means providing representation under the authority
8.29 granted by the VA to representatives, agents, and attorneys to assist claimants in the
8.30 preparation, presentation, and prosecution of claims for VA benefits.

9.1 (c) "Commissioner" means the commissioner of veterans affairs or a designee.

9.2 (d) "Congressionally chartered veterans service organizations" are organizations that
9.3 have been granted charters by Congress through the enactment of public laws. Each
9.4 congressionally chartered VSO is listed in United States Code, title 36, subtitle II: Patriotic
9.5 and National Organizations.

9.6 (e) "Department" means the Department of Veterans Affairs.

9.7 (f) "Full member" means a veteran who meets the requirements for membership in a
9.8 congressionally chartered veterans service organization and is entitled to all of the rights
9.9 and privileges thereof. Full member does not include an associate or auxiliary member.

9.10 (g) "VA" means the United States Department of Veterans Affairs.

9.11 Subd. 3. **Eligibility.** To be eligible for a grant under subdivision 6, a veterans service
9.12 organization must provide:

9.13 (1) accredited representation for the preparation and presentation of veteran claims to
9.14 the United States government for compensation and other benefits to which a veteran is
9.15 entitled as a result of the veteran's military service;

9.16 (2) a state or department level veterans service officer to provide programs and services
9.17 to veterans; or

9.18 (3) statewide transportation services to veterans.

9.19 Subd. 4. **Grant process.** (a) A grant may be used only for the purpose of enhancing the
9.20 operations of congressionally chartered veterans service organizations.

9.21 (b) The commissioner shall provide a list of qualifying uses for grant expenditures as
9.22 required in subdivision 5 and shall approve a grant for a qualifying use if there is sufficient
9.23 grant money remaining in the grant program to cover the full amount of the grant.

9.24 Subd. 5. **Qualifying uses.** The commissioner shall develop a list of qualifying uses for
9.25 grants awarded under this section.

9.26 Subd. 6. **Grant amount.** (a) Each congressionally chartered veterans service organization
9.27 is eligible to receive an annual grant determined by the commissioner as follows:

9.28 (1) a dollar amount per full member for each organization member to be established by
9.29 the commissioner. The dollar amount may be adjusted every biennium, subject to available
9.30 funding; and

10.1 (2) a dollar amount for each organization, established by the commissioner, based on
10.2 the organization's share of the VA claims workload for veterans and their dependents who
10.3 reside in Minnesota. The VA claims workload must be reported as a percentage of the state's
10.4 total VA workload.

10.5 (b) The VA claims workload for each congressionally chartered veterans service
10.6 organization must be determined by a report supplied by the VA, as adopted by the
10.7 commissioner.

10.8 Subd. 7. **Recapture.** If a congressionally chartered veterans service organization fails
10.9 to use the grant for a qualified use approved by the commissioner or does not spend the
10.10 allocated grant money, the commissioner shall seek recovery of the grant from the
10.11 organization and the organization must repay the grant amount or any unused grant money.

10.12 Sec. 5. Minnesota Statutes 2020, section 197.79, subdivision 1, is amended to read:

10.13 Subdivision 1. **Definitions.** For purposes of this section, the following terms have the
10.14 meanings given them.

10.15 (a) "Applicant" means a veteran or a veteran's guardian, conservator, or personal
10.16 representative or a beneficiary or a beneficiary's guardian, conservator, or personal
10.17 representative who has filed an application with the commissioner for a bonus under this
10.18 section.

10.19 (b) "Application" means a request for a bonus payment by a veteran, a veteran's
10.20 beneficiary, or a veteran's guardian, conservator, or personal representative through
10.21 submission of written information on a form designed by the commissioner for this purpose.

10.22 (c) "Beneficiary" means in relation to a deceased veteran and in the order named:

10.23 (1) the surviving spouse, if not remarried;

10.24 (2) the children of the veteran, if there is no surviving spouse or the surviving spouse
10.25 has remarried;

10.26 (3) the veteran's surviving parent or parents;

10.27 (4) the veteran's surviving sibling or siblings; or

10.28 (5) the veteran's estate.

10.29 (d) "Commissioner" means the commissioner of the Department of Veterans Affairs.

10.30 (e) "Department" means the Department of Veterans Affairs.

11.1 (f) "Eligibility period for the bonus" means the period from ~~August 2, 1990, to July 31,~~
 11.2 ~~1991~~ September 11, 2001, to August 30, 2021.

11.3 (g) "Guardian" or "conservator" means the legally appointed representative of a minor
 11.4 or incapacitated beneficiary or ~~incompetent~~ veteran, the chief officer of a hospital or
 11.5 institution in which the ~~incompetent~~ incapacitated veteran is placed if the officer is authorized
 11.6 to accept money for the benefit of the minor or ~~incompetent~~ incapacitated, the person
 11.7 determined by the commissioner to be the person who is legally charged with the
 11.8 responsibility for the care of the minor or incapacitated beneficiary or ~~incompetent~~ veteran,
 11.9 or the person determined by the commissioner to be the person who has assumed the
 11.10 responsibility for the care of the minor or incapacitated beneficiary or ~~incompetent~~ veteran.

11.11 (h) "Honorable service" means honorable federal service in the United States armed
 11.12 forces, as evidenced by:

11.13 (1) an honorable discharge;

11.14 (2) a general discharge under honorable conditions;

11.15 (3) in the case of an officer, a certificate of honorable service; or

11.16 (4) in the case of an applicant who is currently serving in active duty in the United States
 11.17 armed forces, a certificate from an appropriate service authority that the applicant's service
 11.18 to date has been honorable.

11.19 (i) "Incapacitated person" means an individual who, for reasons other than being a minor,
 11.20 lacks sufficient understanding or the capacity to make personal decisions and who is unable
 11.21 to meet the individual's own personal needs for medical care, nutrition, clothing, shelter, or
 11.22 safety even when assisted by appropriate technology or supported decision making.

11.23 ~~(j)~~ (j) "Resident veteran" means a veteran who served in active duty in the United States
 11.24 armed forces at any time during the eligibility period for the bonus, and who also:

11.25 (1) has been separated or discharged from the United States armed forces, and whose
 11.26 home of record at the time of entry into active duty in the United States armed forces, as
 11.27 indicated on the person's form DD-214 or other documents the commissioner may authorize,
 11.28 is the state of Minnesota and who resides in Minnesota at the time of application with the
 11.29 intention of residing in the state and not for any temporary purpose. An applicant may verify
 11.30 a residence address by presenting a valid state driver's license; a state identification card; a
 11.31 voter registration card; a rent receipt; a statement by the landlord, apartment manager, or
 11.32 homeowner verifying that the individual is residing at the address; or other form of
 11.33 verification approved by the commissioner; or

12.1 (2) is currently serving in the United States armed forces, and has a certificate from an
 12.2 appropriate service authority stating that the person: (i) served in active duty in the United
 12.3 States armed forces at any time during the eligibility period for the bonus; and (ii) ~~had~~ has
 12.4 Minnesota listed as the veteran's home of record ~~at the time of entry into active duty in the~~
 12.5 ~~United States armed forces~~ in the veteran's official military personnel file.

12.6 ~~(j)~~ (k) "Service connected" means caused by an injury or disease incurred or aggravated
 12.7 while on active duty, as determined by the United States Department of Veterans Affairs.

12.8 ~~(k)~~ (l) "Veteran" has the meaning given in section 197.447, and does not include a
 12.9 member of the National Guard or the reserve components of the United States armed forces
 12.10 ordered to active duty for the sole purpose of training. Veteran also includes:

12.11 ~~(1)~~ a person who is providing honorable service on active duty in the United States
 12.12 armed forces and has not been separated or discharged; ~~or,~~

12.13 ~~(2) a member of a reserve component of the armed forces of the United States, including~~
 12.14 ~~the National Guard, who was ordered to active duty under United States Code, title 10,~~
 12.15 ~~section 673b, during the eligibility period for the bonus and who was deployed to a duty~~
 12.16 ~~station outside the state of Minnesota, as verified by the appropriate service authority. An~~

12.22 Subd. 2. **Bonus amount.** (a) For a resident veteran who provided honorable service in
 12.23 the United States armed forces at any time during the eligibility period for the bonus, the
 12.24 bonus amount is:

12.25 (1) ~~\$300~~ \$600, if the veteran did not receive the ~~Southwest Asia service medal~~ Armed
 12.26 Forces Expeditionary Medal, Global War on Terrorism Expeditionary Medal, Iraq Campaign
 12.27 Medal, or Afghanistan Campaign Medal during the eligibility period for the bonus;

12.28 (2) ~~\$600~~ \$1200, if the veteran received the ~~Southwest Asia service medal~~ Armed Forces
 12.29 Expeditionary Medal, Global War on Terrorism Expeditionary Medal, Iraq Campaign Medal,
 12.30 or Afghanistan Campaign Medal during the eligibility period for the bonus; or
