1.7 1.8	Section 1. Minnesota Statutes 2022, section 297A.71, is amended by adding a subdivision to read:
1.9	Subd. 54. Road construction materials purchased by contractors. (a) Materials,
1.10	supplies, and equipment used in the construction, reconstruction, repair, maintenance, or
1.11	improvement of roads purchased by a contractor or subcontractor of the following entities
1.12	are exempt:
1.13	(1) school districts, as defined under section 297A.70, subdivision 2, paragraph (c); and
1.14	(2) local governments, as defined under section 297A.70, subdivision 2, paragraph (d).
1.15	(b) The tax on purchases exempt under this subdivision must be imposed and collected
1.16	as if the rate under section 297A.62, subdivision 1, applied and then refunded in the manner
1.17	provided in section 297A.75.

3.16	Subd. 2. Refund; eligible persons. Upon application on forms prescribed by the
3.17	commissioner, a refund equal to the tax paid on the gross receipts of the exempt items must
3.18	be paid to the applicant. Only the following persons may apply for the refund:
3.19	(1) for subdivision 1, clauses (1), (2), and (14), the applicant must be the purchaser;
3.20	(2) for subdivision 1, clause (3), the applicant must be the governmental subdivision;
3.21	(3) for subdivision 1, clause (4), the applicant must be the recipient of the benefits
3.22	provided in United States Code, title 38, chapter 21;
3.23	(4) for subdivision 1, clause (5), the applicant must be the owner of the homestead
3.24	property;
3.25	(5) for subdivision 1, clause (6), the owner of the qualified low-income housing project;
3.26	(6) for subdivision 1, clause (7), the applicant must be a municipal electric utility or a
3.27	joint venture of municipal electric utilities;

4.8	Subd. 3. Application. (a) The application must include sufficient information to permit
4.9	the commissioner to verify the tax paid. If the tax was paid by a contractor, subcontractor,
4.10	or builder, under subdivision 1, clauses (3) to (13) or (15) to (18) (19), the contractor,
4.11	subcontractor, or builder must furnish to the refund applicant a statement including the cost
4.12	of the exempt items and the taxes paid on the items unless otherwise specifically provided
4.13	by this subdivision. The provisions of sections 289A.40 and 289A.50 apply to refunds under
4.14	this section.
4.15	(b) An applicant may not file more than two applications per calendar year for refunds
