BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. [148B.331] GUEST LICENSURE.

- Subdivision 1. Generally. (a) A nonresident of the state of Minnesota who is not seeking 1.8 licensure in Minnesota and intends to practice marriage and family therapy in Minnesota 1.9 must apply to the board for guest licensure. An applicant must apply for guest licensure at 1.10 least 30 days prior to the expected date of practice in Minnesota and is subject to approval 1.11 by the board or its designee. 1.12
- (b) To be eligible for licensure under this section, the applicant must: 1.13
- (1) have a license, certification, or registration in good standing to practice marriage and 1.14 family therapy from another jurisdiction; 1.15
- (2) have a graduate degree in marriage and family therapy from a regionally accredited 1.16 institution or a degree in a related field from a regionally accredited institution with completed 1.17 coursework meeting the educational requirements provided in Minnesota Rules, part 1.18 5300.0140, subpart 2; 1.19
- (3) be of good moral character; 1.20
- (4) have no pending complaints or active disciplinary or corrective actions in any 1.21 jurisdiction; 1.22

.10	the state of Minnesota who is not seeking licensure in Minnesota may serve as an expert
.11	witness, organizational consultant, presenter, or educator without obtaining guest licensure,
.12	provided the nonresident is appropriately trained, educated, or has been issued a license,
.13	certificate, or registration by another jurisdiction.
.14	Subd. 3. Prohibitions and sanctions. A person's privilege to practice under this section
.15	is subject to the prohibitions and sanctions for unprofessional or unethical conduct contained
.16	in Minnesota laws and rules for marriage and family therapy under this chapter.
