1.20 Section 1. Minnesota Statutes 2022, section 62J.61, subdivision 5, is amended to read:

1.21 Subd. 5. ~~Biennial review of rulemaking procedures and rules~~ Opportunity for

1.22 comment. The commissioner shall ~~biennially seek comments from affected parties~~ maintain

1.23 an email address for submission of comments from interested parties to provide input about

1.24 the effectiveness of and continued need for the rulemaking procedures set out in subdivision

1.25 2 and about the quality and effectiveness of rules adopted using these procedures. The

1.26 commissioner ~~shall seek comments by holding a meeting and by publishing a notice in the~~

1.27 ~~State Register that contains the date, time, and location of the meeting and a statement that~~

1.28 ~~invites oral or written comments. The notice must be published at least 30 days before the~~

1.29 ~~meeting date. The commissioner shall write a report summarizing the comments and shall~~

 2.8 a director to execute operations, conduct health education, and provide technical assistance.

2.9 Sec. 3. Minnesota Statutes 2022, section 144.058, is amended to read:

2.10 **144.058 INTERPRETER SERVICES QUALITY INITIATIVE.**

2.11 (a) The commissioner of health shall establish a voluntary statewide roster; and develop
 2.12 a plan for a registry and certification process for interpreters who provide high quality,
 2.13 spoken language health care interpreter services. The roster, registry, and certification
 2.14 process shall be based on the findings and recommendations set forth by the Interpreter
 2.15 Services Work Group required under Laws 2007, chapter 147, article 12, section 13.

2.16 (b) By January 1, 2009, the commissioner shall establish a roster of all available
 2.17 interpreters to address access concerns, particularly in rural areas.

2.18 (c) By January 15, 2010, the commissioner shall:

2.19 (1) develop a plan for a registry of spoken language health care interpreters, including:

2.20 (i) development of standards for registration that set forth educational requirements,

 3.5 roster. Fee revenue shall be deposited in the state government special revenue fund. All fees
 3.6 are nonrefundable.

3.8 Subd. 2. **Definitions.** For purposes of this section, the following terms have the meanings

3.10 (a) "Assessment reference date" or "ARD" means the specific end point for look-back
 3.11 periods in the MDS assessment process. This look-back period is also called the observation
 3.12 or assessment period.

3.13 (b) "Case mix index" means the weighting factors assigned to the ~~RUG-IV~~ case mix
 3.14 reimbursement classifications determined by an assessment.

3.15 (c) "Index maximization" means classifying a resident who could be assigned to more
 3.16 than one category, to the category with the highest case mix index.

3.17 (d) "Minimum Data Set" or "MDS" means a core set of screening, clinical assessment,
 3.18 and functional status elements, that include common definitions and coding categories
 3.19 specified by the Centers for Medicare and Medicaid Services and designated by the
 3.20 Department of Health.

3.21 (e) "Representative" means a person who is the resident's guardian or conservator, the
 3.22 person authorized to pay the nursing home expenses of the resident, a representative of the
 3.23 Office of Ombudsman for Long-Term Care whose assistance has been requested, or any
 3.24 other individual designated by the resident.

3.25 ~~(f) "Resource utilization groups" or "RUG" means the system for grouping a nursing~~
 3.26 ~~facility's residents according to their clinical and functional status identified in data supplied~~
 3.27 ~~by the facility's Minimum Data Set.~~

3.28 ~~(g)~~ (f) "Activities of daily living" includes personal hygiene, dressing, bathing,
 3.29 transferring, bed mobility, locomotion, eating, and toileting.

3.30 ~~(h)~~ (g) "Nursing facility level of care determination" means the assessment process that
 3.31 results in a determination of a resident's or prospective resident's need for nursing facility

4.26 Sec. 6. Minnesota Statutes 2022, section 144.0724, subdivision 4, is amended to read:

4.27 Subd. 4. **Resident assessment schedule.** (a) A facility must conduct and electronically

4.28 submit to the federal database MDS assessments that conform with the assessment schedule

4.29 defined by the Long Term Care Facility Resident Assessment Instrument User's Manual,

4.30 version 3.0, or its successor issued by the Centers for Medicare and Medicaid Services. The

4.31 commissioner of health may substitute successor manuals or question and answer documents

4.32 published by the United States Department of Health and Human Services, Centers for

5.1 Medicare and Medicaid Services, to replace or supplement the current version of the manual
5.2 or document.

5.3 (b) The assessments required under the Omnibus Budget Reconciliation Act of 1987
5.4 (OBRA) used to determine a case mix reimbursement classification ~~for reimbursement~~
5.5 include:

5.6 (1) a new admission comprehensive assessment, which must have an assessment reference
5.7 date (ARD) within 14 calendar days after admission, excluding readmissions;

5.8 (2) an annual comprehensive assessment, which must have an ARD within 92 days of
5.9 a previous quarterly review assessment or a previous comprehensive assessment, which
5.10 must occur at least once every 366 days;

5.11 (3) a significant change in status comprehensive assessment, which must have an ARD
5.12 within 14 days after the facility determines, or should have determined, that there has been
5.13 a significant change in the resident's physical or mental condition, whether an improvement
5.14 or a decline, and regardless of the amount of time since the last comprehensive assessment
5.15 or quarterly review assessment;

5.16 (4) a quarterly review assessment must have an ARD within 92 days of the ARD of the
5.17 previous quarterly review assessment or a previous comprehensive assessment;

5.18 (5) any significant correction to a prior comprehensive assessment, if the assessment
5.19 being corrected is the current one being used for ~~RUG~~ reimbursement classification;

5.20 (6) any significant correction to a prior quarterly review assessment, if the assessment
5.21 being corrected is the current one being used for ~~RUG~~ reimbursement classification; and

5.22 ~~(7) a required significant change in status assessment when:~~

5.23 ~~(i) all speech, occupational, and physical therapies have ended. If the most recent OBRA~~

6.1 (c) The optional state assessment must accompany all OBRA assessments. The optional
 6.2 state assessment is also required to determine reimbursement when:

6.3 (i) all speech, occupational, and physical therapies have ended. If the most recent optional
 6.4 state assessment completed does not result in a rehabilitation case mix reimbursement
 6.5 classification, then the optional state assessment is not required. The ARD of this assessment
 6.6 must be set on day eight after all therapy services have ended; and

6.7 (ii) isolation for an infectious disease has ended. If isolation was not coded on the most
 6.8 recent optional state assessment completed, then the optional state assessment is not required.
 6.9 The ARD of this assessment must be set on day 15 after isolation has ended.

6.10 ~~(e)~~ (d) In addition to the assessments listed in ~~paragraph~~ paragraphs (b) and (c), the
 6.11 assessments used to determine nursing facility level of care include the following:

6.12 (1) preadmission screening completed under section 256.975, subdivisions 7a to 7c, by
 6.13 the Senior LinkAge Line or other organization under contract with the Minnesota Board on
 6.14 Aging; and

6.15 (2) a nursing facility level of care determination as provided for under section 256B.0911,
 6.16 subdivision 26, as part of a face-to-face long-term care consultation assessment completed
 6.17 under section 256B.0911, by a county, tribe, or managed care organization under contract

6.19 Sec. 7. Minnesota Statutes 2022, section 144.0724, subdivision 6, is amended to read:

6.20 Subd. 6. **Penalties for late or nonsubmission.** (a) A facility that fails to complete or
 6.21 submit an assessment according to subdivisions 4 and 5 for a ~~RUG-IV~~ case mix
 6.22 reimbursement classification within seven days of the time requirements listed in the
 6.23 Long-Term Care Facility Resident Assessment Instrument User's Manual when the
 6.24 assessment is due is subject to a reduced rate for that resident. The reduced rate shall be the
 6.25 lowest rate for that facility. The reduced rate is effective on the day of admission for new
 6.26 admission assessments, on the ARD for significant change in status assessments, or on the
 6.27 day that the assessment was due for all other assessments and continues in effect until the
 6.28 first day of the month following the date of submission and acceptance of the resident's
 6.29 assessment.

6.30 (b) If loss of revenue due to penalties incurred by a facility for any period of 92 days

7.5 Subd. 7. **Notice of resident ~~reimbursement~~ case mix reimbursement classification.** (a)
 7.6 The commissioner of health shall provide to a nursing facility a notice for each resident of
 7.7 the classification established under subdivision 1. The notice must inform the resident of
 7.8 the case mix reimbursement classification assigned, the opportunity to review the
 7.9 documentation supporting the classification, the opportunity to obtain clarification from the
 7.10 commissioner, ~~and~~ the opportunity to request a reconsideration of the classification, and
 7.11 the address and telephone number of the Office of Ombudsman for Long-Term Care. The
 7.12 commissioner must transmit the notice of resident classification by electronic means to the
 7.13 nursing facility. The nursing facility is responsible for the distribution of the notice to each
 7.14 resident or the resident's representative. This notice must be distributed within three business
 7.15 days after the facility's receipt.

7.16 (b) If a facility submits a ~~modifying~~ modified assessment resulting in a change in the
 7.17 case mix reimbursement classification, the facility must provide a written notice to the
 7.18 resident or the resident's representative regarding the item or items that were modified and
 7.19 the reason for the modifications. The written notice must be provided within three business
 7.20 days after distribution of the resident case mix reimbursement classification notice.

7.21 Sec. 9. Minnesota Statutes 2022, section 144.0724, subdivision 8, is amended to read:

7.22 Subd. 8. **Request for reconsideration of resident classifications.** (a) The resident, ~~or~~
 7.23 resident's representative, ~~or~~ the nursing facility, or the boarding care home may request that
 7.24 the commissioner of health reconsider the assigned ~~reimbursement~~ case mix reimbursement
 7.25 classification and any item or items changed during the audit process. The request for
 7.26 reconsideration must be submitted in writing to the commissioner of health.

7.27 (b) For reconsideration requests initiated by the resident or the resident's representative:

7.28 (1) The resident or the resident's representative must submit in writing a reconsideration
 7.29 request to the facility administrator within 30 days of receipt of the resident classification
 7.30 notice. The written request must include the reasons for the reconsideration request.

7.31 (2) Within three business days of receiving the reconsideration request, the nursing
 7.32 facility must submit to the commissioner of health a completed reconsideration request

8.1 form, a copy of the resident's or resident's representative's written request, and all supporting
8.2 documentation used to complete the assessment being ~~considered~~ reconsidered. If the facility
8.3 fails to provide the required information, the reconsideration will be completed with the
8.4 information submitted and the facility cannot make further reconsideration requests on this
8.5 classification.

8.6 (3) Upon written request and within three business days, the nursing facility must give
8.7 the resident or the resident's representative a copy of the assessment being reconsidered and
8.8 all supporting documentation used to complete the assessment. Notwithstanding any law
8.9 to the contrary, the facility may not charge a fee for providing copies of the requested
8.10 documentation. If a facility fails to provide the required documents within this time, it is
8.11 subject to the issuance of a correction order and penalty assessment under sections 144.653
8.12 and 144A.10. Notwithstanding those sections, any correction order issued under this
8.13 subdivision must require that the nursing facility immediately comply with the request for
8.14 information, and as of the date of the issuance of the correction order, the facility shall
8.15 forfeit to the state a \$100 fine for the first day of noncompliance, and an increase in the
8.16 \$100 fine by \$50 increments for each day the noncompliance continues.

8.17 (c) For reconsideration requests initiated by the facility:

8.18 (1) The facility is required to inform the resident or the resident's representative in writing
8.19 that a reconsideration of the resident's case mix reimbursement classification is being
8.20 requested. The notice must inform the resident or the resident's representative:

8.21 (i) of the date and reason for the reconsideration request;

8.22 (ii) of the potential for a case mix reimbursement classification change and subsequent
8.23 rate change;

8.24 (iii) of the extent of the potential rate change;

8.25 (iv) that copies of the request and supporting documentation are available for review;

8.26 and

8.27 (v) that the resident or the resident's representative has the right to request a
8.28 reconsideration also.

8.29 (2) Within 30 days of receipt of the audit exit report or resident classification notice, the
8.30 facility must submit to the commissioner of health a completed reconsideration request
8.31 form, all supporting documentation used to complete the assessment being reconsidered,
8.32 and a copy of the notice informing the resident or the resident's representative that a
8.33 reconsideration of the resident's classification is being requested.

9.1 (3) If the facility fails to provide the required information, the reconsideration request
 9.2 may be denied and the facility may not make further reconsideration requests on this
 9.3 classification.

9.4 (d) Reconsideration by the commissioner must be made by individuals not involved in
 9.5 reviewing the assessment, audit, or reconsideration that established the disputed classification.
 9.6 The reconsideration must be based upon the assessment that determined the classification
 9.7 and upon the information provided to the commissioner of health under paragraphs (a) to
 9.8 (c). If necessary for evaluating the reconsideration request, the commissioner may conduct
 9.9 on-site reviews. Within 15 business days of receiving the request for reconsideration, the
 9.10 commissioner shall affirm or modify the original resident classification. The original
 9.11 classification must be modified if the commissioner determines that the assessment resulting
 9.12 in the classification did not accurately reflect characteristics of the resident at the time of
 9.13 the assessment. The commissioner must transmit the reconsideration classification notice
 9.14 by electronic means to the nursing facility. The nursing facility is responsible for the
 9.15 distribution of the notice to the resident or the resident's representative. The notice must be
 9.16 distributed by the nursing facility within three business days after receipt. A decision by
 9.17 the commissioner under this subdivision is the final administrative decision of the agency
 9.18 for the party requesting reconsideration.

9.19 (e) The case mix reimbursement classification established by the commissioner shall be
 9.20 the classification which applies to the resident while the request for reconsideration is
 9.21 pending. If a request for reconsideration applies to an assessment used to determine nursing
 9.22 facility level of care under subdivision 4, paragraph ~~(e)~~ (d), the resident shall continue to
 9.23 be eligible for nursing facility level of care while the request for reconsideration is pending.

9.24 (f) The commissioner may request additional documentation regarding a reconsideration
 9.25 necessary to make an accurate reconsideration determination.

9.26 (g) Data collected as part of the reconsideration process under this section is classified
 9.27 as private data on individuals and nonpublic data pursuant to section 13.02. Notwithstanding
 9.28 the classification of these data as private or nonpublic, the commissioner is authorized to
 9.29 share these data with the U.S. Centers for Medicare and Medicaid Services and the
 9.30 commissioner of human services as necessary for reimbursement purposes.

9.31 Sec. 10. Minnesota Statutes 2022, section 144.0724, subdivision 9, is amended to read:

9.32 Subd. 9. **Audit authority.** (a) The commissioner shall audit the accuracy of resident
 9.33 assessments performed under section 256R.17 through any of the following: desk audits;
 9.34 on-site review of residents and their records; and interviews with staff, residents, or residents'

10.1 families. The commissioner shall reclassify a resident if the commissioner determines that
10.2 the resident was incorrectly classified.

10.3 (b) The commissioner is authorized to conduct on-site audits on an unannounced basis.

10.4 (c) A facility must grant the commissioner access to examine the medical records relating
10.5 to the resident assessments selected for audit under this subdivision. The commissioner may
10.6 also observe and speak to facility staff and residents.

10.7 (d) The commissioner shall consider documentation under the time frames for coding
10.8 items on the minimum data set as set out in the Long-Term Care Facility Resident Assessment
10.9 Instrument User's Manual or OSA Manual version 1.0 v.2 published by the Centers for
10.10 Medicare and Medicaid Services.

10.11 (e) The commissioner shall develop an audit selection procedure that includes the
10.12 following factors:

10.13 (1) Each facility shall be audited annually. If a facility has two successive audits in which
10.14 the percentage of change is five percent or less and the facility has not been the subject of
10.15 a special audit in the past 36 months, the facility may be audited biannually. A stratified
10.16 sample of 15 percent, with a minimum of ten assessments, of the most current assessments
10.17 shall be selected for audit. If more than 20 percent of the ~~RUG-IV~~ case mix reimbursement
10.18 classifications are changed as a result of the audit, the audit shall be expanded to a second
10.19 15 percent sample, with a minimum of ten assessments. If the total change between the first
10.20 and second samples is 35 percent or greater, the commissioner may expand the audit to all
10.21 of the remaining assessments.

10.22 (2) If a facility qualifies for an expanded audit, the commissioner may audit the facility
10.23 again within six months. If a facility has two expanded audits within a 24-month period,
10.24 that facility will be audited at least every six months for the next 18 months.

10.25 (3) The commissioner may conduct special audits if the commissioner determines that
10.26 circumstances exist that could alter or affect the validity of case mix reimbursement
10.27 classifications of residents. These circumstances include, but are not limited to, the following:

10.28 (i) frequent changes in the administration or management of the facility;

10.29 (ii) an unusually high percentage of residents in a specific case mix reimbursement
10.30 classification;

10.31 (iii) a high frequency in the number of reconsideration requests received from a facility;

11.1 (iv) frequent adjustments of case mix reimbursement classifications as the result of
 11.2 reconsiderations or audits;

11.3 (v) a criminal indictment alleging provider fraud;

11.4 (vi) other similar factors that relate to a facility's ability to conduct accurate assessments;

11.5 (vii) an atypical pattern of scoring minimum data set items;

11.6 (viii) nonsubmission of assessments;

11.7 (ix) late submission of assessments; or

11.8 (x) a previous history of audit changes of 35 percent or greater.

11.9 (f) If the audit results in a case mix reimbursement classification change, the
 11.10 commissioner must transmit the audit classification notice by electronic means to the nursing
 11.11 facility within 15 business days of completing an audit. The nursing facility is responsible
 11.12 for distribution of the notice to each resident or the resident's representative. This notice
 11.13 must be distributed by the nursing facility within three business days after receipt. The
 11.14 notice must inform the resident of the case mix reimbursement classification assigned, the
 11.15 opportunity to review the documentation supporting the classification, the opportunity to
 11.16 obtain clarification from the commissioner, the opportunity to request a reconsideration of
 11.17 the classification, and the address and telephone number of the Office of Ombudsman for
 11.18 Long-Term Care.

11.19 Sec. 11. Minnesota Statutes 2022, section 144.0724, subdivision 11, is amended to read:

11.20 Subd. 11. **Nursing facility level of care.** (a) For purposes of medical assistance payment
