1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. Minnesota Statutes 2020, section 168.021, subdivision 2a, is amended to read:

1.13 Subd. 2a. **Plate transfer.** (a) When ownership of a vehicle described in subdivision 1,

1.14 is transferred, the owner of the vehicle shall remove the disability plate or plates. The buyer

1.15 of the motor vehicle is entitled to receive a regular plate or plates for the vehicle without

1.16 further cost for the remainder of the registration period.

1.17 (b) Notwithstanding section 168.12, subdivision 1, the disability plate or plates may be

1.18 transferred to a replacement vehicle on notification to the commissioner. However, the

1.19 disability plate or plates may not be transferred without a fee unless the replacement vehicle

1.20 (1) is listed under section 168.012, subdivision 1, and, in case of a single plate for a

1.21 motorcycle or a motorized bicycle, the replacement vehicle is a motorcycle or a motorized

1.22 bicycle, and (2) is owned or primarily operated by the permanently physically disabled

1.23 person.

2.2 Subd. 1i. **Collector plate transfer.** ~~Notwithstanding section 168.12, subdivision 1, on~~

2.4 ~~vehicle owned or jointly owned by the person to whom the special plates were issued or~~

2.11 Sec. 3. Minnesota Statutes 2020, section 168.12, subdivision 1, is amended to read:

2.12 Subdivision 1. **Plates; design, visibility, periods of issuance.** (a) The commissioner,  
2.13 upon approval and payment, shall issue to the applicant the plates required by this chapter,  
2.14 bearing the state name and an assigned vehicle registration number. The number assigned  
2.15 by the commissioner may be a combination of a letter or sign with figures. The color of the  
2.16 plates and the color of the abbreviation of the state name and the number assigned must be  
2.17 in marked contrast. The plates must be lettered, spaced, or distinguished to suitably indicate  
2.18 the registration of the vehicle according to the rules of the commissioner.

2.19 (b) When a vehicle is registered on the basis of total gross weight, the plates issued must  
2.20 clearly indicate by letters or other suitable insignia the maximum gross weight for which  
2.21 the tax has been paid.

2.22 (c) Plates issued to a noncommercial vehicle must bear the inscription "noncommercial"  
2.23 unless the vehicle is displaying a special plate authorized and issued under this chapter.

2.24 (d) A one-ton pickup truck that is used for commercial purposes and is subject to section  
2.25 168.185, is eligible to display special plates as authorized and issued under this chapter.

2.26 (e) The plates must be so treated as to be at least 100 times brighter than the conventional  
2.27 painted number plates. When properly mounted on an unlighted vehicle, the plates, when  
2.28 viewed from a vehicle equipped with standard headlights, must be visible for a distance of  
2.29 not less than 1,500 feet and readable for a distance of not less than 110 feet.

2.30 (f) The commissioner shall issue plates for the following periods:

2.31 (1) New plates issued pursuant to section 168.012, subdivision 1, must be issued to a  
2.32 vehicle for as long as the vehicle is owned by the exempt agency and the plate shall not be

3.1 transferable from one vehicle to another but the plate may be transferred with the vehicle  
 3.2 from one tax-exempt agency to another.

3.3 (2) Plates issued for passenger automobiles must be issued for a seven-year period. All  
 3.4 plates issued under this paragraph must be replaced if they are seven years old or older at  
 3.5 the time of registration renewal or will become so during the registration period.

3.6 (3) Plates issued under sections 168.053 and 168.27, subdivisions 16 and 17, must be  
 3.7 for a seven-year period.

3.8 (4) Plates issued under subdivisions 2c and 2d and section 168.123 must be issued for  
 3.9 the life of the veteran under section 169.79.

3.10 (5) Plates for any vehicle not specified in clauses (1) to (3) must be issued for the life  
 3.11 of the vehicle.

3.12 (g) In a year in which plates are not issued, the commissioner shall issue for each  
 3.13 registration a sticker to designate the year of registration. This sticker must show the year  
 3.14 or years for which the sticker is issued, and is valid only for that period. ~~The plates and  
 3.15 stickers issued for a vehicle may not be transferred to another vehicle during the period for  
 3.16 which the sticker is issued, except when issued for a vehicle registered under section 168.187.~~

3.17 (h) Despite any other provision of this subdivision, plates issued to a vehicle used for  
 3.18 behind-the-wheel instruction in a driver education course in a public school may be  
 3.19 transferred to another vehicle used for the same purpose without payment of any additional  
 3.20 fee. The public school shall notify the commissioner of each transfer of plates under this  
 3.21 paragraph. The commissioner may prescribe a format for notification.

3.22 (i) Except as otherwise prohibited, a person may transfer license plates to different  
 3.23 vehicles owned or jointly owned by the person to whom the plates were issued. The person  
 3.24 transferring the plates must pay a transfer fee of \$5. The \$5 fee must be paid into the state  
 3.25 treasury and credited to the vehicle services operating account under section 299A.705,  
 3.26 subdivision 1. Special license plates issued under this chapter must not be transferred to a  
 3.27 vehicle that is not eligible for that type of special license plates.

3.29 Subd. 2. **Amateur radio licensee; special plates, rules.** (a) The commissioner shall  
 3.30 issue amateur radio plates to an applicant who:

3.32 (2) is a resident of this state;

4.1 (3) holds an official amateur radio station license or a citizens radio service class D  
4.2 license, in good standing, issued by the Federal Communications Commission;

4.15 (d) If owning more than one motor vehicle of the type specified in this subdivision, the  
4.16 applicant may apply for special plates for each motor vehicle and, if each application  
4.17 complies with this subdivision, the commissioner shall furnish the applicant with the special  
4.18 plates, indicating the official amateur call letters and other distinguishing information as  
4.19 the commissioner considers necessary, for each of the motor vehicles.

4.20 (e) The commissioner may make reasonable rules governing the use of the special plates  
4.21 as will assure the full compliance by the owner of the special plates, with all existing laws  
4.22 governing the registration of motor vehicles and the transfer and use of the plates.

4.24 ~~subdivision may be transferred by an owner to another motor vehicle listed in paragraph~~

4.30 (1) is a member of a fire department receiving state aid under chapter 69, has a letter  
4.31 from the fire chief, and is an owner of a passenger automobile, a one-ton pickup truck, or  
4.32 a motorcycle;

5.1 (2) pays a fee in the amount specified for special plates under subdivision 5, and any  
5.2 other fees required by this chapter;

5.3 (3) pays the registration tax required by this chapter for the motor vehicle; and

5.4 (4) complies with this chapter and rules governing the registration of motor vehicles and

5.14 notification that an individual is no longer qualified for these special plates, the commissioner

5.16 the plate only upon demonstrating compliance with the qualifications of this subdivision.

6.3 passenger automobile;

**168.121 SPECIAL PLATES REMEMBERING VICTIMS OF IMPAIRED DRIVERS.**

Subd. 3. **Plates transfer.** On payment of a transfer fee of \$5, plates issued under this section may be transferred to another passenger automobile registered to the individual to whom the special plates were issued.

**168.123 VETERANS; SPECIAL PLATES.**

Subd. 4. **Plates transfer.** (a) On payment of a fee of \$5, plates issued under subdivision 1, paragraph (a), clause (1), may be transferred to another passenger automobile or recreational motor vehicle, or one-ton truck described in subdivision 1, paragraph (a), clause (1), registered to the individual to whom the plates were issued.

(b) On payment of a fee of \$5, a plate issued under subdivision 1, paragraph (a), clause (2), may be transferred to another motorcycle registered to the individual to whom the plate was issued.

**168.1235 VETERANS SERVICE GROUP EMBLEMS.**

Subd. 4. **Plate emblem transfer.** Despite section 168.12 or other law to the contrary, on payment of a fee of \$5, the veterans service organization special plate emblems issued under subdivision 1, may be transferred by the owner to other plates on a passenger automobile, pickup truck, van, or self-propelled recreational vehicle registered to the person to whom the emblems were issued.

**168.1253 GOLD STAR LICENSE PLATE.**

Subd. 5. **Transfer.** On payment of a fee of \$5 and notification to the commissioner, special plates issued under this section may be transferred to another motor vehicle owned or jointly owned by the eligible person.

**168.1255 "PROUD TO BE A VETERAN" PLATE.**

Subd. 3. **Plate transfers.** Despite section 168.12, subdivision 1, on payment of a transfer fee of \$5, plates issued under this section may be transferred to another passenger automobile registered to the individual to whom the veteran contribution plates were issued, or a single motorcycle plate may be transferred to another motorcycle registered to the individual to whom the plate was issued.

**168.1256 RETIRED LAW ENFORCEMENT SPECIAL PLATES.**

Subd. 3. **Plates transfer.** On application to the commissioner and payment of a transfer fee of \$5, special plates issued under this section may be transferred to another motor vehicle if the subsequent vehicle is:

- (1) qualified under subdivision 1, clause (1), to bear the special plates; and
- (2) registered to the same individual to whom the special plates were originally issued.

**168.1282 "START SEEING MOTORCYCLES" SPECIAL PLATES.**

Subd. 3. **Plates transfer.** On application to the commissioner and payment of a transfer fee of \$5, special plates issued under this section may be transferred to another motor vehicle if the subsequent vehicle is:

- (1) qualified under subdivision 1, clause (1), to bear the special plates; and
- (2) registered to the same individual to whom the special plates were originally issued.

**168.129 SPECIAL COLLEGIATE PLATES.**
