5.27 **REFUND.**

5.28 Notwithstanding Minnesota Statutes, section 474A.061, subdivisions 1a, paragraph (a),
5.29 and 7, and Minnesota Statutes, section 474A.21, due to the unique circumstances of the
5.30 COVID-19 pandemic, issuers that returned all of their allocation of bonding authority from
5.31 the 2020 housing pool shall receive a refund of the amount of the application deposit
5.32 submitted with the issuer's 2020 housing pool application, less any amount previously

- 6.1 refunded. Any application deposit funds that have not yet been transferred under Minnesota
6.2 Statutes, section 474A.21, as of the date of enactment that are connected to full returns of
6.3 bonding authority from the 2020 housing pool need not be deposited in the fund under
6.4 Minnesota Statutes, section 462A.201, and the department may retain those funds in the
6.5 separate account in the general fund under Minnesota Statutes, section 474A.21. The amount
6.6 necessary to refund the application deposits is appropriated to the department from the
6.7 separate account in the general fund under Minnesota Statutes, section 474A.21.
