(a) When an insurer, licensed to conduct business in 1.7 Minnesota, acquires ownership of a late-model or high-value vehicle through payment of 1.8 damages, the insurer shall immediately apply for a salvage certificate of title or shall stamp 1.9 the existing certificate of title with the legend "SALVAGE CERTIFICATE OF TITLE" in 1.10 a manner prescribed by the department. (d) A person who retains ownership of a late-model or high-value motor vehicle and
receives a total loss settlement from an insurance company, shall immediately apply for a
salvage certificate of title.

EFFECTIVE DATE. This section is effective January 1, 2023, and applies to: (1) a vehicle subject to this section that is acquired on or after that date; (2) a vehicle that sustains damage by collision as described in paragraph (c) on or after that date; or (3) a vehicle for which a person receives a total loss settlement as described in paragraph (d) on or after that date.
