1.2 relating to children; making changes to the Minnesota Indian Family Preservation

1.3 Act; amending Minnesota Statutes 2022, sections 260.753; 260.755, subdivisions

1.4 1a, 3, 20, 22, by adding subdivisions; 260.761; 260.7611; 260.762; 260.765,

1.7 260.835, subdivision 2; proposing coding for new law in Minnesota Statutes,

1.9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.10 Section 1. **[260.752] APPLICABILITY.**

1.11 Unless otherwise stated, sections 260.751 to 260.835 and the federal Indian Child Welfare

1.12 Act are applicable without exception in any child placement proceeding involving an Indian

1.13 child where custody is granted to someone other than a parent or an Indian custodian.

1.14 Nothing in sections 260.751 to 260.835 is intended to apply to custody actions between

1.15 parents or between a parent and Indian custodian.

1.16 Sec. 2. Minnesota Statutes 2022, section 260.753, is amended to read:

1.17 **260.753 PURPOSES.**

1.18 The purposes of ~~Laws 2015, chapter 78,~~ the Minnesota Indian Family Preservation Act

1.19 are to (1) protect the long-term interests, as defined by the Tribes, of Indian children, their

1.20 families as defined by law or custom, and the child's Tribe; and (2) preserve the Indian

1.21 family and Tribal identity, including an understanding that Indian children are damaged if

1.22 family and child Tribal identity and contact are denied. Indian children are the future of the

1.23 Tribes and are vital to their very existence.

2.1 Sec. 3. [260.754] POLICY ON TRIBAL-STATE RELATIONS.

2.2 (a) The state of Minnesota acknowledges federally recognized Indian Tribes as sovereign  
 2.3 political entities that predate the existence of the United States and that have retained inherent  
 2.4 sovereign authority to pass their own laws, maintain their own systems of governance, and  
 2.5 determine their own jurisdiction. The sovereign authority of Tribes may only be limited by  
 2.6 the federal government and not by any action of the state, including the state legislature and  
 2.7 state courts.

2.8 (b) Inherently, as members of Indian Tribes recognized by the federal government,  
 2.9 Indian people have rights and privileges as members of their Tribe which the state of  
 2.10 Minnesota recognizes and protects.

2.11 (c) Indian people have a right to be protected from being disfranchised or deprived of  
 2.12 any of the rights and privileges secured to any citizen in the state and to have the recognition  
 2.13 and protection of the rights and privileges flowing from their membership in an Indian Tribe  
 2.14 by any state action.

2.15 (d) The state of Minnesota recognizes all federally recognized Indian Tribes as having  
 2.16 the inherent authority to determine their own jurisdiction for any and all Indian child custody  
 2.17 or child placement proceedings regardless of whether the Tribe's members are on or off the  
 2.18 reservation and regardless of the procedural posture of the proceeding.

2.19 (e) The state of Minnesota has long recognized the importance of Indian children to their  
 2.20 Tribes not only as members of Tribal families and communities, but also as the Tribe's  
 2.21 greatest resource as future members and leaders of the Tribe. The vitality of Indian children  
 2.22 in the state of Minnesota is essential to the health and welfare of both the state and the Tribes  
 2.23 and is essential to the future welfare and continued existence of the child's Tribe.

2.24 (f) The state of Minnesota recognizes that the historical deprivation of rights of Indian  
 2.25 people and Indian Tribes have led to disparate out-of-home placement of Indian children.

2.26 Sec. 4. Minnesota Statutes 2022, section 260.755, subdivision 1a, is amended to read:

2.27 Subd. 1a. **Active efforts.** "Active efforts" means a rigorous and concerted level of effort  
 2.28 that is ongoing throughout the involvement of the ~~local social services~~ child-placing agency  
 2.29 to continuously involve the Indian child's Tribe and that uses the prevailing social and  
 2.30 cultural values, conditions, and way of life of the Indian child's Tribe to preserve the Indian  
 2.31 child's family and prevent placement of an Indian child and, if placement occurs, to return  
 2.32 the Indian child to the child's family at the earliest possible time. Active efforts ~~sets~~ under  
 2.33 section 260.762 requires a higher standard than reasonable efforts to preserve the family,

3.1 prevent breakup of the family, and reunify the family, according to section 260.762. Active  
 3.2 efforts ~~includes~~ include reasonable efforts as required by Title IV-E of the Social Security  
 3.3 Act, United States Code, title 42, sections 670 to 679c.

3.4 Sec. 5. Minnesota Statutes 2022, section 260.755, subdivision 3, is amended to read:

3.5 Subd. 3. **Child placement proceeding.** (a) "Child placement proceeding" includes a  
 3.6 judicial proceeding which could result in the following:

3.7 ~~(a)~~ (1) "adoptive placement," means meaning the permanent placement of an Indian  
 3.8 child for adoption, including an action resulting in a final decree of adoption;

3.9 ~~(b)~~ (2) "involuntary foster care placement," means meaning an action removing an Indian  
 3.10 child from ~~its~~ the child's parents or Indian custodian for temporary placement in a foster  
 3.11 home, institution, or the home of a guardian. The parent or Indian custodian cannot have  
 3.12 the Indian child returned upon demand, but parental rights have not been terminated;

3.13 ~~(c)~~ (3) "preadoptive placement," means meaning the temporary placement of an Indian  
 3.14 child in a foster home or institution after the termination of parental rights, before or instead  
 3.15 of adoptive placement; or

3.16 ~~(d)~~ (4) "termination of parental rights," means meaning an action resulting in the  
 3.17 termination of the parent-child relationship under section 260C.301.

3.18 (b) The ~~terms include~~ term child placement proceeding includes all placements where  
 3.19 Indian children are placed out-of-home or away from the care, custody, and control of their  
 3.20 parent or parents or Indian custodian that do not implicate custody between the parents.  
 3.21 Child placement proceeding also includes any placement based upon juvenile status offenses,  
 3.22 but do not include a placement based upon an act which if committed by an adult would be  
 3.23 deemed a crime, or upon an award of custody in a divorce proceeding to one of the parents.

3.24 Sec. 6. Minnesota Statutes 2022, section 260.755, is amended by adding a subdivision to  
 3.25 read:

3.26 Subd. 3a. **Child-placing agency.** "Child-placing agency" means a public, private, or  
 3.27 nonprofit legal entity: (1) providing assistance to a child and the child's parent or parents;  
 3.28 or (2) placing a child in foster care or for adoption on a voluntary or involuntary basis.

4.1 Sec. 7. Minnesota Statutes 2022, section 260.755, is amended by adding a subdivision to  
4.2 read:

4.3 Subd. 3b. **Child placement.** "Child placement" means placement of an Indian child on  
4.4 a voluntary or involuntary basis in foster care, preadoptive placement, or adoption by a  
4.5 child-placing agency, parent, parents, Indian custodian, or individual.

4.6 Sec. 8. Minnesota Statutes 2022, section 260.755, is amended by adding a subdivision to  
4.7 read:

4.8 Subd. 4a. **Custody.** "Custody" means the physical or legal custody, or both, of an Indian  
4.9 child under any applicable Tribal law, Tribal custom, or state law. A party may demonstrate  
4.10 the existence of custody by looking to Tribal law, Tribal custom, or state law.

4.11 Sec. 9. Minnesota Statutes 2022, section 260.755, is amended by adding a subdivision to  
4.12 read:

4.13 Subd. 5a. **Emergency proceeding.** "Emergency proceeding" means and includes any  
4.14 court action that involves an emergency removal or emergency placement of an Indian child.

4.15 Sec. 10. Minnesota Statutes 2022, section 260.755, is amended by adding a subdivision  
4.16 to read:

4.17 Subd. 5b. **Extended family member.** "Extended family member" is as defined by the  
4.18 law or custom of the Indian child's Tribe or, in the absence of any law or custom of the  
4.19 Tribe, is a person who has reached the age of 18 and who is the Indian child's grandparent,  
4.20 aunt or uncle, brother or sister, brother-in-law or sister-in-law, niece or nephew, first or  
4.21 second cousin, or stepparent.

4.22 Sec. 11. Minnesota Statutes 2022, section 260.755, is amended by adding a subdivision  
4.23 to read:

4.24 Subd. 6a. **Imminent physical damage or harm.** "Imminent physical damage or harm"  
4.25 means that a child is threatened with immediate and present conditions that are life  
4.26 threatening or likely to result in abandonment, sexual abuse, or serious physical injury.

4.27 Sec. 12. Minnesota Statutes 2022, section 260.755, is amended by adding a subdivision  
4.28 to read:

4.29 Subd. 16a. **Public act.** "Public act" means an act of legislation by a political body  
4.30 affecting the public as a whole.

5.1 Sec. 13. Minnesota Statutes 2022, section 260.755, subdivision 20, is amended to read:

5.2 Subd. 20. **Tribal court.** "Tribal court" means a court with jurisdiction over child custody  
 5.3 proceedings and which is either a court of Indian offenses, or a court established and operated  
 5.4 under the code or custom of an Indian Tribe, or any other administrative body of a Tribe  
 5.5 which is vested with authority over child custody proceedings. ~~Except as provided in section~~  
 5.6 ~~260.771, subdivision 5, nothing in this chapter shall be construed as conferring jurisdiction~~  
 5.7 ~~on an Indian Tribe.~~

5.8 Sec. 14. Minnesota Statutes 2022, section 260.755, subdivision 22, is amended to read:

5.9 Subd. 22. **Voluntary foster care placement.** "Voluntary foster care placement" means  
 5.10 a decision in which there has been participation by a ~~local social services~~ child-placing  
 5.11 ~~agency or private child-placing agency~~ resulting in the temporary placement of an Indian  
 5.12 child away from the home of the child's parents or Indian custodian in a foster home,  
 5.13 institution, or the home of a guardian, and the parent or Indian custodian may have the child  
 5.14 returned upon demand.

5.15 Sec. 15. **[260.758] EMERGENCY REMOVAL OR PLACEMENT OF INDIAN**  
 5.16 **CHILD; TERMINATION; APPROPRIATE ACTION.**

5.17 Subdivision 1. **Emergency removal or placement permitted.** Nothing in sections  
 5.18 260.751 to 260.835 shall be construed to prevent the emergency removal of an Indian child  
 5.19 from the Indian child's parent or Indian custodian, including an Indian child who is a resident  
 5.20 of or is domiciled on a reservation but temporarily located off the reservation, or the  
 5.21 emergency placement of the Indian child in a foster home or institution under sections  
 5.22 260.751 to 260.835, in order to prevent imminent serious physical damage or harm to the  
 5.23 Indian child.

5.24 Subd. 2. **Temporary emergency jurisdiction of state courts.** (a) The child-placing  
 5.25 agency or court shall ensure that the emergency removal or placement terminates immediately  
 5.26 when removal or placement is no longer necessary to prevent imminent physical damage  
 5.27 or harm to the Indian child. The child-placing agency or court shall expeditiously initiate a  
 5.28 child placement proceeding subject to the provisions of sections 260.751 to 260.835, transfer  
 5.29 the child to the jurisdiction of the appropriate Indian Tribe, or return the Indian child to the  
 5.30 Indian child's parent or Indian custodian as may be appropriate.

5.31 (b) If the Indian child is a resident of or is domiciled on a reservation but temporarily  
 5.32 located off the reservation, a court of this state has only temporary emergency jurisdiction  
 5.33 until the Indian child is transferred to the jurisdiction of the appropriate Indian Tribe unless

6.1 the Indian child's Tribe has expressly declined to exercise its jurisdiction, or the Indian child  
6.2 is restored to the Indian child's parent or Indian custodian.

6.3 Subd. 3. **Petition for emergency removal; placement requirements.** A petition for a  
6.4 court order authorizing the emergency removal or continued emergency placement of an  
6.5 Indian child, or the petition's accompanying documents, must contain a statement of the  
6.6 risk of imminent physical damage or harm to the Indian child and any evidence that the  
6.7 emergency removal or placement continues to be necessary to prevent imminent physical  
6.8 damage or harm to the Indian child. The petition or its accompanying documents must also  
6.9 contain the following information:

6.10 (1) the name, age, and last known address of the Indian child;

6.11 (2) the name and address of the Indian child's parents and Indian custodians, if any;

6.12 (3) the steps taken to provide notice to the Indian child's parents, Indian custodians, and  
6.13 Tribe about the emergency proceeding;

6.14 (4) if the Indian child's parents and Indian custodians are unknown, a detailed explanation  
6.15 of what efforts have been made to locate and contact them;

6.16 (5) the residence and domicile of the Indian child;

6.17 (6) if either the residence or domicile of the Indian child is believed to be on a reservation  
6.18 or in an Alaska Native village, the name of the Tribe affiliated with that reservation or  
6.19 village;

6.20 (7) the Tribal affiliation of the Indian child and of the Indian child's parents or Indian  
6.21 custodians;

6.22 (8) a specific and detailed account of the circumstances that led the agency responsible  
6.23 for the emergency removal of the Indian child to take that action;

6.24 (9) if the child is believed to reside or be domiciled on a reservation where the Tribe  
6.25 exercises exclusive jurisdiction over Indian child custody matters, a statement of the efforts  
6.26 that have been made and are being made to contact the Tribe and transfer the Indian child  
6.27 to the Tribe's jurisdiction; and

6.28 (10) a statement of the efforts that have been taken to assist the Indian child's parents or  
6.29 Indian custodians so that the Indian child may safely be returned to their custody.

6.30 Subd. 4. **Emergency proceeding requirements.** (a) The court shall hold a hearing no  
6.31 later than 72 hours, excluding weekends and holidays, after the removal of the Indian child.

7.1 The court shall determine whether the emergency removal continues to be necessary to  
 7.2 prevent imminent physical damage or harm to the Indian child.

7.3 (b) The court shall hold additional hearings whenever new information indicates that  
 7.4 the emergency situation has ended and at any court hearing during the emergency proceeding  
 7.5 to determine whether the emergency removal or placement is no longer necessary to prevent  
 7.6 imminent physical damage or harm to the Indian child.

7.7 Subd. 5. **Termination of emergency removal or placement.** (a) An emergency removal  
 7.8 or placement of an Indian child must immediately terminate once the child-placing agency  
 7.9 or court possesses sufficient evidence to determine that the emergency removal or placement  
 7.10 is no longer necessary to prevent imminent physical damage or harm to the Indian child  
 7.11 and the Indian child shall be immediately returned to the custody of the Indian child's parent  
 7.12 or Indian custodian.

7.13 (b) An emergency removal or placement ends when the Indian child is transferred to  
 7.14 the jurisdiction of the Indian child's Tribe, or when the court orders, after service upon the  
 7.15 Indian child's parents, Indian custodian, and Indian child's Tribe, that the Indian child shall  
 7.16 be placed in foster care upon a determination supported by clear and convincing evidence,  
 7.17 including testimony by a qualified expert witness, that custody of the Indian child by the  
 7.18 Indian child's parent or Indian custodian is likely to result in serious emotional or physical  
 7.19 damage to the Indian child.

7.20 (c) In no instance shall emergency removal or emergency placement of an Indian child  
 7.21 extend beyond 30 days unless the court finds by a showing of clear and convincing evidence  
 7.22 that: (1) continued emergency removal or placement is necessary to prevent imminent  
 7.23 physical damage or harm to the Indian child; (2) the court has been unable to transfer the  
 7.24 proceeding to the jurisdiction of the Indian child's Tribal court; and (3) it has not been  
 7.25 possible to initiate a child placement proceeding with all of the protections under sections  
 7.26 260.751 to 260.835, including obtaining the testimony of a qualified expert witness.

7.27 Sec. 16. Minnesota Statutes 2022, section 260.761, is amended to read:

7.28 **~~260.761 SOCIAL SERVICES AGENCY AND PRIVATE LICENSED~~**  
 7.29 **~~CHILD-PLACING AGENCY INQUIRY OF TRIBAL LINEAGE; NOTICE TO~~**  
 7.30 **~~TRIBES, PARENTS, AND INDIAN CUSTODIANS; ACCESS TO FILES.~~**

7.31 Subdivision 1. **Inquiry of Tribal lineage.** ~~The local social services agency or private~~  
 7.32 ~~licensed~~ child-placing agency or individual petitioner shall inquire of the child, the child's  
 7.33 parents and custodians, and other appropriate persons whether there is any reason to believe

8.1 that a child brought to the agency's attention may have lineage to an Indian Tribe. This  
 8.2 inquiry shall occur at the time the child comes to the attention of the ~~local social services~~  
 8.3 child-placing agency or individual petitioner and shall continue throughout the involvement  
 8.4 of the child-placing agency or individual petitioner.

8.5 Subd. 2. ~~Agency and court notice to Tribes~~ **Notice to Tribes of services or court**  
 8.6 **proceedings involving an Indian child.** (a) When a ~~local social services~~ child-placing  
 8.7 agency has information that a family assessment or investigation being conducted may  
 8.8 involve an Indian child, the ~~local social services~~ child-placing agency shall notify the Indian  
 8.9 child's Tribe of the family assessment or investigation according to section 260E.18. Initial  
 8.10 notice shall be provided by telephone and by email or facsimile and shall include the child's  
 8.11 full name and date of birth; the full names and dates of birth of the child's biological parents;  
 8.12 and if known the full names and dates of birth of the child's grandparents and of the child's  
 8.13 Indian custodian. If information regarding the child's grandparents or Indian custodian is  
 8.14 not immediately available, the child-placing agency shall continue to request this information  
 8.15 and shall notify the Tribe when it is received. Notice shall be provided to all Tribes to which  
 8.16 the child may have any Tribal lineage. The ~~local social services~~ child-placing agency shall  
 8.17 request that the Tribe or a designated Tribal representative participate in evaluating the  
 8.18 family circumstances, identifying family and Tribal community resources, and developing  
 8.19 case plans. The child-placing agency shall continue to include the Tribe in service planning  
 8.20 and updates as to the progress of the case.

8.21 (b) When a ~~local social services~~ child-placing agency has information that a child  
 8.22 receiving services may be an Indian child, the ~~local social services~~ child-placing agency  
 8.23 shall notify the Tribe by telephone and by email or facsimile of the child's full name and  
 8.24 date of birth, the full names and dates of birth of the child's biological parents, and, if known,  
 8.25 the full names and dates of birth of the child's grandparents and of the child's Indian  
 8.26 custodian. This notification must be provided so the Tribe can determine if the child is  
 8.27 ~~enrolled in the Tribe~~ a member or eligible for membership in the Tribe, and must be provided  
 8.28 within seven days. If information regarding the child's grandparents or Indian custodian is  
 8.29 not available within the seven-day period, the ~~local social services~~ child-placing agency  
 8.30 shall continue to request this information and shall notify the Tribe when it is received.  
 8.31 Notice shall be provided to all Tribes to which the child may have any Tribal lineage. ~~If the~~  
 8.32 ~~identity or location of the child's parent or Indian custodian and Tribe cannot be determined,~~  
 8.33 ~~the local social services agency shall provide the notice required in this paragraph to the~~  
 8.34 ~~United States secretary of the interior.~~



9.1 (c) ~~In accordance with sections 260C.151 and 260C.152~~ In all child placement  
 9.2 proceedings, when a court has reason to believe that a child placed in emergency protective  
 9.3 care is an Indian child, the court administrator or a designee shall, as soon as possible and  
 9.4 before a hearing takes place, notify the Tribal social services agency by telephone and by  
 9.5 email or facsimile of the date, time, and location of the emergency protective ~~ease~~ care or  
 9.6 other initial hearing. The court shall make efforts to allow appearances by telephone for  
 9.7 Tribal representatives, parents, and Indian custodians.

9.8 (d) The child-placing agency or individual petitioner shall affect service of any petition  
 9.9 governed by sections 260.751 to 260.835 by certified mail or registered mail, return receipt  
 9.10 requested upon the Indian child's parents, Indian custodian, and Indian child's Tribe at least  
 9.11 10 days before the admit-deny hearing is held. If the identity or location of the Indian child's  
 9.12 parents or Indian custodian and Tribe cannot be determined, the child-placing agency shall  
 9.13 provide the notice required in this paragraph to the United States Secretary of the Interior,  
 9.14 Bureau of Indian Affairs by certified mail, return receipt requested.

9.15 (e) A Tribe may request up to 20 additional days to prepare for the admit-deny hearing.  
 9.16 The court shall allow appearances by telephone, Zoom, or other electronic medium for  
 9.17 Tribal representatives, the child's Indian parents, or the Indian custodian.

9.18 ~~(d)~~ (f) ~~A local social services~~ child-placing agency or individual petitioner must provide  
 9.19 the notices required under this subdivision at the earliest possible time to facilitate  
 9.20 involvement of the Indian child's Tribe. Nothing in this subdivision is intended to hinder  
 9.21 the ability of the ~~local social services~~ child-placing agency, individual petitioner, and the  
 9.22 court to respond to an emergency situation. Lack of participation by a Tribe shall not prevent  
 9.23 the Tribe from intervening in services and proceedings at a later date. A Tribe may participate  
 9.24 at any time. At any stage of the ~~local social services~~ child-placing agency's involvement  
 9.25 with an Indian child, the agency shall provide full cooperation to the Tribal social services  
 9.26 agency, including disclosure of all data concerning the Indian child. Nothing in this  
 9.27 subdivision relieves the ~~local social services~~ child-placing agency of satisfying the notice  
 9.28 requirements in ~~the Indian Child Welfare Act~~ state or federal law.

9.29 Subd. 3. **Notice of potential preadoptive or adoptive placement.** In any ~~voluntary~~  
 9.30 adoptive or preadoptive placement proceeding ~~in which a local social services agency,~~  
 9.31 ~~private child-placing agency, petitioner in the adoption, or any other,~~ including voluntary  
 9.32 proceedings, where any party or participant has reason to believe that a child who is the  
 9.33 subject of an adoptive or preadoptive placement proceeding is or may be an "Indian child,"  
 9.34 as defined in section 260.755, subdivision 8, and United States Code, title 25, section  
 9.35 1903(4), the child-placing agency or person individual petitioner shall notify the Indian

10.1 child's ~~Tribal social services agency~~ Tribe by registered mail or certified mail with return  
 10.2 receipt requested of the pending proceeding and of the right of intervention under subdivision  
 10.3 6. If the identity or location of the child's Tribe cannot be determined, the notice must be  
 10.4 given to the United States Secretary of Interior in like manner, who will have 15 days after  
 10.5 receipt of the notice to provide the requisite notice to the Tribe. No preadoptive or adoptive  
 10.6 placement proceeding may be held until at least ten days after receipt of the notice by the  
 10.7 Tribe or the secretary. Upon request, the Tribe must be granted up to 20 additional days to  
 10.8 prepare for the proceeding. The child-placing agency or ~~notifying party~~ individual petitioner  
 10.9 shall include in the notice the identity of the birth parents and child absent written objection  
 10.10 by the birth parents. The ~~private~~ child-placing agency shall inform the birth parents of the  
 10.11 Indian child of any services available to the Indian child through the child's Tribal social  
 10.12 services agency, including child placement services, and shall additionally provide the birth  
 10.13 parents of the Indian child with all information sent from the Tribal social services agency

10.15 Subd. 4. **Unknown father.** If the ~~local social services agency, private~~ child-placing  
 10.16 agency, individual petitioner, the court, ~~petitioner~~, or any ~~other~~ party has reason to believe  
 10.17 that a child who is the subject of ~~an adoptive~~ a child placement proceeding is or may be an  
 10.18 Indian child but the father of the child is unknown and has not registered with the fathers'  
 10.19 adoption registry pursuant to section 259.52, the child-placing agency or ~~person~~ individual  
 10.20 petitioner shall provide to the Tribe believed to be the Indian child's Tribe information  
 10.21 sufficient to enable the Tribe to determine the child's eligibility for membership in the Tribe,  
 10.22 including, but not limited to, the legal and maiden name of the birth mother, her date of  
 10.23 birth, the names and dates of birth of her parents and grandparents, and, if available,  
 10.24 information pertaining to the possible identity, Tribal affiliation, or location of the birth  
 10.25 father.

**260.755 DEFINITIONS.**

Subd. 17. **Private child-placing agency.** "Private child-placing agency" means a private organization, association, or corporation providing assistance to children and parents in their own homes and placing children in foster care or for adoption.
