(c) The commissioner, in consultation with the University of Minnesota, must provide the training and testing module at locations statewide and may make the recertification training available online. (d) The commissioner, in consultation with the University of Minnesota, must annually 2.10 post the best management practices and a list of certified commercial applicators on the 2.11 agency's website. 2.12 (e) The commissioner may charge a fee of no more than \$350 per certified commercial 2.13 applicator for the training or recertification under this section.
